**Agenda item:** Approval of pending rules on conduct of election recounts.




proceeding through the remainder of the rule promulgation process.

Gurewitz, Houskamp. Nays: None. Motion carried.


**Agenda item:** Consideration of the procedure rules for the board.


**Board action on agenda item:** The Board supports the amendments to
