Board action on agenda item: The Board moved to limit the number of challengers able to observe each precinct at any one time to one challenger in support of the proposition and one challenger opposed to the proposition

Board action on agenda item: The Board moved the recount on Proposal 3 be clarified to state that it does not include a recount of the in-person precincts in the city of Detroit. Moved by Gurewitz; supported by Houskamp. Ayes: Daunt, Gurewitz, Houskamp. Nays: None. Motion carried.




