**Agenda item:** Consideration of meeting minutes for approval (May 14, 2021).

**Board action on agenda item:** The Board approved the minutes of the May 14, 2021 meeting as amended. Moved by Bradshaw; supported by Daunt. Ayes: Matuzak, Daunt, Bradshaw. Nays: None. Motion carried.

**Agenda item:** Consideration of the petition to recall Governor Gretchen Whitmer submitted by Hannah Curley on May 14, 2021. The reasons for recall printed in the heading of the petition are as follows:

Governor Gretchen Whitmer continued a State of Emergency after April 30, 2020 without legislative approval. After April 30, 2020 Governor Gretchen Whitmer issued multiple Executive Orders using the Emergency Powers of the Governor Act 302 of 1945. After the October 2, 2020 Michigan Supreme Court's Order for Docket #161917, Governor Gretchen Whitmer issued a press release stating "Governor's Orders remain in effect at least 21 more days."

**Board action on agenda item:** The Board determined that the recall petition does not factually and clearly state the reasons for the recall of Governor Whitmer because of the error in the docket number. Moved by Daunt; supported by Bradshaw. Ayes: Matuzak, Daunt, Bradshaw. Nays: None. Motion carried.

**Agenda item:** Consideration of the petition to recall Attorney General Dana Nessel submitted by Hannah Curley on May 14, 2021. The reasons for recall printed in the heading of the petition are as follows:

On May 13, 2020, Attorney General Dana Nessel announced in coordination with the Michigan Department of Licensing and Regulatory Affairs, Barber Karl Manke's Professional License as well as the License for his Barbershop were summarily suspended. Michigan Attorney General Dana Nessel announced the arrest of Marlana Pavlos-Hackney, owner of Marlana's Bistro and Pizzeria in Holland, made by the Michigan State Police on March 19, 2021.



**Agenda item:** Such other and further business as may be properly presented to the Board.


