# STATE OF MICHIGAN SECRETARY OF STATE

In re: Michigan Campaign Finance Complaint against Citizens for A Fair and Positive Government, and its registered agent, Yolanda Pendleton.

**NOW COMES**, ROBERT DAVIS, a natural person, being first duly sworn and deposed, and under the penalty of perjury, states the following:

1. Pursuant to MCL 169.215(5),(6) of the Michigan Campaign

Finance Act (MCFA), I, Robert Davis, hereby submit this

complaint against Citizens for A Fair and Positive

Government, and its registered agent, Yolanda

Pendleton, for violating MCL §§ 169.224, 169.224b,

169.233, 169.235, and 169.247 of the MCFA.

- 5. Citizens for A Fair and Positive Government is registered as a Michigan domestic nonprofit corporation. According to its articles of incorporation, the registered agent for the nonprofit corporation is Yolanda Pendleton. (See Citizens for A Fair and Positive Government's articles of incorporation attached).
- 6. According to Citizens for A Fair and Positive Government's articles of incorporation, the organization was officially incorporated as a nonprofit corporation on May 2, 2022. (See Citizens for A Fair and Positive Government's articles of incorporation attached).
- 7. According to Citizens for A Fair and Positive Government's articles of incorporation, the organization was "established to ensure that the political process in our local communities are fair and just. We raise funds, host events to support candidates and legislative bills and

proposals that represent a fair and positive government." (See Citizens for A Fair and Positive Government's articles of incorporation attached).

- 8. Sometime in June 2022, Citizens for a Fair and Positive Government and Yolanda Pendleton, as its registered agent, caused to be mailed out county-wide a salacious and defamatory flyer defaming the character of our esteemed Wayne County Sheriff Raphael Washington, while promoting the candidacy of Walter Epps. (See Mailer Attached).
- After contacting the U.S. Postal Office, I was able to determine that the mailer was mailed using the bulk mail permit of Messenger Printing Service.
- 10. I contacted Messenger Printing Service and spoke to a Bob Herriman, who confirmed his company mailed the mailer on behalf of Citizens for a Fair and Positive Government and that they paid for the printing and mailing of the flyer.
- 11. I advised Mr. Herriman that Citizens for a Fair and Positive Government was NOT a registered political action committee with the Wayne County Clerk or the Secretary of State and

thus, could not have been the entity that paid for the mailer because they do not legally exist.

- 12. Mr. Herriman then advised me that he could not provide me with the name of the individual who paid for the printing and mailing of the flyer due to privacy restrictions.
- 13. In June 2022, I personally reviewed the public campaign finance databases of both the Wayne County Clerk and Secretary of State and neither database contained any information showing that Citizens for A Fair and Positive Government was a properly registered political action committee or independent expenditure committee under the MCFA.
- 14. Mr. Herriman would not provide me with the name of the individual who paid Messenger Printing Service to mail and print the defamatory mailer.
- 15. The mailer mailed by Messenger Printing Service did not contain the address of Citizens for a Fair and Positive Government nor the address of Walter Epps, whom the mailer promoted. (See Mailer attached).

- Failing to provide the address of the committee or person(s) who paid for the mailer violates MCL 169.247 of the MCFA.
- 17. Additionally, because Citizens for a Fair and Positive Government has **NOT** properly registered as a political action committee or independent expenditure committee with the Wayne County Clerk or the Secretary of State, failure to properly file a statement of organization violates MCL 169.224 of the MCFA.
- 18. Pursuant to MCL 169.224 of the MCFA, Citizens for a Fair and Positive Government was required to file a statement of organization registering as a political action committee once the committee expended and/or received funds advocating and/or promoting a candidate for election to a particular office.
- 19. Pursuant to MCL 169.224(1), Citizens for a Fair and Positive Government and Yolanda Pendleton, its registered agent, SHALL be assessed a late filing fee in the amount of \$300 by the Wayne County Clerk's office and/or the Secretary of State for failing to file their statement of organization.

- 20. MCL 168.244(1) provides, in relevant part: "A person who fails to file a statement of organization required by this subsection shall pay a late filing fee of \$10.00 for each business day the statement remains not filed in violation of this subsection. The late filing fee must not exceed \$300.00. A person who violates this subsection by failing to file for more than 30 days after a statement of organization is required to be filed is guilty of a misdemeanor punishable by a fine of not more than \$1,000.00."
- 21. Citizens for A Fair and Positive Government may also qualify as an "independent expenditure committee" as well.
- 22. MCL 169.224b(1) provides: "One or more persons may create an independent expenditure committee and shall file a statement of organization under section 24. An independent expenditure committee shall file campaign statements under sections 33 and 35 and as otherwise provided in this act." (emphasis supplied).
- 23. MCL 169.209(3) defines "independent expenditure committee" to mean "a committee formed under section 24b for

the purpose of making independent expenditures under this act."

- 24. MCL 169.209(2) defines "independent expenditure" to mean "an expenditure by a person if the expenditure is not made in cooperation, consultation, or concert with, or at the request or suggestion of, a ballot question committee or a candidate, a candidate committee or its agents, or a political party committee or its agents, and if the expenditure is not a contribution to a committee."
- 25. The mailer was printed double sided and in color. It is believed the mailer was mailed out to over 100,000 registered voters county wide.
- 26. Upon information and belief, I believe candidate Walter Epps donated money to Citizens for a Fair and Positive Government to pay for the printing and postage for the defamatory and salacious mailer.
- 27. Upon information and belief, I believe Citizens for A Fair and Positive Government, and its registered agent, Yolanda Pendleton, are attempting to hide the names and true identities

of individuals who donated to the organization to pay for the printing and postage for the salacious mailer.

- 28. That Citizens for A Fair and Positive Government has failed to file various campaign finance reports required under MCL §§ 169.233 and 169.235 of the MCFA.
- 29. I am requesting the Secretary of State to advise and direct the Wayne County Clerk and her campaign finance compliance staff to assess late filing fees against Citizens for A Fair and Positive Government for failing to file a statement of organization in accordance with MCL 169.224.
- 30. I am requesting the Secretary of State to advise and direct the Wayne County Clerk and her campaign finance compliance staff to issue a letter to Citizens for A Fair and Positive Government, and its registered agent, Yolanda Pendleton, directing them to file campaign statements required under MCL 169.233 and 169.235 and assess the appropriate late filing fees, if necessary.
- If called and sworn as a witness, I am competent to testify as to the facts stated herein.

Dear Citizens for a Fair and Positive Government and Yolanda Pendleton:

The Department of State (Department) has received a formal complaint filed against you by Robert Davis alleging that you violated the Michigan Campaign Finance Act (MCFA or Act). Specifically, the complaint alleges that Citizens for a Fair and Positive Government (Citizens) and its registered agent, Yolanda Pendleton, sent out a mailer without the required "paid for by" disclosure, and that the expenditures on the mailer qualified Citizens as a committee with the attendant filing requirements. A copy of the complaint is included with this notice.

By statutory definition, a committee is formed when "a person receives contributions or makes expenditures for the purpose of influencing or attempting to influence the action of the voters for or against [candidate, ballot question, etc.] if contributions received total \$500.00 or more in a calendar year or expenditures made total \$500.00 or more in a calendar year." MCL 169.203(4). For purposes of determining whether a committee exists, the word "person" includes "a group of persons acting jointly." 169.211(2).

Section 24 requires committees to file a statement of organization with the proper filing official within 10 days after the committee is formed. MCL 169.224(1). Section 24 details specific requirements for all statements of organization that must be filed. See MCL 169.224(2)-(3). A person who fails to file a timely statement is subject to a civil fine of up to \$1,000. MCL 169.221(13). A person who fails to file a statement of organization shall pay a late filing fee of \$10.00 per business day the report is not filed, not to exceed \$300. MCL 169.224(1). A person failing to file a statement of organization after 30 days is guilty of a misdemeanor punishable by a fine of up to \$1,000. *Id*.

The MCFA requires committees file contributions and expenditures with the appropriate filing official by specific dates. MCL 169.233(1) - (3). The Act requires a committee that receives or expends more than \$1,000 during any election to file campaign finance reports in compliance with the act. MCL 16.233(6). A person who knowingly omits or underreports expenditures required to be disclosed by the Act is subject to a civil fine of not more than \$1,000 or the amount of the expenditures omitted or underreported, whichever is greater. MCL 169.233(11).

The purpose of this letter is to inform you of the Department's examination of these matters and your right to respond to the allegations before the Department proceeds further. It is important to understand that the Department is neither making this complaint nor accepting the allegations as true. The investigation and resolution of this complaint is governed by section 15 of the Act and the corresponding administrative rules, R 169.51 *et seq*. An explanation of the process is included in the enclosed guidebook.

If you wish to file a written response to this complaint, you are required to do so within 15 business days of the date of this letter. Your response may include any written statement or additional documentary evidence you wish to submit. Materials may be emailed to BOERegulatory@michigan.gov or mailed to the Department of State, Bureau of Elections, Richard H. Austin Building, 1<sup>st</sup> Floor, 430 West Allegan Street, Lansing, Michigan 48918. If you fail to submit a response, the Department will render a decision based on the evidence furnished by the complainant.

A copy of your answer will be provided to Mr. Davis, who will have an opportunity to submit a rebuttal statement to the Department. After reviewing the statements and materials provided by the parties, the Department will determine whether "there may be reason to believe that a violation of [the MCFA] has occurred [.]" MCL 169.215(10). Note that the Department's enforcement powers include the possibility of entering a conciliation agreement, conducting an administrative hearing, or referring this matter to the Attorney General for enforcement.

#### INSTRUCTIONS FOR COMPLETING THE STATEMENT OF ORGANIZATION FOR LOCAL INDEPENDENT, POLITICAL AND INDEPENDENT EXPENDITURE COMMITTEES STATE LEVEL COMMITTEES FILE THIS FORM ELECTRONICALLY

Michigan's Campaign Finance Act (MCFA), P.A. 388 of 1976, covers a "person" operating within Michigan or out-of-state as soon as it receives or spends \$500.00 or more in a calendar year to influence voters for or against the nomination or election of one or more candidates in Michigan, the qualification, passage or defeat of one or more ballot questions in Michigan or assists a political party to obtain ballot access in Michigan. The term "person" means a business, individual, proprietorship, limited liability company, firm, partnership, joint venture, syndicate business trust, labor organization, company, corporation, association, committee, or any other organization or group of persons acting jointly. As soon as a person reaches the \$500.00 threshold, they have 10 calendar days to form and register a "committee" under the MCFA. A person that is covered by the MCFA, registers a committee by filing this form with the appropriate filing official.

### **COMMITTEE TYPES**

Before registering an Independent Committee, Political Committee, or IEC/Super PAC, the differences between the three committee types must be given careful consideration. For further information regarding committee types please see Appendix H of the Committee Manual.

**Political Committees:** Formed to directly support or oppose one or more candidates; may support or oppose ballot questions. A Political Committee must observe the same contribution limits that apply to individuals.

**Independent Committees:** Formed to directly support or oppose one or more candidates; may support or oppose ballot questions. An Independent Committee that meets the following three criteria may give a candidate ten times the amount a Political Committee is permitted to give the candidate: (1) registers as an Independent Committee at least six months before the election (2) received contributions from a at least 25 persons and (3) in the same calendar year that the 25 contributions are received, expends funds to support or oppose three candidates for elective office. An Independent Committee must adhere to contribution limits applicable to Political Committee meets the criteria detailed above.

**Independent Expenditure/Super PAC Committees:** Formed exclusively for the purpose of making independent expenditures that are not in any way made in cooperation, consultation, or concert with, or at the request or suggestion of, a candidate, a candidate committee or its agents, or political party committee or its agents. An IEC/Super PAC must not make a direct or indirect contribution to a candidate committee, independent committee, political committee, or house or senate political party caucus committee.

### WHERE TO FILE THIS FORM

#### Offices that file with the County Clerk's Office:

• If the districts of all of the candidates supported or opposed are located wholly within the same county, the committee files with the clerk of that county.

# Offices that file with the Michigan Department of State Bureau of Elections must file this form electronically using the assigned Internet application:

• If the districts of any of the candidates supported or opposed are not located wholly within the same county, the committee files with the Bureau of Elections.

NOTE: The information contained on the Statement of Organization must be kept up-to-date. If a change in the information takes place, an amendment to the form must be filed no later than the due date of the first campaign statement required of the committee after the change. The treasurer serving at the time of the change must sign the amendment.

#### INSTRUCTIONS

Type or clearly print in ink all information requested on the Statement of Organization form. Each entry on the form is discussed below.

- **ITEM 1:** On the original Statement of Organization, leave Item 1 blank. An identification number will be assigned to the committee by the filing official. For an amendment enter the assigned identification in Item 1.
- \*ITEM 2: Indicate whether the Statement of Organization is an original or an amendment. If this is an amendment, list all item number(s) and the effective date of the change.
- \*ITEM 3: Check one box (3a, 3b, or 3c) to indicate the type of committee being registered. Independent and Political Committee types (3a & 3b) must designate whether or not the committee is a Separate Segregated Fund (SSF). If yes indicate whether the sponsor forming the committee is a corporation, labor organization or a domestic dependent sovereign (DDS). Enter the sponsor's name. Independent Expenditure Committee/Super PAC check 3c.
- \*ITEM 4: Enter the committee's official name. Do not use initials or abbreviations. An Independent Committee and Political Committee is required to include in the name of the committee the name of the person or persons that sponsor the committee, if any, or with whom the committee is affiliated. A person, other than an individual or a committee, sponsors or is affiliated with an Independent Committee or Political Committee if that person establishes, directs, controls, or financially supports the administration of the committee. A person does not financially support the administration of a committee by merely making a contribution to the committee. If the committee plans to use an abbreviated name or an acronym, enter it in Item 4b.

- \*ITEM 5: Enter the committee's mailing address. A post office box is acceptable as a mailing address. All mail from the filing official will be directed to the committee's mailing address shown in Item 5a. Enter the committee's street address in Item 5b. A post office box is not acceptable. (List the treasurer's home address if no other address is available.)
- \*ITEM 6: Enter the date the committee was formed in Michigan. The original Statement of Organization form must be received by the filing official within 10 calendar days after the committee's formation date. Late filing fees are assessed at a rate of \$10.00 per business day if the form is filed late.
- \*ITEM 7: Enter the committee's phone number including the area code and e-mail address.
- \*ITEM 8: Enter the full name and mailing address of the committee's treasurer. Include a phone number where the treasurer can be reached during business hours. The committee's treasurer must be registered to vote in Michigan if the committee conducts business through an office or facility located in Michigan. The committee treasurer does not have to be a Michigan resident if the committee does not conduct business through an office or facility located in Michigan resident is required to file an "irrevocable written stipulation". The committee does this by checking the box titled OUT-OF-STATE COMMITTEE TREASURER IRREVOCABLE WRITTEN STIPULATION.
- **ITEM 9:** List the name, mailing address, area code and phone number of the person who will be responsible for the committee's records and campaign statement filings. If the committee treasurer will personally handle these responsibilities, leave this item blank. A person designated in this item may sign campaign statements but does not have the authority to sign the Statement of Organization forms in place of the treasurer.

#### **ITEM 10: Reporting Waiver Request**

- Select "YES, I/WE WANT TO APPLY FOR THE REPORTING WAIVER" if the committee does not expect to receive or spend more than \$1,000.00 for a calendar year. The committee does not owe the detailed campaign statements as long as the committee does not receive or spend more than \$1000.00 in a calendar year.
- Select "NO I/WE DO NOT WANT TO APPLY FOR THE REPORTING WAIVER" if the committee expects to receive or expend in excess of \$1,000.00 in a calendar year. This means that the committee owes detailed campaign statements even if the committee does not spend or receive in excess of \$1,000.00 in a calendar year.
- \*ITEM 11: In Item 11, enter the name and address of the Michigan bank, savings and Ioan association or credit union that the committee now uses or intends to use as its "official depository." The committee's official depository must be located in Michigan if the committee conducts business through an office or facility located in Michigan. The committee depository does not have to be located in Michigan if the committee does not conduct business through an office or facility located in Michigan. List the names and addresses of any "secondary depository" the committee currently uses or intends to use. A secondary depository may be used only for the deposit of contributions (for example, as a temporary holding place for receipts from a joint fund raiser); it may not be used for committee expenditures.
- \*ITEM 12: This form must be signed and dated by the active committee treasurer and designated recordkeeper if applicable. This form serves as an electronic signature for electronically filing campaign statements and reports.

## Re: *Davis v. Citizens for a Fair and Positive Government, Pendleton* Campaign Finance Complaint No. 2022 – 10 – 132 – 224, 233, 235, 247

Dear Citizens for a Fair and Positive Government and Yolanda Pendleton:

The Department of State (Department) has finished investigating the campaign finance complaint filed against you by Robert Davis on July 5, 2022. The complaint alleges that you violated the Michigan Campaign Finance Act (MCFA or Act). Specifically, the complaint alleges that Citizens for a Fair and Positive Government (Citizens) and its registered agent, Yolanda Pendleton, sent out a mailer without the required "paid for by" disclosure, and that the expenditures on the mailer qualified Citizens as a committee with the attendant filing requirements.

You responded to the complaint on October 28, 2022. In your response you indicated that you were unaware of the requirement to file a Statement of Organization form for Citizens, instead believe that you were required to establish the organization through the Department of Licensing and Regulatory Affairs. You further state that on October 27, 2022, you filed a Statement of Organization with the Wayne County Clerk's Office.

Mr. Davis was notified of your response on November 3, 2022, but did not provide a rebuttal.

By statutory definition, a committee is formed when "a person receives contributions or makes expenditures for the purpose of influencing or attempting to influence the action of the voters for or against [candidate, ballot question, etc.] if contributions received total \$500.00 or more in a calendar year or expenditures made total \$500.00 or more in a calendar year." MCL 169.203(4). For purposes of determining whether a committee exists, the word "person" includes "a group of persons acting jointly." 169.211(2).

Section 24 requires committees to file a statement of organization with the proper filing official within 10 days after the committee is formed. MCL 169.224(1). Section 24 details specific requirements for all statements of organization that must be filed. See MCL 169.224(2)-(3). A person who fails to file a timely statement is subject to a civil fine of up to \$1,000. MCL 169.221(13). A person who fails to file a statement of organization shall pay a late filing fee of \$10.00 per business day the report is not filed, not to exceed \$300. MCL 169.224(1). A person failing to file a statement of organization after 30 days is guilty of a misdemeanor punishable by a fine of up to \$1,000. *Id*.

The MCFA requires committees file contributions and expenditures with the appropriate filing official by specific dates. MCL 169.233(1) - (3). The Act requires a committee that receives or expends more than \$1,000 during any election to file campaign finance reports in compliance with the act. MCL 16.233(6). A person who knowingly omits or underreports expenditures required to be disclosed by the Act is subject to a civil fine of not more than \$1,000 or the amount of the expenditures omitted or underreported, whichever is greater. MCL 169.233(11).

The Department has reviewed your response and finds that the evidence provided, together with the admission in your response, establish that there may be reason to believe that a violation has occurred.

When the Department finds that there may be reason to believe a violation has occurred, the Act requires the Department to use "informal methods such as a conference [or] conciliation" to correct the potential violation or to prevent further violation. MCL 169.215(10). Statute provides 90 business days for the Department to engage this resolution process. *Id*.

Upon review of the Wayne County Campaign Finance Information System and the document provided in your response, the Department is satisfied that you have subsequently filed a Statement of Organization form for Citizens and paid the late filing fee to the appropriate filing officials. You should continue to work with the Wayne County Clerk's Office to ensure that all required statements are filed. Please note that you may be assessed late filing fees by the County for any statements that were not timely filed. Late-filing fees are assessed and collected by the filing official with whom the statements are filed. MCL 169.217(1). Any questions regarding these late-filing fees should be directed to the County Clerk's office.

Please be advised that this notice has served to remind you of your obligation under the Act to disclose contributions and expenditures and may be used in future proceedings as evidence that tends to establish a knowing violation of the Act.
