Michigan Campaign Finance Act (MCFA) Section alleged to be violated: MCL 169.241.

STATEMENT OF FACTS

1. Tudor Dixon is a candidate running in the Republican primary for Governor of

Michigan and has a candidate committee, Tudor Dixon for Governor Inc, registered with the Michigan Secretary of State's Bureau of Election ("BOE").

2. Michigan Strong is a SuperPAC registered with the BOE. Michigan Strong describes itself as "a political action committee dedicated to electing Tudor Dixon Governor of Michigan in 2022." *See https://michiganstrongpac.com/about/* (accessed 6/30/2022).

3. MCL 169.241 prohibits a committee from accepting or expending an anonymous contribution. MCL 169.241(2).

4. MCL 169.241 further prohibits a committee from accepting a contribution "directly or indirectly, by any person in a name other than the name by which that person is identified for legal purposes." MCL 169.241(3).

5. MCL 169.241(4) provides that "[a] person who knowingly violates this section is guilty of a misdemeanor punishable, if the person is an individual, by a fine of not more than \$1,000.00 or imprisonment for not more than 90 days, or both, or, if the person is other than an individual, by a fine of not more than \$10,000.00."

ALLEGATIONS

On December 31, 2021, Michigan Strong reported that it received a \$5,000.00
 contribution from an entity named "Tudor PAC." See attached Exhibit A, Michigan Strong,
 Campaign Finance Statement, Contributions, January Quarterly, 2022.

7. Searches and review of state and federal campaign finance records located no PAC or other political committee involving an entity named "Tudor PAC."

8. An online search of business entities through Michigan's Department of Licensing and Regulatory Affairs reveals no business entity registered to operate in Michigan with the name of "Tudor PAC."

9. Further, Kent County confirmed that there is no business that filed a D/B/A (doing business as) for "Tudor PAC" in the county.

Michigan Strong reported Tudor PAC's address as "801 Broadway Ave, Suite 203,
 Grand Rapids, MI 49504."

11. The same address reported by Michigan Strong for Tudor PAC is also listed as the address for NxGen MDx, a genetic screening company. *See* attached **Exhibit B**, Google Search Results for 801 Broadway Ave, Suite 203, Grand Rapids, MI 49504.

12. Based on the facts above and applicable law, Michigan Strong accepted an anonymous contribution or a contribution by a person in a name other than the name by which that person is identified for legal purposes.

13. Further, Michigan Strong knowingly filed an incomplete and inaccurate campaign statement by accepting and reporting an illegal donation from an unknown unregistered PAC.

After reviewing this complaint, any answer, and rebuttal filed, the BOE should complete their investigation and make a finding that there may be reason to believe that Michigan Strong has violated the MCFA. The BOE should assess all penalties or fees necessary to bring Michigan Strong into compliance with the MCFA.

I certify to the best of my knowledge, information, and belief, formed after a reasonable inquiry under the circumstances, each factual contention of this complaint is supported by evidence.





Secretary Benson,

We are counsel to Michigan Strong and are in receipt of your letter dated October 24, 2022, labeled as "Second Notice." Please be advised, however, that our client received this letter today— December 14, 2022—despite it bearing a date of nearly two months ago. Please be further advised that this is the first letter our client received from your office regarding Campaign Finance Complaint No. 2022-09-123-41. With that in mind, we are responding as promptly as possible—indeed, this response is submitted the same day that our client received notice of these proceedings—regarding this alleged violation.

Michigan Strong received a copy of a draft of this complaint from a reporter on July 15, 2022.¹ Michigan Strong did not, however, receive a letter or notice from the State Bureau of Elections regarding this matter, and had no knowledge or indication that these proceedings had been commenced.

Upon review of the reporter's inquiry on July 15, 2022, it became apparent that a contribution had been incorrectly reported on Michigan Strong's 2022 January quarterly report. Specifically, a \$5,000 contribution from Alan Mack, received January 31, 2022, was incorrectly reported with the contributor listed as "Tudor PAC." This was a clerical error. The text in the memo line of the corresponding check (attached hereto as Exhibit A) read "Tudor PAC" and that information was input incorrectly by Michigan Strong's compliance professionals—a human error.

¹ It is not uncommon for would-be prospective complainants, political activists, or political adversaries to provide the media with draft complaints, but to then never submit the draft complaint to a regulator or adjudicative body. Until today, Michigan Strong was of the belief that this was what happened here, and that no such proceedings had been commenced before the Bureau.

As soon as Michigan Strong became aware of the error—again, that awareness stemmed from an inquiry by a reporter—Michigan Strong amended its 2022 January quarterly report to reflect the correct contributor (Alan Mack). That amendment occurred the same day that Michigan Strong learned of this error—July 15, 2022.

This was nothing more than a clerical error that was immediately resolved once our client was notified. MCL 169.241 provides that "[a] person who *knowingly* violates this section is guilty of a misdemeanor..." Michigan Strong did not *knowingly* report a contribution in the name of another. And, as soon as they became aware of the error, Michigan Strong amended the report to accurately reflect the contributor.

For the reasons stated above, Michigan Strong respectfully requests that the Bureau accept this response as timely under MCL 169.215,² and that the Bureau dismiss this complaint and find no reason to believe Michigan Strong violated the Michigan Campaign Finance Act.

Dear Mr. Avers:

The Department of State (Department) has finished investigating the campaign finance complaint filed against your client, Michigan Strong, by Lisa Honeycutt on July 7, 2022. The complaint alleges that your client violated the Michigan Campaign Finance Act (MCFA or Act). Specifically, the complaint alleges that your client accepted a contribution on December 31, 2021, from "Tudor PAC", which is not a registered political action committee with the State of Michigan. Accordingly, the complaint alleges that your client either accepted an anonymous contribution or accepted a contribution from a person in a name other than the person's name for legal purposes.

You responded to the complaint on December 14, 2022. In your response you indicated that your client became aware of this complaint from a reporter on July 15, 2022. You state that upon review of the reporter's inquiry, it became apparent that a contribution had been incorrectly reported on Michigan Strong's January 2022 quarterly report. You state that due to a clerical error, a contributor was listed as "Tudor PAC" (the text contained in the memo line of the check) rather than Alan Mack (the actual contributor). You go on to indicate that Michigan Strong amended its quarterly report to reflect the correct contributor on the same day it learned of this error, July 15, 2022.

Ms. Honeycutt was notified of your response on December 20, 2022 but did not provide a rebuttal.

Section 41 of the MCFA bars a person or committee from accepting and/or expending an anonymous contribution. MCL 169.241(2). Anonymous contributions are required to be given to a tax-exempt charity with a receipt given, and the receipt is to be maintained. *Id*. The Act prohibits a contribution "made, directly or indirectly, by any person in a name other than by which that person is identified for legal purposes." MCL 169.241(3). A knowing violation of this section is a misdemeanor punishable by a fine of not more than \$1,000. MCL 169.241(4).

The Department has reviewed your response and finds that the evidence provided, together with the admission in your response, establish that there may reason to believe that a violation has occurred.

When the Department finds that there may be reason to believe a violation has occurred, the Act requires the Department to use "informal methods such as a conference [or] conciliation" to correct the potential violation or to prevent further violation. MCL 169.215(10). Statute provides 90 business days for the Department to engage this resolution process. *Id*.

Upon review of the Michigan Campaign Finance Searchable Database, the Department is satisfied that you have subsequently filed an amended January 2022 Quarterly campaign statement correcting the error raised in this complaint. Given this, the Department concludes that a formal warning is a sufficient resolution to the complaint.

Please be advised that this notice has served to remind you of your obligation under the Act to disclose contributions and expenditures and may be used in future proceedings as evidence that tends to establish a knowing violation of the Act.
