I have received the complaint that Mr. Richard Briand filed against me regarding my campaign committee activities. I believe after reviewing the information I have provided you will find his complaint lacks merit and contains many false statements.

I opened up a Campaign Committee "Chuck Heit For Sheriff" on 05/04/2022 with the Berrien County Clerks Office and was given Committee ID #141151. I also obtained an Employer Identification Number (EIN) 88-2142214 with the IRS on 05/04/2022. These were done before I accepted any campaign donations. I have attached each of these forms for your review. You will notice this is more than two months before my golf outing fundraiser that was held on June 24, 2022, in which Mr. Briand falsely accuses me of not having a campaign committee established.

I have filed three separate campaign committee reports with the Berrien County Clerks Office and each of these are attached to this response. The first was filed on July 24, 2022, which includes 30 pages of itemized contributions that includes the golf outing and covers from 05/05/2022 to 07/20/2022. The second campaign committee report was filed on 10/23/2022 which covers from 07/21/2022 to 10/20/2022. The third campaign committee report was filed on 01/29/23 which covers from 10/21/2022 to 12/31/2022.

I reached out to Berrien County Clerk Sharon Tyler and she was surprised that she had been contacted regarding this complaint. To my knowledge I have filed all of my campaign committee reports before each of the filing deadlines. Mr. Briand also makes an issue about me not filing an affidavit of identity. This is done when you formally file to be a candidate to have your name listed on the ballot. At this time there is much discussion about the date of the 2024 primary possibly changing. The deadline to file for this election has not been set and I will absolutely file my affidavit of identity when I file to become a formal candidate.

I hope the information I have provided is helpful in showing that the complaint that has been filed against lacks merit.
