Upon these complaints I have taken down all campaign signs & mailers to cease and desist, as Ross Township Lawyers have requested of me, and to update campaign materials to be in compliance. (See attachment)

State of Michigan Regulatory Section please make a correction for the complainant as Ross Township. This is between Harris v. Ross Township not (Harris v. Hutchings). The complainant was filed on behalf of Ross Township Government appointed Township Supervisor with their Attorney's(See Attachment). The address on the complainant uses Ross Townships office address at 12086 M-89. Not Christina Hutchings address at 11904 Yorkshire. BOE please update this title and any responses should come through Ross Township not Hutchings.

The location of my campaign sign was on private property. (See Attachment) Sadly this sign has been stolen. Following the Bureau Of Elections 2020 warning to include a 'Paid By', I did update my signs as requested of me. I wrote the statement with a permanent marker 'Paid By Alex Harris' on all of my signs, as I intended to be in full compliance. In 2020 the notices I received from the BOE, formally referred to a "Paid by" correction to be made, that was the primary warning that I received, not a warning about an address. I did not give an additional detail any thought, as my address is on the sign with the jurisdiction 'Ross Township' that descriptive place is clearly where I reside. Anyone can look my name and this address up on 'google' and it will lead to me.

It sounds as though I have misunderstood the need for a home Street with Numbers, State and Zip Code. In recent investigation, it appears many candidates(the complainant) use a PO BOX for an address, and this is considered acceptable to divert any possible trouble with putting your home number out in public? I will add my Street with Numbers, State and zip code or a PO BOX, since it appears this was my misinterpretation, I have now done so. (see attachment)

Regarding the public image/logo of our American flag and Township, I used no public funds. There are no discernable trademarks, nor other markings/claims of artistic license. I did however, re-create the image/logo in my campaign, as I noted that Christina Hutchins(the complainant) clearly incorporates that logo in her own Facebook page. (see attachment) I assumed (wrongly???) that said image/logo was a PUBLIC SYMBOL - representing the Nation and Township of the office I am seeking election.

However, IF the use of said logo IS somehow considered a 'monetary asset', as alleged by Christina Hutchins, and thus, some kind of FEC (Federal Election Commission) "campaign donation" - may I again point out that Ms Hutchins' own Facebook website incorporates the very **same** logo! Is Ross Township "allowing" the use of their logo for the endorsement of their 'chosen', and select, candidates - but NOT others? It appears so! Perhaps the BOE needs to be looking at the one(s) making the accusations - rather than at me?!!

According to the Official **Public & Government Service** webpage Christina Hutchings, Ross Township Supervisor/Personal campaign social media platform. The official/unofficial Ross Township body is actively endorsing my competitor Mary Stage. (Please see attachment) A relevant detail in my recent primary election, held by Ross Township, they illegally issued two ballots to one person, this was a newly registered voter on election day, resulting in my tied election. This is not very professional for a Government Body to pick and choose, rather it should be to serve.

I will be in full compliance going forward with the correction of 'Paid By'. Unfortunately, this is big Government bullying a small republican nominee for the Clerks office.

Greetings Bureau of Elections:

Perhaps you are suggesting I file 2 complaints for Mr. Harris? One on behalf of Ross Township? Ross Township's legal counsel clearly had cause to order a cease and desist for his promoting for political and personal gain, the Township's photos and logo without consent of the Township. When Alex Harris attended the Board meeting of September 28 and accused us of harassment, I had to remind him he was STILL USING a photo of the Ross Township fire department and offices on his Facebook campaign page, which is a continued violation of our attorneys cease and desist and our website's Terms of Use agreement. He finally changed his cover page after this meeting.

Second to this, Christina Hutchings has been the Ross Township Supervisor since I was appointed by the Board of Trustees February 2021. Having successfully campaigned and win the August primary, I am no longer just a candidate. I am officially employed by the Township as Supervisor, I am NOT APPOINTED. I had to campaign for the role I won, and none of my campaign materials used Ross Twp. Logo or resources. Attached samples for your review.

The Ross Township Newsletter "Updates you can use" is public. This resource is emailed from the Township to over 500 emails. We provide technology within the newsletter itself to share with others, forward text a link, and post our Newsletter to various other websites as desired in the public realm. This is specifically created for a mass communication mailing via email, and it is intended to be shared. I broke no rules by sharing the Ross Township newsletter to my campaign page to promote it to constituents.

'Christina Hutchings for Ross Township Supervisor' has NEVER been a topic of writing or influence in this official e-newsletter campaign, and residents have not EVER received an e-newsletter endorsing ANY CANDIDATE. This includes me, Mary Stage, Carin Louis (the current Clerk), and Alex Harris.

Any of these candidates as well as the general public can repost and share the e-newsletter, this is not illegal. I enclose examples. Should I have used the e-newsletter to advance my campaign, that would be of concern. I assure you—this did not ever occur.

I have authority to run my own Facebook page, called 'Christina Hutchings, Ross Township Supervisor'. This is NOT an official page of Ross Township, especially because it has my face and title only. No official Township business is EVER conducted via this Facebook page. I will, on occasion, pull ALREADY PUBLIC INFORMATION from the Ross Twp website to answer constituents' questions off Township working hours.

Ross Township's website is [www.rosstownshipmi.gov](http://www.rosstownshipmi.gov)

I encourage you to look at our website and the details that are open to public view and sharing. This is exactly why the Township created a "Terms of Use" legal statement, so people could use what they want, but not abuse Township specific logos and photographs.

I contacted Kalamazoo County Clerk's office of Elections to be sure I was able to speak as Christina Hutchings, and not as official Ross Township, using my own Facebook page. I have exercised caution to keep both Township website and resources very separate from my own Facebook page offerings. When I post township information from the Township's website, I cite where it came from. It is never cited as my original or exclusive work.

In closing, I have a right to voice whomever I choose to endorse on my own Facebook page. I chose to endorse Mary Stage, Alex Harris' opponent. This is my right and I have NEVER disparaged Alex Harris publicly on my Facebook or on the Townships website. I urge you to view both Ross Township's website and my personal Facebook site, you will clearly see the Township has never endorsed any political candidate. None of the Township website's resources have been used to promote me, Mary Stage, or Alex Harris.

I still contend Mr. Harris' unauthorized use of the Ross Township logo in his campaign flyers from 2020 and again in 2022, are very clear violations. If I am to know better, just like all other political candidates, so should he. I attach my campaign resources for your review since Mr. Harris is trying to accuse me of wrongdoing.

One final: One document with the flag and "Kerry Lynn Elieff" isn't my campaign material. If you look closely, it was my opponent's campaign flyer, not mine.
