

Dear Ms. Baker:

The Department of State (Department) has received a formal complaint filed against you by William Ostash alleging that you violated the Michigan Campaign Finance Act (MCFA or Act). Specifically, the complaint alleges that you made qualifying independent expenditures that required the filing of an independent expenditure report. A copy of the complaint is included with this notice.

The MCFA requires that a person, other than a committee, that makes an independent expenditure of \$100.01 or more advocating for the election or defeat of a candidate must file an independent expenditure report within 10 days of making the expenditure. MCL 169.251(1). A person who fails to file a required report may be subject to late filing fees up to \$5,000 and a civil fine up to \$1,000, and/or imprisonment for no more than 90 days. MCL 169.251(2).

The complaint also alleges that you were required to form a committee. By statutory definition, a committee is formed when "a person receives contributions or makes expenditures for the purpose of influencing or attempting to influence the action of the voters for or against [candidate, ballot question, etc.] if contributions received total \$500.00 or more in a calendar year or expenditures made total \$500.00 or more in a calendar year." MCL 169.203(4). However, the word "person" is defined in the Act as businesses, corporations, and committees, among other entities. MCL 169.211. For purposes of determining whether a committee exists, "[a]n individual, other than a candidate, does not constitute a committee." 169.203(4). Because you do not qualify as a committee, the Department dismisses the alleged violations of sections 26, 33, and 36 of the Act.

The purpose of this letter is to inform you of the Department's examination of these matters and your right to respond to the allegations before the Department proceeds further. <u>It is important to understand that the Department is neither making this complaint nor accepting the allegations as true</u>. The investigation and resolution of this complaint is governed by section 15 of the Act and

the corresponding administrative rules, R 169.51 *et seq*. An explanation of the process is included in the enclosed guidebook.

If you wish to file a written response to this complaint, you are required to do so within 15 business days of the date of this letter. Your response may include any written statement or additional documentary evidence you wish to submit. Materials may be emailed to BOERegulatory@michigan.gov or mailed to the Department of State, Bureau of Elections, Richard H. Austin Building, 1st Floor, 430 West Allegan Street, Lansing, Michigan 48918. If you fail to submit a response, the Department will render a decision based on the evidence furnished by the complainant.

A copy of your answer will be provided to Mr. Ostash, who will have an opportunity to submit a rebuttal statement to the Department. After reviewing the statements and materials provided by the parties, the Department will determine whether "there may be reason to believe that a violation of [the MCFA] has occurred [.]" MCL 169.215(10). Note that the Department's enforcement powers include the possibility of entering a conciliation agreement, conducting an administrative hearing, or referring this matter to the Attorney General for enforcement.

Can someone please explain what this letter means? From what I am understanding I am being fined because Mr. Ostash Lost the election and he is blaming me; a single mother of four (with twin handicapped boys) on a fixed income for putting up \$50 worth of yard signs (100 signs I got the posts from my shed they were in there when I bought the house, I got the signs in red cause they were blank red signs so my friend said you can have them. then my other friend and myself got together with her circuit making the words for the signs). It cost me \$50 in vinyl. Then we drove around Saginaw putting them up in areas other signs were. Within 2 hours he had them all taken down. So I then started a free Facebook page with one like and 1 follower (he was probably the follower) From what I understand he is upset about losing he is trying to get the State Michigan to make me pay for his loss.

As a Saginaw City resident I had an experience with Mr Ostash and his Husband Mr. Rooker. One that personally impacted my life in such a negative way it's still affects me to this day. A decision was made to send a cease and desist email to the contractor (United way free ramp). His husband and himself decided to get involved after being asking to help out in the build of my temporary handicap ramp from other people involved in the historical community. I needed the temporary ramp to leave my home for doctors appointment or in case of an emergency (my leg had been shattered and had to be reconstructed over 4 long painful surgeries). So instead of saying oh I'm busy on that day or sorry I can't help out this married couple decided to shut my ramp down by scaring the contractor.

When he came up for election, I being a voter, expressed my opinion. I felt that he did hurt families with disabilities like mine and so I spoke the truth. And the moment I did,

he saw my signs took them down less than 2 hours after I put them up! Then I created a FREE Facebook page (I followed all the protocol facebook told me to do to get the page page up. Facebook told me I had to put paid for by Rachel baker on my posts because I was going to do them as ads but I needed a notarized letter stating I was me. I didn't get a chance to take the paper to the bank to get notarized to send to facebook in time. So no money was spent on Facebook. Now, because I expressed my opinion, I get this letter? I don't understand. Voters are to have no opinion? Voters aren't allowed to express express their opinion or share them with other? I have to start a committee to be motivated and have an opinion in the USA? I didn't spend millions on a campaign against him I spent \$50 and hard work and determination to be heard by my fellow voters on my part. Maybe let's talk about the class 3 misdemeanor that was committed by taking downs signs that are not yours. I need to file a complaint

for that please.

By statutory definition, a committee is formed when "a person receives contributions or makes expenditures for the purpose of influencing or attempting to influence the action of the voters for or against [candidate, ballot question, etc.] if contributions received total \$500.00 or more in a calendar year or expenditures made total \$500.00 or more in a calendar year." MCL 169.203(4). However, the word "person" is defined in the Act as businesses, corporations, and committees, among other entities. MCL 169.211. For purposes of determining whether a committee exists, "[a]n individual, other than a candidate, does not constitute a committee." 169.203(4). Regarding Ms. Baker stating she made these signs with vinyl lettering I feel is not a true statement. For my campaign I had signs made and 100 had cost me over \$800.00. See attachment invoice and order from Campaign Catalyst. Why I feel the signs were not made with vinyl tape with friends as she states. I have obtained a sign and took a few photos of it. I obtained this sign from a resident. The sign was put on the owner's property with no approval. See photos "A.jpeg, B.jpeg, C.jpeg" attached. You can see these are printed. Photo C.jpeg shows there is not vinyl, and the letters edges are perfect. Also, she was able to create content as needed. See Facebook page attached screen shot "D.jpeg". You can see the meta data shows I captured this on October 22, 2022. You also can see in this photo content had changed from myself to now my husband as well. He ran for Saginaw Public School Board. The signs had complete rewording. He has not filed a Bureau of Elections (BOE) complaint as I have for violating the Michigan Campaign Finance Act (MCFA) to date.

Also, to address her statement, I took her signs down and I am in violation of a class three misdemeanor. The week Rachel Baker put her signs up I was in Muskegon Michigan attending the 2022 Michigan Municipal League Conference. I left for the conference on Tuesday October 18, 2022, and returned to Saginaw on October 21, 2022. See the attached photo "E.jpeg" which shows charges to my credit card for purchased in Muskegon. Photo "F.jpeg" shows Tesla charging charges I had returning home Friday October 21, 2022. I have also attached the conference confirmation email: *Fwd MML Event Confirmation 2022 MML Convention.pdf* from the City Manager staff that booked this trip. Not sure how this relates to her rebuttal. But I addressed it.

Rachel's comment about her Facebook page that is has one follower, and she assumes it is me. I run many Facebook pages and you can see who your followers are. I can say it was not me. I was not going to follow this page. Not sure how this relates to her rebuttal. But I addressed it.

Rachel Baker states I am upset with the election loss, and I am making her pay for this by filing a complaint. This is a false accusation. I filled out the complaint date October 22, 2022 (17 days before election on 11/08/2022) and emailed all to the BOE on October 31, 2022 (8 days before election 11/08/2022). Rachel Baker received a copy my complaint in the first packet mailed to her that states this. I am very confused with this accusation that is misleading. Not sure how this relates to her rebuttal. But I addressed it.

My Reflection on my election loss November 8, 2022.

First, WOW!! What an amazing four years I had serving the residents of Saginaw, Michigan as your Councilman.

However, the day after this election I was in disbelief that I'd lost, as were many of you, my friends, and fellow residents. Thank you for all the calls, texts, and messages of support.

Emotionally, I felt grief as though I had lost an immediate family member. Because I lost something I truly loved doing and had my soul into.

I was deeply involved in neighborhood associations, commissions, and boards prior to Covid. Then late 2021 began to do so again. I poured myself into this city, volunteering and helping residents wherever and whenever I could. I was accessible, got things done and was responsive.

As I reflected about my loss the next day. I kept processing all the conversations I was having afterwards. Especially from my Mayor, Brenda Moore who I adore and look to as a mentor. During our conversation she said, "Brother, look how much you have grown, don't forget your contacts and the Michigan Municipal League (MML)"!

I then thought about all the people I have met, helped, and worked with and decided that I was not going to stop serving my community or go anywhere. This election loss had only made me stronger!!

I reflected even further; I saw my incredible growth as a person. I have learned so much, gained friendships, connections, and knowledge, over the last four years.

I realize, I will have some time now to do things I have been wanting to get moving. As a City Councilman time was slim because I worked it first. My residents came above all, and they can attest to that. I had heard that residents would say, "when you need something, call Bill"! City staff could not believe I had a 9-5 job running an IT Programming team, because of the time I spent with my council position.

Over the course of the next two years, I will continue to build myself. One, of which, I am working directly with one of our neighborhoods on the SW side regarding community organization and programming for their center. I will also prepare to run for council again in 2024. It will be one heck of a campaign and I will work even harder to reach some areas of Saginaw I was not able to. Saginaw is big city to walk knocking doors, trying to reach them all is a challenge.

I will continue to be very active in Saginaw. I will frequent the neighborhood associations. I will continue to serve on the Planning Commission, and I applied to the Saginaw Economic Development Corporation

(SEDC) commission. I will devote time to help with the Potter Street Train Station restoration project. I want to make sure I can lend a hand with this preservation initiative where needed. Especially with STARS transit looking to restore the station and put their corporate headquarters there. I will continue to serve on the Saginaw County Animal Shelter Board. Last, I will keep my seat on the Great Lakes Bay Pride Board, LGBGTQ+ non-profit as a director. I can have a huge impact on our community for you.

Looking back, I need to remember what was accomplished with the city staff and as City Council for Saginaw. First, there marijuana legalization in the state of MI in 2018. We had to act, as there was organizing within the city to create their own ordinance per the new law if we did not. We got this done and it was solid. Second, we had to deal with the pandemic. There was a city to run. This went on for two years. I feel city staff, Manager Morales and City Council did a great job to get through this.

To revisit my personal accomplishments. I will be ever so proud of bringing two programs to our city. They are:

One, working with Saginaw County Health Department, City of Saginaw Staff, City Attorney, Great Lakes Bay Health Centers, our Saginaw Police Department, and countless others, we put in place a harm reduction/safe syringe program to assist with heroin addiction. Saginaw County was one of the Michigan counties, that had not adopted the Michigan Department of Health and Human Services (MHHDS) program. Hence, the beautiful 50-foot mural on the County Building representing this.

Second, with the help of the State Historic Preservation Office (SHPO), the city Urban Planner Robert Gollin and the Historic District Commission (HDC), the city implemented, "Certified Local Government (CLG)". CLG covers the preservation development side. This can have and will have huge grant potentials for economic development. To note, prior the city was certified as a "Redevelopment Ready City (RRC)" impacting the DDA district. The CLG certification program can also work in tandem with our RRC certification.

As stated, I am not going anywhere or stopping. I am just getting started, reprioritizing and setting new goals and directions. I may have lost an election, but I feel I won. Because I get to continue to #MoveSaginawForward and doing what I love. So, let's get it done.

Once a Councilman, always a Councilman and I am here to serve!!

Peace, Love and Thank You Saginaw for ALL the support you have given me throughout my tenure and after the election loss I endured.

Not sure how this relates to her rebuttal. But I will address it. Rachel Baker is stating I have affected her life regarding an accident in her rebuttal. She is stating I had stopped the building of a ramp for access to her house. She states I sent a cease-and-desist email to her contractor which an attorney would send, so I am very confused with that statement.

The accident and issue she had was with the City of Saginaw in 2020 for permits to build the ramp. She has failed to state that the issues were with the Historic District Commission (HDC) needing to approve the ramp build. There would not have been an issue if Rachel Baker would have obtained the building permit. Building permits trigger the HDC application. Supporting documents for this attached:



Dear Ms. Baker:

The Department of State (Department) has finished investigating the campaign finance complaint filed against you by William Ostash alleging you violated the Michigan Campaign Finance Act (MCFA or Act). This letter concerns the disposition of that complaint.

First, the complaint alleged that you made qualifying independent expenditures in the form of yard signs and Facebook postings that required the filing of independent expenditure reports. The complaint also alleged that, in the alternative, you were required to form a committee as a result of your actions.

From the outset, the Department dismissed the second allegation in full. By statutory definition, a committee is formed when "a person receives contributions or makes expenditures for the purpose of influencing or attempting to influence the action of the voters for or against [candidate, ballot question, etc.] if contributions received total \$500.00 or more in a calendar year or expenditures made total \$500.00 or more in a calendar year." MCL 169.203(4). However, the word "person" is defined in the Act as businesses, corporations, and committees, among other entities. MCL 169.211. For purposes of determining whether a committee exists, "[a]n individual, other than a candidate, does not constitute a committee." 169.203(4). As such, you do not qualify as a committee and alleged violations of sections 26, 33, and 36 of the Act were dismissed.

You responded to the complaint in a letter dated December 7, 2022. In your response, you argued that you did not purchase the signs in question; rather, you were given the blank signs by a friend and found the stakes in your shed when you moved into your home. You stated the sign lettering was created by you and a friend using a Cricut for the cost of the vinyl, which was approximately \$50.00. You also argued that you were unable to complete the process of verifying your identity to purchase ads on Facebook and so your Facebook posts cost you no money, bringing the total expenses for your efforts to \$50.00.

In your response you also made allegations regarding the removal of the signs you placed in your neighborhood and the construction of an accessibility ramp at your home. These matters are not covered by the Act and will not be addressed further in this determination.

In an email received on January 17, 2023, Mr. Ostash rebutted your arguments. He provided close-up photographs of the signs, alleging to show their construction and quality, along with receipts documenting the cost of similarly printed signs for his campaign. Additional copies of postings from your Facebook group were also provided.

Accordingly, the Department proceeds to the determination stage considering all of the relevant material provided by both parties.

The MCFA requires that a person, other than a committee, that makes an independent expenditure of \$100.01 or more advocating for the election or defeat of a candidate must file an independent expenditure report within 10 days of making the expenditure. MCL 169.251(1). A person who fails to file a required report may be subject to late filing fees up to \$5,000 and a civil fine up to \$1,000, and/or imprisonment for no more than 90 days. MCL 169.251(2).

Expenditure is defined in the Act as "a payment, donation, loan, or promise of money or anything of ascertainable monetary value for goods, materials, services, or facilities in assistance of, or in opposition to, the nomination or election of a candidate, the qualification, passage, or defeat of a ballot question, or the qualification of a new political party." MCL 169.206(1)

The Department has reviewed the evidence submitted in this matter and finds that insufficient evidence has been presented to support a finding of a potential violation of the MCFA. Specifically, the Department finds your explanation that your costs for producing the yard signs totaled under \$100.00 and that no expenses were incurred when creating your Facebook posts credible. While evidence was submitted showing the cost of printed signs, sufficient evidence was not submitted to show your signs were not made with a personal Cricut machine. Additionally, no evidence was submitted showing there to be a cost associated with your Facebook posts. As such, the Department dismisses the Section 51 allegations contained in the complaint.

Accordingly, the Department dismisses the complaint and will take no further action.
