



Dear Stephanie Boone for Kent County Commissioner:

The Department of State (Department) has received a formal complaint filed against you by Gerard Sullivan alleging that you violated the Michigan Campaign Finance Act (MCFA or Act). Specifically, the complaint alleges that you made expenditures for advertisements that were not included in your pre-primary campaign finance report, filed with Kent County July 20, 2022. The Department confirmed independently that an expenditure for the cost of the advertisements does not appear to be accounted for in the <u>report</u>. A copy of the complaint is included with this notice.

The MCFA requires that candidates and committees record the full name, street address, amount contributed, and date of contribution for each individual from whom contributions are received. MCL 169.226(1)(e). Further, if the individual's cumulative contributions are more than \$100.00, the candidate or committee must also report the individual's occupation, employer, and principal place of business. *Id.* For each person other than an individual, candidates and committees need not include the additional employment information but must provide all other contributor information previously listed. MCL 169.226(1)(g).

The purpose of this letter is to inform you of the Department's examination of these matters and your right to respond to the allegations before the Department proceeds further. It is important to understand that the Department is neither making this complaint nor accepting the allegations as true. The investigation and resolution of this complaint is governed by section 15 of the Act and the corresponding administrative rules, R 169.51 *et seq*. An explanation of the process is included in the enclosed guidebook.

If you wish to file a written response to this complaint, you are required to do so within 15 business days of the date of this letter. Your response may include any written statement or additional documentary evidence you wish to submit. Materials may be emailed to BOERegulatory@michigan.gov or mailed to the Department of State, Bureau of Elections, Richard H. Austin Building, 1st Floor, 430 West Allegan Street, Lansing, Michigan 48918. If you Stefanie Boone for Kent County Commissioner Page 2

fail to submit a response, the Department will render a decision based on the evidence furnished by the complainant.

A copy of your answer will be provided to Mr. Sullivan, who will have an opportunity to submit a rebuttal statement to the Department. After reviewing the statements and materials provided by the parties, the Department will determine whether "there may be reason to believe that a violation of [the MCFA] has occurred [.]" MCL 169.215(10). Note that the Department's enforcement powers include the possibility of entering a conciliation agreement, conducting an administrative hearing, or referring this matter to the Attorney General for enforcement.

After review of my records, it does appear that an oversight on my part has occurred. On 7/28/2022 I made a payment to the Lowell Ledger/Buyers Guide in the amount of \$1011.15 for the ad in question in this complaint. I used my personal credit card for this expenditure, and overlooked the expense when reviewing my accounts at the time of filing. There is no debt owed by the campaign, as the debt has been forgiven by the campaign and the campaign committee has been closed.

I logged into the online filing system on 2/5/2023 and submitted an amendment to reflect this oversight.

I am not sure if there is any follow-up action necessary to this, but please inform me if there is and I will get it taken care of. I apologize for any miscommunication or misunderstanding as it was not my intention for this to happen. This was my first campaign for an elected position, and I did my very best to follow MCFA to the best of my abilities.

Dear Ms. Boone:

The Department of State (Department) has finished investigating the campaign finance complaint filed against you by Gerard Sullivan alleging that you violated the Michigan Campaign Finance Act (MCFA or Act). This letter concerns the disposition of that complaint.

The complaint alleged that you made expenditures for advertisements that were not included in your pre-primary campaign finance report, filed with Kent County July 20, 2022. The Department confirmed independently that an expenditure for the cost of the advertisements does not appear to be accounted for in the <u>report</u>.

You responded to the complaint in a letter received by the Department on February 8, 2023. In your response, you thanked the Department for bringing the issue to your attention and acknowledged that there had been an oversight on your part. You stated that you used your personal credit card in making the expenditure in question and failed to account for the expense in your report. You stated that you filed an <u>amended report</u> on February 5, 2023 to disclose the expenditure, and that you are willing to take other actions to address the matter.

While the complaint alleged that the expenditure should have been included in your pre-primary report, that report covered activity running through July 17, 2022; as the payment was made on July 28, 2022, you correctly included it in your post-primary report, which covers the period from July 18, 2022 to August 22, 2022.

In a letter dated February 22, 2023, the Department provided Mr. Sullivan the opportunity to submit a rebuttal statement; to date, no rebuttal has been received.

The MCFA requires that candidates and committees record the full name, street address, amount contributed, and date of contribution for each individual from whom contributions are received.

MCL 169.226(1)(e). Further, if the individual's cumulative contributions are more than \$100.00, the candidate or committee must also report the individual's occupation, employer, and principal place of business. Id. For each person other than an individual, candidates and committees need not include the additional employment information but must provide all other contributor information previously listed. MCL 169.226(1)(g).

Upon review of the evidence submitted, the Department finds that sufficient evidence has been presented to support a finding of a potential violation of the MCFA. After reaching this conclusion, the Act requires the Department to "endeavor to correct the violation or prevent a further violation by using informal methods" if it finds that "there may be reason to believe that a violation ... has occurred [.]" MCL 169.215(10). The objective of an informal resolution is "to correct the violation or prevent a further violation." *Id*.

You acknowledged in your response that you did not realize that you were out of compliance with the MCFA. Once you were made aware, you amended your report and indicated that you would take any other necessary steps to remedy the matter.

Given the steps you took to address the violation, the Department has determined that a formal warning is a sufficient resolution to the complaint and will consider this matter concluded.
