Now appears Mr. Jason A. Watts, Complainant, PO Box 216, Allegan, MI 49010, making his complaint against Committee to Elect (CTE) Scott Beltman, 3110 130th Ave, Hopkins, MI 49328. In this complaint, Mr. Watts states:

1. That CTE Scott Beltman is the committee for Scott Beltman, candidate for County Commissioner – 3<sup>rd</sup> District, filed with the Allegan County Clerk.
2. That CTE Scott Beltman did not file Late Contribution Reports (LCR) on 7/18/2022, 7/20/2022, or 7/29/2022 in violation of MCL 169.232<sup>1</sup>. Complainant confirmed that no LCRs were filed on 9/1/2022 with the Allegan County Clerk's office<sup>2</sup>.
3. That the CTE Scott Beltman's Pre-Primary report includes items after the close of books that should be in the Post-Primary report<sup>3</sup>.
4. That CTE Scott Beltman should have filed a LCR on:
  - a. 7/18/22 for Mr. Dan Caywood's \$900.00 cumulative contribution<sup>45</sup>,
  - b. On 7/20/2022 for Mr. Dan Caywood's \$1200.00<sup>6</sup> cumulative contribution<sup>7</sup> and Mr. Brad Beltman's \$550.00 cumulative contribution.<sup>8</sup>
  - c. On 7/29/2022 for Ms. Kelly Caywood's \$500.00 cumulative contribution<sup>9</sup>.





5. That CTE delayed reporting a final mailer nearly a month after it was sent out<sup>10</sup>. This is not in keeping with committee's other reporting of a mailer that was mailed 6-25-22<sup>11</sup>. This seems to suggest that an independent contractor mailed the mailer on behalf of the campaign potentially in violation of MCLs 169.233 and 169.243. The USPS will not send out anything without paid postage. Is the public to assume that said mailer was sent out for free?
6. When the CTE received \$400 from Mr. Dan Caywood on 7/20/2022<sup>12</sup>, the committee received over \$150.00 over the contribution limit for county commissioner candidates in the county of Allegan (in violation of MCL 169.252). It is common practice that such overages are returned to the contributor within 30 days. The committee has yet to return the contribution.
7. It should also be noted that CTE Scott Beltman is also carrying over the incorrect ending balance from the Pre-Primary Report.<sup>13</sup>

Mr. Watts believes that CTE Scott Beltman through all these actions is trying circumvent the MCFA and that a **\$1,000.00 fine**, imprisonment for up to **93 days**, or **both** be assessed. Mr. Watts notes that CTE Scott Beltman did not file timely late contribution reports, in violation of **MCL 169.232** and should be assessed the maximum fine of **\$2,000.00**. The CTE Scott Beltman should also return **\$150.00** to Mr. Dan Caywood forthwith; the excess amount over the contribution limit.

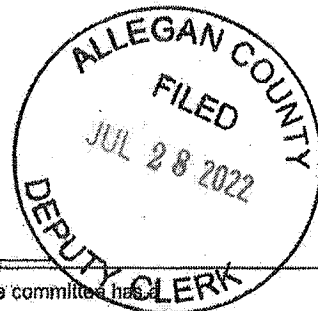

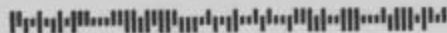

Dear Mr. Beltman:

The Department of State (Department) has received a formal complaint filed against you by Jason Watts alleging that you violated the Michigan Campaign Finance Act (MCFA or Act). Specifically, the complaint alleges that you failed to file late contribution reports for contributions received during the late contribution period, that contributions from Dan Caywood were in excess of the amount allowed, and that you failed to report expenditures for a mailer until nearly a month after it was sent out. A copy of the complaint is included with this notice.

Under the MCFA, a candidate committee must file a late contribution report for contributions from the same contributor with a cumulative total of \$500 or more received after the closing date of the last campaign statement required to be filed before an election. MCL 169.232(7).

In Michigan, contributions to a candidate committee are governed by statute. MCL 169.252. Specifically, in local elections for districts containing fewer than 85,000 people, no person could donate more than \$1,050 during the 2022 election cycle.<sup>1</sup>

It appears that the \$400 contribution from Dan Caywood on July 20, the \$400 contribution from Brad Beltman on July 20, and the \$200 contribution from Kelly Caywood on July 29 all fall within the late contribution period. The complainant submitted an email from Allegan County stating that you had not submitted late contribution reports as of September 1, 2022.

The Department dismisses the third allegation—that a mailer was not reported until nearly a month after it was sent out. This timeline is in keeping with the typical timeline for a product to be sent, an invoice to be created and delivered, and an invoice to be paid.

The purpose of this letter is to inform you of the Department's examination of these matters and your right to respond to the allegations before the Department proceeds further. It is important to

understand that the Department is neither making this complaint nor accepting the allegations as true. The investigation and resolution of this complaint is governed by section 15 of the Act and the corresponding administrative rules, R 169.51 *et seq.* An explanation of the process is included in the enclosed guidebook.

**If you wish to file a written response to this complaint, you are required to do so within 15 business days of the date of this letter.** Your response may include any written statement or additional documentary evidence you wish to submit. Materials may be emailed to [BOERegulatory@michigan.gov](mailto:BOERegulatory@michigan.gov) or mailed to the Department of State, Bureau of Elections, Richard H. Austin Building, 1<sup>st</sup> Floor, 430 West Allegan Street, Lansing, Michigan 48918. If you fail to submit a response, the Department will render a decision based on the evidence furnished by the complainant.

A copy of your answer will be provided to Mr. Watts, who will have an opportunity to submit a rebuttal statement to the Department. After reviewing the statements and materials provided by the parties, the Department will determine whether “there may be reason to believe that a violation of [the MCFA] has occurred [.]” MCL 169.215(10). Note that the Department’s enforcement powers include the possibility of entering a conciliation agreement, conducting an administrative hearing, or referring this matter to the Attorney General for enforcement.

This is an addendum to my complaint (No. 23-023) made on 9/1/22. Through a mutual acquaintance, I assisted the committee in correcting their campaign finance reports<sup>[1]</sup>. The committee's troubles are a result of unfamiliarity with Michigan Campaign Finance and lack of training provided by the Allegan County Clerk (ACC). I believe these amended reports clear most of the outstanding issues in the complaint.

On the matter of Mr. Dan Caywood exceeding the contribution limit for the cycle, I believe the committee has corrected the issue. Based upon the committee's amended reports, Mr. Caywood did not exceed the contribution limit for the cycle. The committee de-reported a contribution by Mr. Caywood in their amended Post-Primary Report.

In review, it appears that the only areas where the committee is out of compliance are the two Late Contributions where the committee did not file timely reports. I note that the Allegan County Clerk has yet to issue any fines as it relates to these Late Contribution Reports.

I believe these amended reports clear most of the outstanding issues in the complaint.

Looking at the late contribution reports the committee filed on 10/28/22, it is only claiming late contributions from Dan Caywood (7/20/22) and Brad Beltman (7/22/22)<sup>2</sup>. They de-reported the contribution from Kelly Caywood.<sup>3</sup> That contribution was actually received by the committee on 7/16/22 and reflected in the committee's amended Pre-Primary Report.<sup>4</sup>

I did review the expense related to my third allegation, and find that everything is in order. The mailing house sent the second mailing on credit and it was paid a little over a month past the Primary.

On the matter of Mr. Dan Caywood exceeding the contribution limit for the cycle, I believe the committee has corrected the issue. Based upon the committee's amended reports, Mr. Caywood did not exceed the contribution limit for the cycle. The

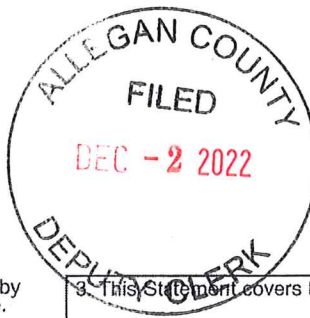

Dear Mr. Beltman:

The Department of State (Department) has finished investigating the campaign finance complaint filed against you by Jason Watts alleging that you violated the Michigan Campaign Finance Act (MCFA or Act). This letter concerns the disposition of that complaint.

The complaint alleged that you failed to file late contribution reports for contributions received during the late contribution period and that contributions from Dan Caywood were in excess of the amount allowed. The Department determined that it appeared that the \$400 contribution from Dan Caywood on July 20, the \$400 contribution from Brad Beltman on July 20, and the \$200 contribution from Kelly Caywood on July 29 all fell within the late contribution period. The complainant submitted an email from Allegan County stating that you had not submitted late contribution reports as of September 1, 2022.

You responded to the complaint in an email dated April 4, 2023. In your response, you claimed that this was the first time you ran for public office and the first time your treasurer was involved in a campaign, and that neither of you intentionally violated the MCFA. You stated that you reached out to Mr. Watts for assistance once you learned of the complaint and that you remedied the filings with his assistance. Finally, you attached the corrected filings in your submission to the Department.

Mr. Watts also sent a follow-up email to the Department on March 30, 2023. The Department asked in an April 7, 2023 email whether he intended the email to serve as his rebuttal statement. He responded that same day but did not answer that question. In the absence of an answer, the Department will treat the two emails as his rebuttal.

In his March 30, 2023 email, Mr. Watts included the corrected filings submitted by you to the Allegan County Clerk. He noted that the corrected submissions include late contribution reports for the contributions from Dan Caywood and Brad Beltman, and that the contribution from Kelly Caywood was corrected to the actual contribution date of July 16, 2022 and reflected in the

committee's amended pre-primary report. Further, he indicated that the contribution from Mr. Caywood that would have been in excess of the allowed amount was de-reported.

In his April 7, 2023 email he reiterated that the matter of your two outstanding late contributions had yet to be resolved, and asked that the complaint not be dismissed until any fines for late reporting had been assessed.

The Department emailed you on April 7, 2023 to confirm that, in addition to removing the contribution from Mr. Caywood, you returned that amount to him. In an April 17, 2023 email, you responded that the contribution had been removed from the initial report because it was mistakenly reported twice.

Under the MCFA, a candidate committee must file a late contribution report for contributions from the same contributor with a cumulative total of \$500 or more received after the closing date of the last campaign statement required to be filed before an election. MCL 169.232(7).

In Michigan, contributions to a candidate committee are governed by statute. MCL 169.252. Specifically, in local elections for districts containing fewer than 85,000 people, no person could donate more than \$1,050 during the 2022 election cycle.<sup>1</sup>

The Department has reviewed the evidence submitted in this matter and finds that sufficient evidence has been presented to support a finding of a potential violation of the MCFA because you initially failed to report the late contributions you received. After reaching this conclusion, the Act requires the Department to "endeavor to correct the violation or prevent a further violation by using informal methods" if it finds that "there may be reason to believe that a violation ... has occurred [.]". MCL 169.215(10). The objective of an informal resolution is "to correct the violation or prevent a further violation." *Id.*

Because you corrected your reports and removed the contribution that was mistakenly included twice, the Department has determined that a formal warning is the appropriate resolution to the complaint and will consider this matter concluded.


The Department notes that your committee may be assessed a late-filing fee by the Allegan County Clerk for any statement that was not timely filed. MCL 169.233(7). Late-filing fees are assessed and collected by the filing official with whom the statements are filed. MCL 169.217(1).
