Dear Mr. Cumings:

The Department of State (Department) has completed its investigation of the complaint filed against Representative Griffin by Brandon Dillon, which alleged a violation of the Michigan Campaign Finance Act (MCFA or Act), 1976 PA 388, MCL 169.201 *et seq*. This letter concerns the disposition of Mr. Dillon's complaint.

The MCFA and corresponding administrative rules require the Department to ascertain whether there may be "reason to believe that a violation of this act has occurred." MCL 169.215(10), R 169.55(3). If the Department finds that there may be "reason to believe that a violation of this act has occurred[,]" the Department is required by law to "endeavor to correct the violation or prevent a further violation by using informal methods." *Id*.

The MCFA prohibits a public body or an individual acting on its behalf from "us[ing] or authoriz[ing] the use of funds, personnel, office space, computer hardware or software, property, stationery, postage, vehicles, equipment, supplies, or other public resources to make a contribution or expenditure." MCL 169.257(1).

Mr. Dillon filed his complaint on September 23, 2016, and Rep. Griffin filed a written response dated January 24, 2017. The allegations of the complaint were that Rep. Griffin improperly used public finds by using her Van Buren County Commission email account to expressly advocate for her nomination and election, to further the nomination or election of other candidates, and to solicit campaign contributions.

In her response, Rep. Griffin pointed to five specific emails where she admitted that potential violations of MCL 169.257 may have occurred. First, two of these emails involved "testing the waters" discussions where Rep. Griffin was seeking advice on becoming and announcing as a candidate. Two emails discussed upcoming fundraisers and RSVPs for fundraisers, and the last email discussed volunteering for Rep. Griffin's campaign. Rep. Griffin stated that use of the county email was inadvertent and were sent from her privately-owned iPhone which had access to both emails. She further indicated that she has since put safeguards in place to prevent this from occurring again.

Dear Ms. Bourbonais:

This letter serves as Beth Griffin's answer to the complaint that Brandon Dillon filed on September 22, 2016. On October 7, you granted an extension of time to file this answer to November 14. Then on November 3, you informed me that Mr. Dillon had submitted supplemental evidence. Based on that submittal, on November 14 you granted a further extension of time to file this answer to November 21.

Background

We understand that Mr. Dillon through his associates submitted a FOIA request to Van Buren County in an attempt to obtain Ms. Griffin's e-mail messages from her public account for the past three years. Mr. Dillon then presumably reviewed all the e-mails, compiled the messages he felt were "political" in nature, and filed a complaint based on those e-mails. As to the substance of the complaint, the factual background contains so many inaccuracies that it is largely unintelligible. Mr. Dillon only provides an explanation of exhibits 2-9. His explanations contain entirely incorrect information for exhibits 2, 4, 5, 6, 7, 8, and 9. And he completely fails to explain or even cite exhibits 10-24. In the end, Mr. Dillon appears to rely only on his general claims in paragraphs 18-21 of his complaint without providing any intelligible argument as to how he feels each of his exhibits or supplemental evidence demonstrates a violation of Section 57 of the Michigan Campaign Finance Act (the "Act").

The balance of this letter will address each of Mr. Dillon's 24 exhibits and supplemental evidence. In short, the vast majority of Mr. Dillon's evidence should not amount to a violation of Section 57 of the Act. With that said, Ms. Griffin did send messages regarding her candidacy and campaign using her public e-mail account on a few isolated occasions over the past three years. But Ms. Griffin's use of the county e-mail system for these messages did not involve the use of public resources while Ms. Griffin was working as a county commissioner or while she was on county property, were not sent from county-owned device, and did not amount to an ascertainable monetary value of public resources. Further, this letter will explain that

Ms. Griffin has taken measures to ensure this type of inadvertent mistake does not occur again. Consequently, we request that the Department treat this matter the same as similar situations in the past by issuing a warning letter and using that letter as evidence in any future proceedings of a knowing violation of the Act.

Analysis

Mr. Dillon did present five e-mail messages that may be violations of Section 57 spanning approximately one year. In Exhibit 2, Ms. Griffin responded to a local township official regarding an upcoming township board meeting and in her response references an upcoming fundraiser for her campaign. In Exhibit 3, one of her colleagues sent her a message about a problem she was having with the online RSVP process for one of Ms. Griffin's upcoming campaign fundraisers. Ms. Griffin responded simply acknowledging her colleague's RSVP. In Exhibit 10, Ms. Griffin forwarded a state Republican party mass e-mail message to a person suggesting that the person forward the message to the local party and encourage people to get involved, including in her campaign. Finally, Exhibits 7 and 9, involve "testing the waters" discussions whereby Ms. Griffin seeks advice on becoming and announcing as a candidate for the state House.

The use of Ms. Griffin's county e-mail account for each of these five e-mail messages, however, was inadvertent. Ms. Griffin sent all of the e-mails from her privately-owned iPhone (see "on my iPhone" message at the end of each message). That iPhone did have access to both her private e-mail account and her county e-mail account. For each of these messages, Ms. Griffin mistakenly sent the messages on her county e-mail account. Upon realizing that these oversights had occurred, Ms. Griffin put safeguards in place to prevent this from happening again: she removed access to her county e-mail account from her iPhone. Further, as a state representative Ms. Griffin will not mix e-mail accounts on one cell phone. Rather, she will have one phone for political business and then access her state e-mail account using another device.

In addition, as a county commissioner, Ms. Griffin did not have a county office nor any specific office hours. So she did not use any further public resources (such as county time, county offices, or a county-owned computer or device) in sending the messages. The resources were limited to only the use of the county e-mail account. The Department has stated previously in a similar context that "[t]he cost to the county for using the e-mail system was too minimal to calculate."

Consequently, this situation is unlike the facts in the Stobie matter that Mr. Dillon raises. In the Stobie matter, the candidate was a public employee who sent messages under circumstances whereby the county treasurer could ascertain additional public resources that were expended—presumably salary and fringe benefits for the time that the employee sent the messages during office hours or in the office. This situation is more akin to Brewer v. Krueger (February 26, 2014) and Schuette self-report (December 4, 2015) whereby there was no ascertainable monetary value of public resources used.

In addition to the five messages discussed above, Mr. Dillon has raised 22 other messages that he apparently feels violate Section 57. Upon a review of these 22 messages, we do not believe they should constitute a violation of Section 57. As the Department has previously reasoned when reviewing e-mail messages under Section 57 of the Act, when the Department "has determined that [the message] does not contain words of express advocacy", "the use of a public e-mail account [] does not give rise to an expenditure." *See* Jones v. Foster (November 19, 2014). Below are brief descriptions for each of the 22 exhibits:

• Exhibit 4

This exhibit involves an initial message from the Lt. Governor's reelection campaign regarding an upcoming Lincoln Day event in 2014. Ms. Griffin simply responded with the information. The exchange did not involve Ms. Griffin's campaign.

• Exhibit 5

This exhibit involves an exchange between Ms. Griffin and a colleague at the county regarding whether Ms. Griffin will continue to serve as vice chair. Ms. Griffin does mention attending a meeting as a candidate for state representative. But it was a factual statement and not express advocacy.

• Exhibit 6

This exhibit includes a message from Ms. Griffin to another person referencing a previous conversation about the open state house seat. Ms. Griffin sent this message before she became a candidate. The message does not mention that she is or wants to run for the seat and otherwise does not contain any express advocacy.

Exhibit 8

This exhibit contains a string whereby another person began asking Ms. Griffin for contact information related to a local Republican party official. Ms. Griffin simply responded with the contact information. In her response, she mentions the possibility of running for the House seat, but does not confirm either way let alone expressly advocate.

• Exhibit 11

This exhibit contains an e-mail exchange regarding Ms. Griffin's appointment to the Michigan Board of Chiropractic. It does not involve any express advocacy regarding Ms. Griffin's candidacy. Rather, any mention of her candidacy is in relation to how she should describe it in her application materials for the board.

• Exhibits 12, 13, 14, and 15

These exhibits contain a string among a women's group from 2013. One of the women in the group mentioned that she announced to run for the House. Various women in the string offered support. Ms. Griffin responded on her iPhone that she would be willing to help, offered a suggestion on a platform for the candidate, offered advice on a compliance issue, and offered congratulations. The string had nothing to do with Ms. Griffin's candidacy and, in fact, occurred more than two years before Ms. Griffin became a candidate for state House.

Exhibit 16

This exhibit contains an exchange regarding Ms. Griffin's request for an official from an electric utility to speak to the Van Buren County Republican women's club. The exchange occurred in 2014 and does not involve any express advocacy.

• Exhibit 17

This exhibit contains an initial message from a House candidate in 2014. Ms. Griffin responded with gratitude to the candidate for running. The exchange did not involve Ms. Griffin's candidacy and, in fact, occurred more than a year before Ms. Griffin became a candidate.

Exhibit 18

This exhibit contains an exchange between Ms. Griffin and a township clerk. In the exchange, the township clerk attaches voter lists for the township. Ms. Griffin responds with a question. The exchange does not elaborate further. There is no express advocacy involved. And the exchange occurred in 2014.

• Exhibit 19

This exhibit contains a string whereby one of Ms. Griffin's county colleagues forwards her a campaign mass e-mail message from Ms. Griffin's opponent in her state House race. Ms. Griffin simply responds by saying thanks to her colleague. We understand that Ms. Griffin subsequently asked this person to cease sending these messages to her county e-mail account.

Exhibit 20

This exhibit contains a message forwarding a letter the editor criticizing the Van Buren County Board of Commissioners. Ms. Griffin is one of the recipients. Ms. Griffin responded by questioning the facts in the letter and mentioning that they are awaiting additional information. The exchange does contain any express advocacy and occurred in 2013.

Exhibit 21

This exhibit contains a string whereby one of Ms. Griffin's county colleagues forwards her a campaign mass e-mail message from Ms. Griffin's opponent in her state House race. Ms. Griffin forwards the message to one individual on her iPhone but does not otherwise respond. We understand that Ms. Griffin subsequently asked this person to cease sending these messages to her county e-mail account.

• Exhibit 22

This exhibit contains a string whereby one of Ms. Griffin's county colleagues forwards her a campaign mass e-mail message from Ms. Griffin's opponent in her state House race. Ms. Griffin simply responds by saying thanks to her colleague. We understand that Ms. Griffin subsequently asked this person to cease sending these messages to her county e-mail account.

Exhibit 23

This exhibit contains a string whereby one of Ms. Griffin's county colleagues forwards her a campaign mass e-mail message from Ms. Griffin's opponent in her state House race. Ms. Griffin forwards the message to one individual on her iPhone but does not otherwise respond. We understand that Ms. Griffin subsequently asked this person to cease sending these messages to her county e-mail account.

Exhibit 24

This exhibit contains an invite to attend a Van Buren County Republican Women meeting. Ms. Griffin simply responded that she'd be there. This is a simple scheduling message should not be construed as express advocacy.

• Supplemental Evidence, Exhibits 25-27

The supplemental evidence that Mr. Dillon submitted included three e-mails that Ms. Griffin sent from her personal e-mail accounts. They do not implicate any violation of Section 57 of the Act. And Mr. Dillon does not provide any analysis or discussion as to the purpose of this additional "evidence."

Conclusion

As stated above, Ms. Griffin did inadvertently send messages from her county e-mail account that may have violated Section 57 of the Act. For the five messages analyzed above, based on past Department precedent there was not an ascertainable monetary value of public resources involved and an appropriate resolution is a warning letter.

For the 22 other messages that Mr. Dillon raises, we do not believe they are violations of Section 57 of the Act. Regardless, even if the Department did consider some of those messages to be violations of Section 57 of the Act, we believe that the same analysis applies: the occurrence was inadvertent, there is not an ascertainable monetary value of public resources involved, and Ms. Griffin has taken steps to ensure these situations do not occur in the future.

Ms. Griffin takes her ethical duties as a public official very seriously. She desires to work cooperatively with the Department to resolve this matter amicably. And she is committed to ensuring that the changes she has made to her operations will continue to avoid any inadvertent issues with Section 57 of the Act moving forward. Please contact me if you have any questions. I look forward to working with you to resolve this matter.

Dear Ms. Griffin:

The Department of State (Department) received a formal complaint filed by Brandon Dillon against you, alleging that you violated the Michigan Campaign Finance Act (MCFA or Act), 1976 PA 388, MCL 169.201 et seq. The investigation and resolution of this complaint is governed by section 15 of the Act and the corresponding administrative rules, R 169.1 et seq. A copy of the complaint and supporting documentation is enclosed with this letter.

In Michigan, it is unlawful for a public body or individual acting on its behalf to use or authorize the use of "funds, personnel, office space, computer hardware or software, property, stationary, postage, vehicles, equipment, supplies, or other public resources to make a contribution or expenditure [.]" MCL 169.257(1). A knowing violation of section 57 is a misdemeanor offense. MCL 169.257(4).

Mr. Dillon alleges that you improperly used public funds by using your Van Buren County Commission email account to expressly advocate for your nomination and election, to further the nomination or election of other Michigan House candidates, and to solicit campaign contributions.

The purpose of this letter is to inform you of the Department's examination of these matters and your right to respond to the allegations before the Department proceeds further. It is important to understand that the Department is neither making this complaint nor accepting the allegations as true.

If you wish to file a written response to this complaint, you are required to do so within 15 business days of the date of this letter. Your response may include any written statement or additional documentary evidence you wish to submit. All materials must be sent to the Department of State, Bureau of Elections, Richard H. Austin Building, 1st Floor, 430 West Allegan Street, Lansing, Michigan 48918. If you fail to submit a response, the Department will render a decision based on the evidence furnished by the complainant.

A copy of your reply will be provided to Mr. Dillon, who will have an opportunity to submit a rebuttal statement to the Department. After reviewing all of the statements and materials provided by the parties, the Department will determine whether "there may be reason to believe that a violation of [the MCFA] has occurred [.]" MCL 169.215(10). Note that the Department's enforcement powers include the possibility of entering a conciliation agreement, conducting an

Complainant, Brandon Dillon, declares to the Secretary of State the following:

Jurisdiction and Legal Background

- 1. The Van Buren County Commission is a "public body" as defined under the Michigan Campaign Finance Act. MCL 169.211(7).
- 2. Beth Griffin is, and was at all relevant time periods, a Van Buren County Commissioner. Ms. Griffin's official Van Buren County governmental email address is griffinb@vbco.org, as evidenced on the County website at http://www.vbco.org/pages9845940.asp.
- 3. The Michigan Campaign Finance Act (MCFA) prohibits a public body or an individual acting on its behalf from "us[ing] or authoriz[ing] the use of funds, personnel, office space, computer hardware or software, property, stationery, postage, vehicles, equipment, supplies, or other public resources to make a contribution or expenditure." MCL 169.257(1).
- 4. Expenditure is a broadly-defined term under the MCFA and includes "a payment, donation, loan, or promise of payment of money or anything of ascertainable monetary value for goods, materials, services or facilities in assistance of, or in opposition to the nomination or election of a candidate." MCL 169.206(1).
- 5. The MCFA applies to the solicitation and acceptance of contributions because such activities are deemed to further the nomination, election, or defeat of a candidate.
- An expenditure made to gauge support for an individual's candidacy or to solicit advice
 regarding a possible candidacy is in violation of section 57 of the MCFA if public resources are
 used. See Tom Stobie letter from SOS dated October 30, 2014, Exhibit 1.

Factual Background

- 7. Ms. Griffin is a candidate running for office in the 66th District, Michigan House of Representatives.
- 8. On January 6, 2016, Ms. Griffin used her publicly provided, governmental email account to reach out to an individual she met at a meeting in her capacity as "a candidate for State Rep" to solicit contact about her campaign. Exhibit Number 2.
- 9. On February 7, 2016, Ms. Griffin used her governmental email account to accept RSVPs to her fundraising event. Exhibit Number 3.
- 10. On February 16, 2016, Ms. Griffin used her governmental email account to solicit attendance at her fundraiser at Café Julia in South Haven, Michigan. In this email, Ms. Griffin states, "I hope you can come to my Feb 20 fundraiser at Café Julia in South Haven, from 6-8 pm." Exhibit Number 4.
- 11. On May 18, 2016, Ms. Griffin used her governmental account to forward and promote a Michigan Republican Party event that expressly advocated for the election of Republican candidates. Specifically, the event was designed for "helping get Republicans elected" and it focused on "State House seats," thus directly benefitting Ms. Griffin's election bid. Exhibit Number 5.

- 12. Ms. Griffin sent a number of emails from her County provided email account to a number of individuals asking and informing them that she was exploring and gauging support for a run for state representative. Exhibit Number 6.
- 13. In one email, Ms. Griffin stated, "I'd love to come talk to you about the 2016 House race." Exhibit Number 7.
- 14. In another email, Ms. Griffin uses her County email to solicit a discussion and seek advice about her run for the House of Representatives. "About continuing our discussion about the 2016 open House race, would this Thurs evening, or next Mon or Tues evening work? Maybe just for 30 mins, to capture you and Judy's advice/thoughts...." Exhibit Number 8.
- 15. In yet another email, Ms. Griffin discusses getting her campaign up and moving. In the email, she stated she "will solicit Aric, Tonya's, and Middaugh's thoughts about timing for announcing...." Later in the email she stated, "I think I will need a day or two to file the Cte online, get the number, then form the bank account, po box, and then get debit card quickly so I can pay StudioOne." This email clearly shows campaign strategy activity. Exhibit Number 9.
- 16. Ms. Griffin also used her public, governmental email account to inform individuals that she is a candidate for the House of Representatives. In another email she states,"...no I am not running for the presidency. The House however...let's have coffee one morning and catch up." Exhibit Number 10.
- 17. Additionally, prior to becoming a candidate, Ms. Griffin used her county commission account to provide assistance to another state representative candidate. In an email string, Ms. Griffin offered a candidate for state representative both messaging and campaign fund raising advice. Exhibit Number 11.

Claims

- 18. Ms. Griffin improperly used public funds to further her nomination and election, and the nomination and election of other State House candidates, by sending campaign-related emails using her Van Buren County Commission email account
- 19. Additionally, Ms. Griffin solicited campaign contributions using public resources, as described in detail above. This is a direct violation of Section 57 of the MCFA. MCL 169.257.
- As discussed above, Ms. Griffin made numerous instances of express advocacy from her County provided email address account. This is a direct violation of Section 57 of the MCFA. MCL 169.257.
- 21. Finally, Ms. Griffin used her email to gauge support for her campaign in direct violation of Section 57 of the MCFA. MCL 169.257.

Conclusion

Based on the foregoing, Ms. Griffin is in violation of Section 57 of the MCFA.

Request of Action by the Secretary of State

The Complainant respectfully requests that the Secretary of State immediately investigate this violation and determine as a matter of law that Ms. Griffin has violated the MCFA and assess all appropriate penalties for such violation.

The Department of State (Department) has concluded its initial investigation of the complaint filed by Kimberly Joms against you, which alleged that you violated the Michigan Campaign Finance Act (MCFA or Act), 1976 PA 388, MCL 169.201 et seq. This letter concerns the disposition of Ms. Joms' complaint, which was filed on June 13, 2014. You filed an answer to the complaint on July 10, 2014, and Ms. Jorns filed a rebuttal statement on August 5, 2014.

Ms. Jorns alleged that you improperly used public funds to further your nomination or election by sending campaign-related emails using your Frankfort-Elberta Area Schools' (FEA Schools) email account.

The MCFA prohibits a public body or an individual acting on its behalf from "us[ing] or authoriz[ing] the use of funds, personnel, office space, computer hardware or software, property, stationery, postage, vehicles, equipment, supplies, or other public resources to make a contribution or expenditure." MCL 169.257(1). Expenditure is a term of art which includes "a payment, donation, loan, or promise of payment of money or anything of ascertainable monetary value for goods, materials, services, or facilities in assistance of, or in opposition to the nomination or election of a candidate [.]" MCL 169.206(1). A knowing violation of section 57 is a misdemeanor offense. MCL 169.257(3).

The Act also requires the Department to "endeavor to correct the violation or prevent a further violation by using informal methods [,]" if it finds that "there may be reason to believe that a violation ... has occurred [.]" MCL 169.215(10). The objective of an informal resolution is "to correct the violation or prevent a further violation [.]" *Id*.

As evidence, Ms. Jorns provided 18 emails purportedly sent from your FEA Schools email account. Ms. Jorns asserted the emails expressly advocated for your nomination or election or solicited campaign contributions, causing unlawful expenditures of public funds.

In your answer you admitted that the emails were sent from your FEA Schools email account. However, you assert that several of the emails were sent prior to your becoming a candidate and some were sent to "get feedback from close friends and advisors." You further assert that one email in particular, sent April 22, 2013, was work-specific and meant to inform the school board of your decision to retire as superintendent, not to announce your candidacy.

You further indicated in your answer that you were "advised by friends and supporters that [you] should start consistently using [your] campaign email account [,]" but that you "do not recall ever being advised that it was a violation of the [MCFA] to use [your] school email." You also stated that an AT&T employee set up your new cell phone for you and you did not realize that the phone email was linked to your school account. Finally, you indicated that you no longer have access to your FEA Schools email account and will not use it in the future.

The Department first notes that it is its long-held position that someone who is "testing the waters" and has not made a clear choice to run for a particular public office becomes a "candidate" as defined by the Act once monies are accepted or expended in the assistance of the nomination or election of that candidate — even if that person never formally files to run for office. See Clarkson Declaratory Ruling, January 24, 1984 and Wolpe Declaratory Ruling, October 22, 1992. An expenditure made to gauge support for your candidacy or to solicit advice regarding your possible candidacy runs afoul of section 57 of the Act if public resources are used.

Because you admitted that the emails submitted as evidence were sent using your FEA Schools account, and these emails discuss your candidacy, the Department has determined that there is a reason to believe that a violation of section 57 of the Act occurred when you used FEA Schools resources by sending emails which expressly advocated your candidacy, forwarded a newsletter which discussed your candidacy and advocated for the defeat of your opponent, solicited funds to support your candidacy or discussed fundraisers, and contained campaign material. Upon making this determination the Department is required by law to attempt to resolve the matter informally. MCL 169.215(10).

Please request that the FEA Schools' treasurer calculate the amount of public resources expended for the emails, including but not limited to your time (by using your rate of pay and the cost for your fringe benefits) and the cost of the FEA Schools' resources used By November 21, 2014. The Department will use this information to facilitate an informal resolution of Ms. Jorns' complaint.

Please be advised that if the Department is unable to resolve the matter through informal methods, the Department must refer the matter to the Attorney General for enforcement of the criminal penalty provided in MCL 169.257(3). MCL 169.215(10)(a).





MRP Roiling Out Decentralized Structure

The Michigan Republican Party (MRP) is embarking on a new decontralized management structure that puts more focus on five regional offices designed to "get to the cross of the grassroots."

MRP Chair Bobby SCHOSTAK said today that ofter several months of study, the party leadership has come up with a plan geared foward "expanding our voter universe" through peer-to-peer, friend-to-friend contact

"We are moving as much out of Lansing as we can," he said.

The new plan also calls for use of new technology and a "full-lime" 24/7 operations structure designed to reach independents, conservatives, men, women, African-Americans, Hispanics and "every American that lives in Michigan with whom we share areas of common interest."

The locations of the five regional offices are expected to be announced in early June

"We're in the process of making very dynamic changes," Schostak said. "The results over the past several years have shown Gov. (Rick) SNYDER and the Republican-led Legislature know how to fix the damage of the "hast decade." Now, we need to continue Michigan's comeback; this political plan will allow us to deliver the message of Republican success to every corner of the state, grow our party and elect Republicans in 2014."

The new strategy comes after the MRP emerged from a "spring training" workshop this weekend in Boyne. However, the reworking of the MRP began shortly after the November elections, Schostak sold. It involved "looking in every corner" about what went well and what didn't go well.

Roughly 500 Republicans showed up for this first-ever Spring Training session, which included six worksheps of state and national panelists. The get-together coincided with a State Central Committee meeting and differs from the late September blennial conference on Mackinac Island in that the Boyne event was more of a training seminar, Schostak said

"The state party's new political plan is impressive and greatly needed," said Senate Majority Floor Leader Artan MEEKHOF (R-West Olivo). "Republicans in our state have a lot to look forward to next year. We've filled the gaps from 2012 and will take all steps necessary to keep our majority."


