

Dear Wilson:

The Department of State (Department) received a formal complaint filed by John King against you, alleging that you violated section 47(1) of the Michigan Campaign Finance Act (MCFA), 1976 PA 388, MCL 169.247(1), by failing to include a complete and correct identification statement on certain campaign materials. A copy of the complaint is provided as an enclosure with this letter.

The MCFA and corresponding administrative rules require a person who produces printed material that relates to an election to include the phrase "Paid for by [name and address of the person who paid for the item]." MCL 169.247(1), Mich. Admin. R 169.36(2).

In support of his complaint, Mr. King provided a picture of a sign which states, "ELECT John WILSON CITY COUNCIL [,]" a copy of a flyer which states, "John Wilson, Candidate – Jackson City Council [,]" and a copy of a letter which states, "ELECT John Wilson City Councilmember [.]" Your committee's address appears to be missing from the paid-for-by statements on these materials.

The purpose of this letter is to inform you of the Department's examination of these matters and your right to respond to the allegations before the Department proceeds further. It is important to understand that the Department is neither making this complaint nor accepting the allegations as true.

If you wish to file a written response to the complaint, you are required to do so within 15 business days of the date of this letter. Please include any evidence that reflects any corrective measures you have taken to bring your campaign material into compliance with the MCFA. Your response may include any written statement or additional documentary evidence you wish to submit. All materials must be sent to the Department of State, Bureau of Elections, Richard H. Austin Building, 1st Floor, 430 West Allegan Street, Lansing, Michigan 48918. If you fail to submit a response, the Department will render a decision based on the evidence furnished by the complainant.

A copy of your reply will be provided to Mr. King, who will have an opportunity to submit a rebuttal statement to the Department. After reviewing all of the statements and materials provided by the parties, the Department will determine whether "there may be reason to believe

that a violation of [the MCFA] has occurred [.]" MCL 169.215(10). Note that the Department's enforcement powers include the possibility of entering a conciliation agreement, conducting an administrative hearing, or referring this matter to the Attorney General for enforcement of the criminal penalty provided in section 47(6) of the Act.

Dear Mr. Wilson:

The Department of State (Department) has concluded its investigation into the formal complaint filed by John King against you, alleging that you violated section 47(1) of the Michigan Campaign Finance Act (MCFA), 1976 PA 388, MCL 169.247(1), by failing to include a complete and correct identification statement on certain campaign materials. From the outset, the Department apologizes for the delay in processing this complaint. Regrettably, the complaint was misfiled in our office and was not caught until recently.

The MCFA and corresponding administrative rules require a person who produces printed material that relates to an election to include the phrase "Paid for by [name and address of the person who paid for the item]." MCL 169.247(1), Mich. Admin. R 169.36(2).

In support of his complaint, Mr. King provided a picture of a sign which states, "ELECT John WILSON CITY COUNCIL [,]" a copy of a flyer which states, "John Wilson, Candidate – Jackson City Council [,]" and a copy of a letter which states, "ELECT John Wilson City Councilmember [.]"

You filed a response that was received by our office on October 17, 2018 essentially indicating that your full address has been laminated and placed on yard signs that were in circulation.

Upon review, it appears that the paid for by statement was either omitted entirely from campaign materials or is incomplete in violation of MCL 169.247. Your yard signs failed to contain a proper paid for by statement and materials you mailed contained a paid for by statement which failed to provide the address of the committee paying for the materials.

Given this, the Department is hereby advising you that MCL 169.247(1) and R 169.36(2) require you to print a complete and accurate identification statement on all campaign materials, consisting of the phrase "paid for by" followed by the full name and address of your committee. Note that all printed materials that refer to an election or your candidacy produced in the future must include this identification statement.

Please be advised that this notice has served to remind you of your obligation under the Act to identify your printed matter and may be used in future proceedings as evidence that tends to

establish a knowing violation of the Act. A knowing violation is a misdemeanor offense and may merit referral to the Attorney General for enforcement action. MCL 169.247(6), 215(10). The Department considers the instant action closed and resolved.
