Explain how those sections were violated: (1) For the last year, Frank Shepherd and Leslie Cunningham have

published a one-sided, largely inaccurate monthly campaign publication called "The Sentinel," which is completely a political campaign advertisement. It urges Hayes Township residents to recall current Hayes Township (Charlevoix County) Clerk Marlene Golovich and Trustee Paul Hoadley from office; and to instead vote for and elect Warren Nugent for Hayes Township Clerk; Julie Collard for Hayes Township Treasurer; and Bob Jess for Hayes Township Trustee. This publication has been distributed free by U.S. Mail to every resident of Hayes Township. The following legend is printed in every issue: "Published by: Hayes Township Sentinel, A Non-Profit Corporation." (2) There is a monthly advertising circular called the Charlevoix Community Shopper. It is distributed in Charlevoix County, and is distributed free by U.S. mail to every resident of Hayes Township. For at least the last four months (July, August, September, and October, 2018), this circular has contained a paid ad urging Hayes Township residents to vote for Nugent, Collard, and Jess for the Hayes Township Board of Trustees. Each ad has been labeled: "Paid for by the Hayes Township Sentinel; P. O. Box 581, Charlevoix, MI 49720." I have called both the Charlevoix County Clerk and the Secretary of State and have been informed that "The Hayes Township Sentinel" is not registered as a Campaign Committee; a Political Committee; an Independent Committee; an Independent Expenditure Committee; or a Super PAC Committee. The distribution of The Sentinel newsletter and of the paid

, ads in the Charlevoix Community Shopper by persons who are not registered as any type of campaign committee are clear violations of Michigan's Campaign Finance Act.

Evidence that supports those allegations (attach copies of pertinent documents and other information): The first issue of The Sentinel

was published in November, 2017, and it has been published every month since then. Every issue is nothing but one-sided, largely inaccurate partisan advocacy and political advertising for the recall of Township Clerk Marlene Golovich and Trustee Paul Hoadley from office; and for the election of Warren Nugent for Hayes Township Clerk; Julie Collard for Hayes Township Treasurer; and Bob Jess for Hayes Township Trustee. These three people are candidates for elective office, as defined by MCL 169.203(1) and 169.205(4). This political advertising is covered by Michigan's Campaign Finance Act (MCFA), and must be published by an authorized committee, organized pursuant to the MCFA. I do not have extra copies of every issue. I am attaching copies of two issues (February and September, 2018), as representative samples.

Further, the paid ads which have been placed in the Charlevoix Community Shopper during the months of July, August, September, and October, 2018, are clearly ads which can only be placed by an authorized committee, organized pursuant to the MCFA. Copies of the ads for these four months are attached.

The Hayes Township Sentinel has not filed a Statement of Organization as required by the MCFA. The paid ads in the Charlevoix Community shopper do not contain the wording: "Not authorized by any candidate committee." No issues of the Sentinel have contained the wording: "Not authorized by any candidate committee." As Required by MCL 169.247(1).

The distribution of The Sentinel and the Charlevoix Community Shopper are "mass mailings" as defined in MCL 169.210(2).

A recall election is covered by the MCFA. MCL 169.205(2).

#### A message from your Supervisor, Ron VanZee t's your money; you decide"

Ron VanZee

For ten years or more the previous Hayes Township Board of Trustees kept your road mileage money in the general fund, which is against state law. The Board had been warned repeatedly by the auditors to create a separate road fund.

When I was elected in 2016, I began asking for a simple inexpensive audit to ensure that your road tax dollars had not been used for the Camp Seagull park acquisition and project. Marlene Golovich, Paul Hoadley, and Robbin Kraft refused!

In 2017 Matt Cunningham and I asked the Trustees to consider a less invasive, more affordable park plan. We had a Hayes Township resident donor who offered to pay for redesigning the plan. Once again, Golovich, Hoadley, and Kraft refused!

Any time we have been discussing the park plan, I have repeatedly asked, "Do we have adequate funds? ...Post your numbers on the township website in under-

standable language and format."
The three continue to refuse.

Golovich, Hoadley, and Kraft said in January of 2018 that they would not approve a park project contract if it came in too high. But when the bids came in much higher than the engineers estimate they stripped away all the safety features and the infrastructure for future development and approved it anyway.

They said over and over that they would never borrow money for this boat launch. Yet they borrowed \$250,000 from a local bank.

At the design phase, Golovich, Hoadley, and Kraft hired an engineer without advertising for competitive bids. Why?

Before the construction phase began, the pre-2016 Board wanted the dead ash trees cleared from the park. And again, instead of seeking competitive bids, they hired the spouse of Clerk Marlene Golovich (a family business in which she is a principal) to do the clearing, to the tune of \$46.000.

And further, Golovich had signed as grantee of the DNR Trust Fund acquisition grant stating that neither she nor anyone in her family would benefit financially because of the grant. Why?

The same Board also hired Golovich's brother-in-law as a maintenance man for the park, again with no advertising or competitive bids and violating the general law township rule of incompatibility as well. Why?

Clerk Marlene Golovich, a supervisor of Township employees, suggested to the Board that they hire her as office manager and park manager, again without advertisements or competitive bids. They did.

Clerk Golovich supervised herself, and then supervised herself again! Incompatibility! Why?

Now we, the taxpayers of Hayes Twp. are having financial trouble and we have asked Golovich, Hoadley, and Kraft repeatedly "How much are you willing to spend on this Boat Launch? What is your cap?" They will not answer. We have also asked on countless occasions how much the taxpayers have paid so far for the park? No answers.

After Paul Hoadley, Trustee Matt Cunningham and I attended a 2017 Michigan Township Association financial planning conference in Lansing, Paul said to me, "We're in trouble, aren't we Ron?" But has Hoadley ever suggested getting the financial facts? No he has not.

Well, yes, Paul we were in trouble then and we are now, and it's the vote of the three trustees up for recall (Kraft withdrew her name and is not on the Nov, ballot) that has gotten us into this mess.

Matt Cunningham and I asked the Board late in 2017 for an audit. The three voted it down. In the same meeting, we asked the Board to go to mediation, which was suggested by Chip Hansen of the Charlevoix Community Foundation, but Golovich, Hoadley, and Kraft refused.

Many in the Township believed that their only recourse was to mount a recall campaign. And so here we are at a community crisis in our neighborhoods. I am asking you to vote to end the governing by phone, the secret meetings with the engineer, the refusal to share information with the public, the exclusion of Matt and I from knowing what they are planning to bring up at the next meeting or even if Robbin is moving, and the selfish manipulation of others out of spite to further their personal agendas.

This must all stop.

I hope you will join me in bringing positive planning and cooperation towards our common good. Help me start the healing of our community by voting for Bob Jess, Julie Collard and Warren Nugent on Nov. 6th and stop this insanity!

#### Supervisor VanZee puts the brakes on change

During a very well resident attended special Board of Trustee meeting on Wednesday, September 5,(absent Treasurer Robbin Kraft), three change orders totaling almost \$50K were presented by engineer Jim Malewitz, from Performance Engineering. Malewitz recommended approving change order #3 that will increase the drainage for the area where the natural springs are in the park. He also spoke in support of a change order to add support rods to the single sheet sea wall.

Both MDC and the Hydro Engineer made an assessment of 100 feet of hillside frontage that they believe requires an additional stabilization system to hold the soil on the steep grade.

Malewitz, however, told the board that he has been watching the effects of the heavy rain on this hillside and does not agree with their recommendation.

Supervisor Van Zee spoke to Mike McCain from MDC regarding this, and he said they will not stand behind this part of the work without further securing the 100 feet of frontage.

Trustee Matt Cunningham asked "Where do we stop spending? It seems like there is no end to it. Is there a cap where everybody would stop?"

Both Paul Hoadley and Marlene Golovich were ready to approve all change orders, with Golovich commenting "How can we not do it?"

Supervisor Van Zee explained his position: "I don't think any of this is unforeseen, I think it should have been in the contract since day one. I don't think its good engineeringthe springs were there all along. The township hired you (Malewitz) to check these things out. We hired someone to do the proper testing, but because I feel strongly that it is not unforeseen. I have to vote no. If it does pass, I ask the board to have someone else sign the change orders." The crowd burst into applause as VanZee completed this statement.

Malewitz responded by saying he can understand why he feels that way, but doing more testing before the project would have been an expense that he knew would be a strain on the Township finances. "When you look at the overall value of the project, the money is not significant," Malewitz said.

"We may not have had a project,"
Van Zee said.

The board voted on change order #3, with the vote failing to have a quorum and did not pass. Hoadley was quick to comment "On Monday we will have a quorum and can pass this vote."

"I think there is responsibility that the engineer needs to take," VanZee replied.

The other change orders were tabled until the regular Board of Trustee meeting Monday, September 10th.

Public Comment opened, and with a few exceptions, people

spoke out in support of VanZee's comments. Many continued questioning why some board members are pushing so hard to rush the work at the park. People continued to make impassioned pleas regarding the decisions being made.

"Pause is needed! It's so sad for an agenda to be pushed—it's disgusting to me."

"No accountability—if it was too steep to test, why build there?"

"I don't think we should be used as a blank check for MDC/Malewitz."

"I am appalled at the unprofessional way this project is being run. The engineer is not organized and lacks of professionalism. This is how our tax dollars are being managed?"

Warren Nugent commented: "Ron, you're right. Board members just got this (change order information)...There is a lot of fuzzy math with this project."

Vikki Damon asked VanZee his vision for the park. He replied, "A vison of a park where the whole family can enjoy a Sunday afternoon."

Shirlene Tripp said "It's not easy sitting in those chairs (on the board). The people (attending the meetings) need to be listened to." Roy Griffitts inquired "When is the reporting system going to be

in place for Camp SeaGull?"
The change orders will be revisited at the regular BOT meeting on Monday, September 10th, at 7pm.

#### Board at a stalemate on appointing a new treasurer

A special Board of Trustee meeting was called on September 18, 2018, at 3pm with two items on the agenda; pay warrants(invoices) to Manthei Development (MDC) and Performance Engineering, and to discuss the appointment of a new Treasurer.

The two Warrants to Manthei Development for the work they have completed at Camp Sea Gull totaled \$321,698.78. The warrant for pro-rated billable hours to Performance Engineering was for \$9,108, for a grand total of \$330,806.78 being approved to pay out of the Camp Seagull fund.

Then Supervisor Van Zee opened the board and the floor to comments regarding the appointment of a new Treasurer in the wake of Robbin Kraft's resignation, which was effective on September 20th.

Both Paul Hoadley and Marlene Golovich continued to push for Patricia Feliciano, the current Deputy Treasurer, to be appointed for the 6 weeks left until the November election.

Ron VanZee cited a conflict of interest in appointing Patricia Feliciano as interim Treasurer. Her husband Omar Feliciano is on two township boards as well as employed by the Township as its Webmaster.

Golovich's comments were concerned with paying the Treasurer's salary to Treasurer candidate Julie Collard as she begins assuming the responsibilities and learning the routines of the position. She said that she believes Collard is unqualified. Golovich also advised Collard to get training on her own time with her own resources and refused to consider her as a solid choice for Treasurer, even though Collard is running unopposed.

Golovich insisted that the Town-

ship should not have to pay a sal-

ary while Collard learns the job, even though Golovich has been in favor of paying others to learn. Charlevoix County Clerk Cheryl Browe has advised VanZee that Collard would be the person that would make the most sense to appoint at this time, since she will be Treasurer after the November 6th election anyway. Charlevoix County Treasurer Marilyn Cousineau has offered her assistance to Collard, as well as that of the Chief Deputy Treasurer Betty Simon Without a Treasurer the bills and payroll cannot be paid.

Warren Nugent came to the defense of Collard, "I think you would find that working together (Collard and Feliciano), Julie would be doing a ton of work as well." Meanwhile Robbin Kraft obviously forgot that the meetings are recorded so everyone can hear what takes place and at the HII28 mark on the recording she says, "She's never been trained as Treasurer," Kraft giggled to Golovich.

When asked what will happen without a Treasurer, VanZee said "We will have to figure this out and get it back on track as fast as we can. I want to make sure we follow the law and the procedures and we are going to be finding out how quickly we can turn this all around."

#### Robbin Kraft retires, change orders adjusted

During the September Board of Trustee Meeting, it was announced that Treasurer Robbin Kraft is resigning, effective as of September 20, 2018. Kraft sent this information via a letter and was not present at the meeting. This leaves the township without a Treasurer until the November 6<sup>th</sup> election.

There was a motion made to appoint Patry Feliciano, current Deputy Treasurer, as temporary Treasurer, but it was voted down. Supervisor Ron VanZee praised Feliciano's work, but said he wanted more time to decide what the appropriate process within the Township is. Regarding the change orders discussed at the special BOT

meeting held on Wednesday, September 5th, VanZee said "I'm really glad we took an extra few days. The contractors dug out a rain garden and did further excavation looking for substantial soil to hold on the slope. We went through the change orders thoroughly—there is a reason for hiccups, we didn't have a chance to ask questions or survey the sight (before the special meeting)."

Aaron Nordman from Performance Engineering explained the details of proposed Change Order number 3 for Phase One of Camp Seaguil. He was clear in his description and was able to answer all of the questions asked by both board members

and residents. He explained the additional drainage field precautions using everyday language that everyone present was able to understand. Nordman did tell the board that the work completed by Performance Engineering would be warranted for a year.

Change order #3 came to a total of \$25,843.60. The board passed it. "I think we took the extra step to make sure we do it right," VanZee commented.

Change order #4 is for \$8,334.90 and will be to add tie rods from the pier to the single sea wall to help stabilize it. The board passed the motion for this change order as well.

The current Cemetery Or-

dinance was amended to reflect the MTA recommendations. Cemetery fees were also reviewed, as well as discussion of an additional two members from the community to join the cemetery committee for a total of 5 members. The openings will be posted on the Township website for interested individuals.

Site Planning sent a proposal to remove/treat phragmites along the Lake Michigan shoreline in Hayes Township. They proposed \$350 for treatment and the motion was passed.

Matt Cunningham, on behalf of the Planning Commission, requested That we conduct a community survey in the interest of Master Plan revision.

The Planning Commission requested \$6921 for assistance from Beckett and Raeder, but after review, the board edited some of the items and approved approximately \$4900 for the requested assistance.

VanZee indicated that more change orders would be coming and will most likely need a special meeting to discuss and approve. He also shared that they could take more time to discuss the appropriate steps on handling the Treasurer vacancy, and add that to the agenda as well

The next regular scheduled Board of Trustee Meeting is Monday, October 8, 2018 at 7pm.

represent their interests, it is very important that every step of the way shows absolute transparency. For years, residents have asked repeatedly for the township financial reports and annual budgets to be posted on the Township webpage each month—this has not yet been done, and it keeps them in the dark on the financial status. There should be a clear reporting of how much money has been spent, how much money has come in, and at what percentage

above or below the budget this information falls.

This is basic accounting reporting. I'm a resident and I believe this information should be readily available; but it is not. As Treasurer, I will make sure this reporting is clear, up to date, posted online, and available for anyone to view. When I spoke to Dr. Dave Kemme, professor of Economics at Memphis University, he recommended the sources and uses of funds be shared, as well as assets,

liabilities, and net worth. He also mentioned that the general ledger of expenditures should reflect every transaction and check written. I highly value Dr.Kemme's suggestions, and will be sure to clearly report the Township financials as he outlined.

Unfortunately, much of the current state of confusion and frustration lies in the lack of transparency, and general shutdown of communication between current board members and the

public asking important questions. When you hold a public position, you have a responsibility to explain in detail your actions to the tax paying citizens who voted for you. It is their tax money that is being spent, and they have the right to know where every penny goes.

Transparency is right around the corner for Hayes Township, and it will be my first act as Treasurer to clearly share all financial information with our residents.

In a recent letter Marlene Golovich says that Ethel Knepp had a vision for this 1.6+ million dollar big boat launch and outdoor toilet project that Hoadley and Golovich are building. Well, it was Ethel who made the promises not to raise taxes or to use significant taxpayer dollars to build this park. When we had a fundraiser for the park some years ago Ethel handed me a park fact sheet that stated, "the township envisions a launch for small boats of the type that township residents might use for fishing." This is not what Marlene Golovich and Paul Hoadley are building.

Ethel also led the effort to survey township residents asking what they would like in the park at Camp Seagull. Number one on the list is restrooms. Next are

picnic areas, a swimming beach, playgrounds, and bike path. Finally way down at #7 on the list is a small boat launch.

Most importantly the finances of the township are at risk as they agreed to pay another \$330,000 at a special board meeting recently with more to come. Only Marlene Golovich knows what money we really have and any reports we get out of the township are always incomplete and misleading.

The results were that they didn't know what they were talking about while representing all of us. I then attended the bid openings where no one bid on the cafeteria. No one offered them money for the valuable materials as they had said someone would. Shortly after the bid opening meeting, they decided to knock down/remove

At the same time all this was go-

ing on, the BOT had a proposal in hand to make the building operable to rent for \$26,500.00. Instead of fixing the building for that price, the BOT paid someone \$27,000 to take the building down. First, they were going to auction the building and make money, and then in the end they spent money. Poor planning, based on little to no research or experience, is a common theme with certain members (and a member that recently quit during her term) of the BOT.

Head scratching events like this have been going on for years in Hayes. No matter how many red flags are raised the BOT goes full speed ahead to implement the destructive and selfish agenda of three people.

The BOT had me scratching my head again at their special September 5, 2018 meeting, which was well attended. When the Board made their first change order on the Park project in August I assumed the change order would be paid for out of the project contingency fund. I've been involved in projects worth millions of dollars and frequently a change order is paid out of the contingency fund, which is 5% on this project. In Hayes, with the current Board, a change order can come out of taxpayer money. So, at the special meeting when they were asking for money to pay for change orders 3 & 4 we learned that the board hadn't spent any of the contingency funds yet. They paid for the first round of change orders (change order 1 & 2) with taxpayer money that they told us would be our surplus funds for after the project is complete. A shell game in action, because current approved change orders now total \$91,000, which is much more than 5% of the original project bid. This is just the beginning. There are 4 more pending change orders, which have not been approved yet. Where is the cap on this project?





#### HOW TO REGISTER TO VOTE

### Saturday, October 6th is the last day to register to vote







- To register to vote, you must be all of the following:
- · A U.S. citizen
- At least 18 years old by Election Day
- · A resident of Michigan
- A resident of the city or township where you are applying to register to vote.

(You must be registered to vote at least 30 days before the election, so keep that in mind if you are registering with the intention of voting in an upcoming election.)
You may obtain the application at one of the following:

- Your local <u>Secretary of State</u> <u>branch office</u>
- Your local county, city, or township clerks office
- Offices of several state agencies, like the Department of-Health and Human Services, the Department of Community Health, and the Department of Licensing and Regulatory Affairs

- · Military recruitment centers
- Voter registration drives
- Online at www.Michigan.gov/ sos

If you hand-deliver your application, the staff person helping you will take your form and you don't need to do anything else,

If you have never registered to vote in Michigan and choose to mail in your application, you will need to meet an identification requirement. This means you must: Enter your driver's license number or personal identification card number where requested on the form. OR

Send a copy of ONE of the following forms of identification with your application:

- A photocopy of your driver's license or personal ID card, or
- A photocopy of a paycheck stub, utility bill, bank document or government document that lists both your name and your address.

Your city or township clerk will send you a voter registration card upon processing your application. Keep it in your wallet or purse so you know where to go to cast your ballot.

For directions and a map to your polling place, visit www.Michigan.gov/vote.

When you go to the polls on Election Day, you will be asked to present voter identification. If you don't have acceptable photo ID, you can vote by signing an affidavit. The affidavit can be used by 1) voters who don't have acceptable photo ID or 2) voters who have photo ID - but didn't bring it to the polls.

- Acceptable photo ID includes:
   Michigan driver's license
- Michigan personal identification card
- Driver's license or personal identification card issued by another state

- Federal or state governmentissued photo identification
- U.S. passport
- Military identification card with photo
- Student identification with photo from a high school or an accredited institution of higher education, such as a college or university
- Tribal identification card with photo.

If you do not have a driver's license or other acceptable photo identification, you can get a state identification card at your local Secretary of State branch office for \$10. State ID cards are free to individuals who are 69 or older or blind or who have had driving privileges terminated due to a physical ormental condition. The fee can also be waived for individuals who present other good cause for a fee waiver. Proof of identity and residency are required when


applying for a state ID card.

#### Points to Remember

If you move to a new city or township, you must re-register. If you move within a city or township and are already registered to vote, you only need to update your address. If you are in jail, awaiting arraignment or trial, you may register to vote. If you are in jail after being convicted and sentenced, you may not register to vote or vote while you are confined.

And like our popular supervisor, Ron VanZee said, "Let's return sanity to the township board."


Let's also give the park back to the vast majority of township residents starting Nov. 6th and then focus on a family park with family amities and not one exclusively for boaters.

#### 3 amigos appeal recall; Stall for time

We have learned that Trustees Hoadley, Kraft and Golovich have filed an appeal with Circuit Court Judge Joe Hayes asking Hayes to review the Charlevoix County Election Board's unanimous decision to approve recall language in a recent recall petition. Fourteen members of Hayes Township filed the petition, asking permission to circulate petitions and set an election date where the voters of Hayes Township would be able to vote yes or no on recalling and then replacing them as trustees.

The petitioners charged the 3 Amigos for failing to represent the best interests and true will wide survey conducted in 2013. of the majority of the electors of Hayes Township. wide survey conducted in 2013. Residents wanted bathrooms, a covered pavilion, swimming

The lack of transparency and fiscal responsibility/accountability they have exhibited in pushing for Phase One of Camp Seagull Park, as demonstrated in the complaint's documentation, is a large aspect of the complaint against these Board members.

The petitioners believe the \$1.4 million Phase I large boat launch is fiscally reckless, possibly getting the township in a financial bind AND it ranked in 7th place in a Township

wide survey conducted in 2013. Residents wanted bathrooms, a covered pavilion, swimming beach, a trailhead on the BC Road where the bike trail will pass and campsites, all ahead of a boat launch.

We adamantly believe these three Trustees have broken a bond with the majority of voters in the Township and broken a bond with the voter's collective wishes as expressed in the survey.

We believe the appeal will be denied and petitions will begin as soon as the 40-day appeal is exhausted. We also believe the 1800 residents should make this important decision and not 3 trustees; after all it's the hard earned taxpayers' monies that pay the bills.

I worked for a newspaper company whose motto was "Give light and the people will find their own way." I believe the folks of Hayes Township, when allowed to vote, will find their own way and reject the 3 Amigos and send a loud and clear message to the Township: "Stop this \$1.4 million boat launch. It's too much and way over the top and it's not what we asked for!"

Let's not let them start cutting

the trees down and swinging the shovels before we can recall them. Get to the meetings.

This bickering has got to stop. The 3 Amigos may think their line in the sand is funny but they are digging their own grave. The real losers are the vast majority of residents in Hayes Township who spoke on the survey by putting a boat launch in 7th place in importance. Why is it now in 1st place and costing \$1.4 million????

#### A letter from the Supervisor

I watched for a long time as people were asked to donate to a one-time opportunity while secretly a different park plan was being formulated.

I agreed to run for Supervisor because I saw the Township residents being forced into an agreement that was totally contrary to what they conveyed to their elected officials and I truly thought I could bring reason into all the differences.

I must be a slow learner because at Wednesday night's special meeting I was forced to finally believe the old saying, "It is totally useless arguing with a habitual liar because they believe their lies."

Editors Note: The engineer and the old board, including the 3 Amigos, Hoadley, Kraft and Golovich, have consistently held that we could not have gotten the Grant to buy the Park without a promise to build a boat launch, yet, the State granted 60 points for preservation of the Park habitat and ZERO points for a boat launch.

#### Special meeting reveals Malewitz trust issues, \$20K in revision costs

Jim Malewitz, of Performance Engineers, presented a revision drawing of Phase One, Camp Seagull, at a special Hayes Township Board meeting January 22. Malewitz pushed for action because of the short timeline to get bids from contractors and get trees cut by April 1, which is the deadline for destroying the Long Eared Bat habitat before they breed

Malewitz also stated several times that the revision work he was doing on the park was pro bono but then he revealed that he is, in fact, charging the Township for the work. His pay sheet shows a total of \$124,458.75 paid to date, but a balance of \$82,330.90 owing on Phase I. The \$20,000 the board added to his account last night will bring up to \$102,330.90. The total amount both paid and on account to date with Malewitz is \$226,789.65, if he uses the new \$20,000 allocation. Further Malewitz also admitted

that he had withheld the park revision work from Supervisor Ron Van Zee because of trust issues.

"I was worried that you would go to the Army Corps of Engineers and stop the wheels," Malewitz told VanZee, Yet it is still unclear which Board members did know about the work or contributed to it."

Clerk Marlene Golovich also attacked Supervisor Ron Van-Zee when he told the group that nothing would be decided until their regular Board meeting, to be fair and give everyone time to digest the revision. She informed him "he can't set the rules."

"I don't want you to assume you can dictate this because you can't," Golovich declared.

Golovich demanded that the Board move forward to authorize the new plan immediately in spite of the missing cash flow analysis and independent audit, When Phase One is complete, "People are going to applaud," Golovich proclaimed.

A motion for the Board to approve the park revision, approve the additional engineering costs of up to \$20K, and move forward with bids for the Phase One work was made and passed, with the predictable 2-3 vote.

#### No park contracts until financial report completed!

The Monday January 8, Hayes Board was well-attended, with a crowd of almost 30 strong, speaking volumes about the increased community involvement in Hayes Township matters.

The morning before the meeting, the Charlevoix County Election Board, chaired by Probate Judge Valeria Snyder, approved Recall Petition Language. It has since been appealed and will be decided by Circuit Court Judge Roy Hayes.

At the Monday evening meeting the three named board members in the recall petition, Marlene Golovich, Paul Hoadley, and Robbin Kraft, were doing some backpedaling on previous motions that they had all voted down.

Golovich introduced a motiona very watered-down version of Ron Van Zee's original motion requesting financial transparency, accountability, and timeline of both grant monies coming into the township and payouts (township funds) on the construction contracts of the proposed Phase I Camp Seagull development.

The new motion included an agreement for Golovich and Van-Zee to review all of the proposed spending and budget for Phase One and hiring an independent auditor to review Camp Seagull financial information and processes.

After changing some language of the motion to insist on an outside professional audit of the financial aspect of the plans, as well as the audit needing to be complete before any bids will be accepted, the motion was passed by all five board members, with a \$10,000 spending limit attached. Golovich was somewhat hesi-

tant to agree to VanZee's modifications, concerned that the additions could be used as a "stall tactic" to delay getting bids for the Phase One construction.

On another note, Paul Hoadley spoke to the board about the MTA conference he attended, having listened to information regarding fraud within a township "under everybody's nose," and he asked the Board "who looks at the township bills."

VanZee responded, "The treasurer should be looking at every invoice that goes with a check." As the current Treasurer, this responsibility falls in Kraft's realm of statutory duties, however, she told the board she does not crosscheck anything.

VanZee responded to this admission of nonfeasance by offering to perform the required check and balance function and review the Township warrants and invoices prior to presenting to the board.

The Trustees appointed two new Planning Commission Board members, Roy Griffith and Omar Feliciano.

VanZee recommended Griffiths for the second time, and the previously hesitant board members reconsidered their stance and voted yes unanimously.

Doug Kuebler was also recommended by Ron VanZee for the second time, but was again voted down by the majority of the Board. Hoadley asked Kuebler if he would follow an ordinance he did not agree with, and Kuebler responded, "You go by what the ordinance says."

Golovich explained her no vote because Kuebler quit mid-term after being elected. "Doug was on the Planning Commission and on the Board of Trustees and quit mid-term and I just have a hard time supporting someone who just up and quits in the middle of something after people elected him and voted for him and showed confidence in him." She did not address her own leaving the Park and Rec Com-

mittee and then rejoining this

year, nor the fact that she quit the

FOIA position in the fall of 2016. Kuebler responded to Golovich's comment. "The reason I resigned from the Township board is because the board, at the time I was on it, the board decided that they could do things with their property that John Q Public could not. I was on that board for 23 years, and this came down that the township board could have more privileges in zoning than John Q Public," Kuebler explained.

In other business, Supervisor VanZee met with the Township engineer earlier in the day to review a yet another revision of the Phase One plan. Engineer Jim Malewitz, citing the public outcry against the current plan, briefly presented a map of Camp Seaguil that proposes to eliminate two of the previously planned parking lots in the park and re-route the road that was slated to run along the current beach area.

A special Board of Trustees meeting was scheduled for January 22, 2018 at 7pm to discuss this revision but was postponed due to weather. It was re-scheduled for Wednesday, January 24th.

When public comments were opened at the end of the three hour meeting, Hayes Township citizen recommended we "put a for sale sign" in front of Camp Seagull. "We just can't afford it."

Rebecca Berg suggested that the boat launch issue be put to a vote of the Hayes Township residents; this would show where the residents really stand on such a contentious issue.

A question was asked regarding the definitions of a large boat launch versus a small boat launch. Warren Nugent speculated that a large launch would be around 28-30 feet range, and a small launch would be 23 feet or smaller.

Malewitz, the lead engineer in the design and plans for the proposed boat launch, was unable to give the exact information, but defended the plan for a large launch.

Paul Zardus spoke to the group. The first plan was significantly different than the current plan... all fundraising was based on a small boat launch, it showed the stone wall in the pictures-a misrepresentation of the plans...the cafeteria building was beautiful, eight thousand dollars was raised to renovate it, and it was demolished against the public's wishes,' It was a long evening but resulting in two newly appointed Planning Commission members, a revised motion requiring financial accounting of the Park before it can go forward, public input, and a plan to consider a modification to a controversial boat launch plan.

#### Hayes Township board members Recall Hearing

The public hearing on the language for the recall of Hayes Township Board members Marlene Golovich, Paul Hoadley, and Robbin Kraft was held on January 8, 2018. The hearing was to consider the clarity and factual basis of the recall language for the 3 members.

On December 20, 2017, a request was filed with the Charlevoix County Clerk in a recall effort on Golovich, Hoadley, and Kraft, Fourteen named Hayes Township individuals filed the motion. The main issue cited was the three Board members failing to represent the best interests and true will of the majority of the electors of Hayes Township. The

lack of transparency and fiscal responsibility/accountability for Phase One of Camp Seagull, as demonstrated in the complaint's accompanying documentation, is a large aspect of the complaint against these Board members.

Greg Luyt, the attorney for the recall group, shared information from the Michigan Constitution pertaining to recall languages as well as referencing a prior recall case that had been approved with very similar wording as the submitted request.

Golovich spoke to the Board and read a written statement that she had provided before the hearing. Her argument against the recall wording was that Ron VanZee's motions were given to the board in written form and were different from the words he actually said.

Former Township trustee and supervisor Fred Parsons spoke up at the hearing. "There has been an extended period of time where I felt that the board no longer listened to the majority of people that were in attendance at the meetings. This reached a point where I just discontinued attending because my opinion wasn't worth the voice it took to give it...It was clear that the(new) board had an agenda, and it was different from what the public really wanted."

Jim McMahon spoke to the Election Board, and chose to repeat the same rhetoric that he has been reciting for the past few months. He brought up the Sentinel, claiming it is a divisive publication that needs to be stopped. "I'd like to see it end. It's mean spirited he mumbled.

McMahon also mentioned what he thought may be a conflict of interest with a member of the Election Board's husband having attended Hayes Township meetings in the past and speaking his personal objection against Phase One of Camp Seagull.

The lead member of the Election Board, Probate Judge Valerie Snyder, addressed McMahon's statement, disputing his claims of conflict of interest. She said that she has "no dog in the ring" and has never discussed Camp Seagull with her husband and has no opinion on it either way.

During the discussion, the Election Board observed that the language in VanZee's motions mirrored his actual words and that the request was both factual and had clarity. Snyder told the attendees of the hearing, "It is up to the voters to decide the truth."

A motion was made to approve the language in the recall petition, and it was unanimously approved. The 3 Amigos have appealed this decision to Circuit Court Judge Joe Hayes.

#### Kraft admits nonfeasance during Board of Trustee Meeting

Trustee Paul Hoadley opened a can of worms regarding the township checks being cross-checked against the invoices, having attended the Michigan Township Association conference and learning about fraud within townships that happens "under everybody's nose," he explained. "Most of the fraud is picked up locally," Hoadley said.

The Hayes Township Treasurer Robbin Kraft admitted that she does not look at the outgoing checks. As the current Treasurer, this responsibility falls in Kraft's realm of responsibility, however, she told the board she does not currently crosscheck invoices/ checks. Mondays are pretty full,

she said. I have no time to even check my emails."

This blatant admission of nonfeasance from Kraft was met with confusion by the board members not aware of this failure on her part to fulfill her appointed duties. Like a deer caught in the headlights, Kraft mumbled again that she "didn't have enough time on Monday's" to review the checks, and appeared baffled that this is something she should have been doing since taking office. VanZee addressed this erroneous situation.

"The treasurer should be looking at every invoice that goes with a check, VanZee said."

He agreed to review the Township checks and invoices each month, which unfortunately is happening because the elected Treasurer has no time and this has been going on for years. If the Treasurer is failing to crosscheck invoices, where is the Clerk in this process?

The Clerk has statutory responsibilities too. Golovich is supposed to be balancing with the Treasurer each month.

Hayes Township needs a full

audit of both finances and procedures before going any further with its Phase 1 Sea Gull Park plan.

It is as simple as that



#### Golovich to Kuebler: "You're a smart guy but you quit!"

The flamethrowers came loaded for bear at the January 8th Board of Trustees Meeting and it didn't take long for them to scorch the crowd. When Supervisor VanZee asked the Board for the second time to approve his appointment of well-respected and long-time farmer and resident Doug Kuebler

The Election Commission, Chaired by Judge Valerie Snyder, voted unanimously to approve recall language directed at Hoadley, Kraft and Golovich and allow recall petitions to be circulated for signatures.

Fourteen members of Hayes Township had submitted the petition and since getting approval that morning, the petitioners are busy getting petitions printed and ready for circulation. However, it has been appealed.

The main issue cited at the hearing was that Hoadley, Kraft, and Golovich failed to represent the best interests and true will of the majority of the electorates of Hayes Township. The lack of transparency and fiscal accountability for Phase One of Camp Seagull is a large aspect of the complaints against these Board members.

And this writer believes the 3 Amigos rush to begin their Phase I large boat launch (\$1.4 million or more) is a direct result of their possible recall. Once underway it will be hard to stop but I believe nothing will stop recall, not even their "stall for time" appeal or the possible beginning of Phase I.

If 222 signatures are gathered and approved by the Clerk, then an election will be held where the voters of Hayes will decide with a yes or no yote whether to kick Hoadley, Kraft and Golovich out of office and elect new trustees.

Golovich was probably frustrated by the morning's recall decision and lashed out at Kuebler that evening. Even her most ardent supporters seemed surprised.

a signature on the recall petition and this writer hopes he will, again, step forward to serve the Township, I for one will vote for him. And I suspect a large majority will also. That will put a smile on our Supervisor's face.

The Commission members agreed that the savings from writing their own minutes should cover the cost of having a planner attend their meetings. Feliciano comment-


ed on the budget information: "Nothing should be a secret."


Zoning Administrator Larry Sullivan informed the board that they should expect three public hearings to come to them in the


near future-one on a storage rental proposal, one on an event barn venue, and one on 10,000lbs. of fireworks being stored in a

Dear Mr. Shepherd and Ms. Cunningham:

The Department of State (Department) received a formal complaint filed by John Royal against you, alleging that you and the Hayes Township Sentinel violated the Michigan Campaign Finance Act (MCFA or Act), 1976 PA 388, MCL 169.201 *et seq*. The investigation and resolution of this complaint is governed by section 15 of the Act and the corresponding administrative rules, R 169.51 *et seq*.

The complaint alleges that the Hayes Township Sentinel has published campaign advertisements which expressly advocate for the election of certain candidates and have failed to register as a committee. A copy of the complaint and supporting documentation is enclosed with this letter.

A committee is required to file its statement of organization within 10 days of its formation, and campaign statements listing a committee's contributions and expenditures in accordance with the schedules set forth in the Act. MCL 169.224; 169.233. The MCFA requires a committee that receives or expends more than \$1,000 during any election to file campaign finance reports in compliance with the Act. MCL 169.233(6). Failure to timely file any of these statements may result in the assessment of late filing fees, or if the statement or organization or two or more campaign statements remain unfiled for more than 30 days, prosecution for a misdemeanor offense. MCL 169.224(1); 169.233(7)-(8).

For purpose of the Act's registration requirement, the words "contribution" and "expenditure" are defined, in pertinent part, to include anything of ascertainable monetary value that is made for the purpose of influencing or to assist the nomination or election of a candidate. MCL 169.204(1); 169.206(1). A communication is not treated as an expenditure unless it "support[s] or oppose[s] a . . . candidate by name or clear inference [,]" or unless it contains "express words of advocacy of election or defeat, such as 'vote for,' 'elect,' 'support,' 'cast your ballot for,' 'Smith for governor,' 'vote against,' 'defeat,' or reject.'" kind contributions or expenditures must be listed at fair market value and reported as both contributions and expenditures." MCL 169.226(1)(b).

The purpose of this letter is to inform you of the Department's examination of these matters and your right to respond to the allegations before the Department proceeds further. <u>It is important to understand that the Department is neither making this complaint nor accepting the allegations as true.</u>

If you wish to file a written response to this complaint, you are required to do so within 15 business days of the date of this letter. Your response may include any written statement or additional documentary evidence you wish to submit. Should you elect to file a response, please address all the allegations in the complaint and submit any evidence you feel necessary to rebut the allegations.

All materials must be sent to the Department of State, Bureau of Elections, Richard H. Austin Building, 1<sup>st</sup> Floor, 430 West Allegan Street, Lansing, Michigan 48918. If you fail to submit a response, the Department will render a decision based on the evidence furnished by the complainant.

A copy of your answer will be provided to Mr. Royal, who will have an opportunity to submit a rebuttal statement to the Department. After reviewing all of the statements and materials provided by the parties, the Department will determine whether "there may be reason to believe that a violation of [the MCFA] has occurred [.]" MCL 169.215(10). Note that the Department's enforcement powers include the possibility of entering a conciliation agreement, conducting an administrative hearing, or referring this matter to the Attorney General for enforcement of the criminal penalties provided in the Act.

Dear Mr. Fracassi:

This office represents the <u>Hayes Township Sentinel</u>, Frank Shepherd (Publisher), and Leslie Cunningham (Editor) (collectively, the "Respondents") in the above-referenced matter. We have received your letter dated November 1, 2018, which contained the Complaint. As your November 1, 2018 letter indicates, the Complaint alleges that the <u>Hayes Township Sentinel</u> has published campaign advertisements which expressly advocate for the election of certain candidates and has failed to register as a committee under the Michigan Campaign Finance Act (the "MCFA"). For the following reasons, the Complaint must be dismissed.

#### I. THE <u>HAYES TOWNSHIP SENTINEL</u> IS A "NEWSPAPER, MAGAZINE, OR OTHER PERIODICAL OR PUBLICATION"

There can be no dispute that the <u>Hayes Township Sentinel</u> is a "newspaper, magazine, or other periodical or publication" for the purposes of Section 6(2)(d) of the MCFA.<sup>1</sup> As the Complainant himself admits, Respondent Frank Shepherd is the "Publisher" and Respondent Leslie Cunningham is the "Editor" of the <u>Hayes Township Sentinel</u>.<sup>2</sup> The Complaint's admission on this point is consistent with the facts:

- Frank Shepherd is, first and foremost, a newspaper publisher. From 1969 to 1981, he ran the Macomb Daily and the Royal Oak Tribune before selling the interests in these and other newspapers in 1981. Thereafter, in 1997, he purchased these same two newspapers along with The Oakland Press. He operated these three newspapers until 2004 when he sold his company, 21st Century Newspapers, to The Journal Register Company of New Haven, Connecticut.
- 2. In November 2017, Frank Shepherd and Leslie Cunningham published the first edition of the <u>Hayes Township Sentinel</u>, and have published this newspaper <u>each month</u> thereafter. As each edition of the <u>Hayes Township Sentinel</u> states:

## "Hayes Township SENTINEL

Keeping Watch and Shining Light on the Politicians and Political News of Hayes Township Published Monthly and Mailed Free to all Residents of Hayes Township, Charlevoix County"

- 3. The <u>Hayes Township Sentinel</u> hired a reporter, who also worked for the local weekly newspaper, the <u>Charlevoix Courier</u>. This reporter covered Hayes Township meetings, recorded these meetings, posted Hayes Township meeting agendas, and posted news stories on the <u>Hayes Township Sentinel</u> Facebook page and website, <u>www.HayesTownshipSentinel.com</u>.
- 4. For your reference, each monthly publication of the <u>Hayes Township Sentinel</u> has or will be personally delivered to your office. As you will notice, the news stories, tributes, and editorials focus on Hayes Township political news and how Hayes Township conducts the people's business. As publisher Frank Shepherd stated in the first edition of the <u>Hayes Township Sentinel</u>:

"You are reading the first edition of The Hayes Township Sentinel, a newspaper dedicated to transparency in our township government. It will be published monthly and mailed free to all residents of Hayes Township. Our mission is to cover, document, and report all the political news in the Township that affects you, making sure you have all information you need to make intelligent and informed decisions."

Moreover, the mere physical appearance of the <u>Hayes Township Sentinel</u> illustrates that the <u>Hayes Township Sentinel</u> is a newspaper. If it looks like a newspaper, reads like a newspaper, then it must be a newspaper!<sup>3</sup>

5. Although not even alleged in the Complaint, it must be emphasized that Respondent Frank Shepherd and Respondent Leslie Cunningham are not candidates, agents of a candidate or a candidate committee, or agents of any committee under the MCFA.

Accordingly, there can be no dispute that the <u>Hayes Township Sentinel</u> is a "newspaper, magazine, or other periodical or publication" for the purposes of the MCFA.

#### II. THE MEDIA EXEMPTION UNDER THE CAMPAIGN FINANCE LAWS

The MCFA applies only where an activity or disbursement falls within the definition of either a "contribution" or "expenditure" set forth in the MCFA.<sup>4</sup> According to Section 6(2)(d) of the MCFA,<sup>5</sup> an "expenditure" does not include activities in connection with the so-called "media exemption":

"(d) An expenditure<sup>6</sup> by a broadcasting station, newspaper, magazine, or other periodical or publication for a news story, commentary, or editorial in support of or opposition to a candidate for elective office or a ballot question in the regular course of publication or broadcasting."

Unfortunately, there are no rulings under the MCFA with respect to the so-called "media exemption", however, the MCFA parallels the Federal Election Campaign Act. Consequently, in determining the applicability of the MCFA, rulings and regulations by the Federal Election Commission under the analogous provisions of the Federal Election Campaign Act are often utilized. According to the Michigan Department of State: 10

"While rulings of the FEC are not dispositive of questions posed under Michigan law, they do constitute guidance with respect to comparable questions presented in Michigan."

The Federal Election Campaign Act contains a "media exemption" similar to the "media exemption" found in the MCFA. 11 CFR 100.132 of the Federal campaign finance regulations provides in pertinent part:

"Any cost incurred in covering or carrying a news story, commentary, or editorial by any broadcasting station (including a cable television operator, programmer or producer), Web site, newspaper, magazine, or other periodical publication, including any Internet or electronic publication, is not an expenditure...."

The Federal Election Commission has interpreted the "media exemption" broadly, consistent with Congress's admonition that the Federal Election Campaign Act was not intended "to limit or burden in any way the first amendment freedom of the press." For instance, although 52 U.S.C. § 30101(9)(B)(i) speaks only of a "news story, commentary, or editorial," the Federal Election Commission's regulations have extended the protection to any "cost incurred in covering or carrying" exempt material. <sup>13</sup>

In Advisory Opinion 2003-34 (Viacom) dated December 19, 2003, the Federal Election Commission summarized the applicability of the press exemption as follows:

"Several factors must be present to conclude that the proposed activity falls within the press exemption of 2 U.S.C. 431(9)(B)(i) and 434(f)(3)(B)(i). First, the entity engaging in the activity must be a press entity as described by the Act and Commission regulations. See Advisory Opinions 2000-13, 1998-17, 1996-48, 1996-41, 1996-16 and advisory opinions cited therein. Furthermore, an application of the press exemption depends upon the two-part framework presented in Reader's Digest Association v. FEC, 509 F. Supp. 1210, 1215 (S.D.N.Y.1981): (1) Whether the press entity is owned or controlled by a political party, political committee, or candidate; and (2) Whether the press entity is acting as a press entity in conducting the activity at issue (i.e., whether the entity is acting in its "legitimate press function"). See also FEC v. Phillips Publishing, 517 F.Supp.1308, 1312-1313 (D.D.C. 1981); Advisory Opinions 2000-13, 1996-48, and 1982-44."

Significantly, the courts hold that a press entity is entitled to rely upon the media exemption without regard to the medium of the publication. In <u>Reader's Digest Ass'n v FEC</u>, <sup>14</sup> the Federal Election Commission issued a subpoena regarding a videotape distributed by a magazine company. However, the court and the Federal Election Commission determined that the videotape was within "Reader's Digest legitimate press function." In <u>Federal Election Commission v Phillips Publishing</u>, Inc., <sup>15</sup> the Federal Election Commission

attempted to enforce a subpoena regarding a solicitation by the publisher of a newsletter. Again, the court found that the solicitation was within the publisher's legitimate press function.<sup>16</sup>

#### III. THE MEDIA EXEMPTION UNDER THE MCFA REQUIRES THE DISMISSAL OF THE COMPLAINT

In the present situation, the Complaint references two activities undertaken by the <u>Hayes Township Sentinel</u> as constituting "expenditures" under the MCFA:

- 1. The dissemination of news, opinion, commentary, and editorials in the monthly publications of the <u>Hayes Township Sentinel</u>; and
- 2. The promotion of the news, opinion, commentary, and editorials by the <u>Hayes Township Sentinel</u> in certain paid advertisements in the <u>Charlevoix Community Shopper</u>.

Both of these activities are exempt activities pursuant to Section 6(2)(d) of the MCFA:

- 1. The <u>Hayes Township Sentinel</u> is a "newspaper, magazine, or other periodical or publication" under Section 6(2)(d) of the MCFA. As indicated earlier in this Response, the <u>Hayes Township Sentinel</u> is a monthly publication covering the news of Hayes Township. The <u>Hayes Township Sentinel</u> is a press entity for the purposes of the so-called "press" or "media" exemption under the campaign finance laws.
- 2. The news, opinion, commentary, and editorials set forth in the monthly publication of the <u>Hayes</u> <u>Township Sentinel</u> were conducted in the regular course of publication.
- 3. The news, opinion, commentary, and editorials paid for by the <u>Hayes Township Sentinel</u> in the <u>Charlevoix Community Shopper</u> advertisements were activities taken by the <u>Hayes Township Sentinel</u> acting in its "legitimate press function" by promoting its editorial views to the citizens of Hayes Township.<sup>17</sup> As indicated by the <u>Reader's Digest</u> and <u>Phillips Publishing</u> cases referenced earlier in this Response, the <u>Hayes Township Sentinel</u> is entitled to rely upon the media exemption without regard to the medium of the publication.

Accordingly, since the activities referenced in the Complaint are the legitimate press functions of a press entity, Section 6(2)(d) of the MCFA exempts such activities from the coverage of the MCFA. The <u>Hayes Township Sentinel</u>, a press entity, was engaging in a legitimate press function - editorializing - when it published both the monthly publications of the <u>Hayes Township Sentinel</u> and the news, opinion, commentary, and editorials in the <u>Charlevoix Community Shopper</u> advertisements. These activities are exempt from the MCFA pursuant to Section 6(2)(d), and are furthermore exempt from the MCFA for sound public policy and constitutional reasons.

For the foregoing reasons, the Complaint must be dismissed.

Petitioner's Reply Memorandum to Respondents' Response.

Dear Mr. Fracassi:

This is my Reply Memorandum to the Response filed by Attorney Eric Doster on behalf of the Hayes Township Sentinel, Frank Shepherd and Leslie Cunningham.

#### I. THE HAYES TOWNSHIP SENTINEL IS NOT A NEWSPAPER; IT IS A PARTISAN TABLOID CAMPAIGN PUBLICATION.

A. The Respondents correctly point out that "newspapers" are treated differently than campaign publications under the Michigan Campaign Finance Act. (MCFA). MCL 169.206(2)(d). However, the Hayes Township Sentinel is not a "newspaper" by any reasonable definition.

Under Michigan's Revised Judicature Act, a newspaper is defined as follows:

MCL 600.1950 Newspaper; definition.

(1) The term "newspaper" is limited to a newspaper published in the

English language for the dissemination of local or transmitted news and intelligence of a general character or for the dissemination of legal news, which has a bona fide list of paying subscribers or has been published at not less than weekly intervals in the same community without interruption for at least 2 years, and has been established, published, and circulated at not less than weekly intervals without interruption for at least 1 year in the county where the court is situated.

The Respondents have done all of us a favor by attaching to their Response every single copy of the Sentinel that has been distributed from November, 2017, through October, 2018, except the issue dated September, 2018, which was attached to the Petitioner's Complaint (Note: there apparently was no issue dated March, 2018). Review of these issues demonstrates that the Sentinel does not qualify as a "newspaper", but is a partisan tabloid campaign publication.

Applying the above definition, the Sentinel has never disseminated "local or transmitted news and intelligence of a general character...." From first issue to last, all it has done is attack and call for the recall of three members of the Hayes Township Board of Trustees (Marlene Golovich, W. Robbin Kraft, and Paul Hoadley), and call for the election of Warren Nugent, Julie Collard, and Bob Jess to take their place. The three incumbents are continuously berated for supposedly engaging in planning and financial mismanagement in the process of converting a former summer camp into a Hayes Township Park. (The purpose of the new Park is to provide access to Lake Charlevoix to all Township residents (indeed, to the general public), including those who do not own lakefront property).

There is not a single non-partisan article about the disputed issues or the recall campaign in any copy of The Sentinel. No letters or columns disagreeing with Frank Shepherd and Leslie Cunningham's partisan diatribes have been printed in any issue. Every issue has been filled with false, slanderous allegations; fabricated propaganda; and distorted half-truths. No rebuttal has ever been allowed.

Further, there has been no pretense of providing "news or intelligence of a general character" about Hayes Township, as required by the statutory definition.

In addition, the Sentinel has no paid subscribers, but is mailed free of charge to every resident in the Township, at the expense of the Sentinel's secret financial backers. It has been published monthly, instead of at the "not less than weekly" intervals required of a real newspaper. And it has not been published for two years, as required by statute.

Further proof that the Sentinel is not a "newspaper" is established by the fact that publication ceased after the November 6, 2018 election, for a period of three months. Then, in the last week of January, 2019, another issue was distributed that is attached hereto, and which provides important information in support of the Complaint. The front page article entitled "We're back – and Ready to Roll," says that "our last printed newspaper we mailed to your home just before the November 6<sup>th</sup> election...." It goes on to state that each issue of the Sentinel costs \$800 to write, layout, typeset, print, and mail. And it states: "So far we have *quietly* raised \$6,000...." (emphasis added). The article does not include the identification of the secret financial backers of this partisan publication who "quietly" contributed \$6,000—which is just the information that the voters of Hayes Township had a right to have, pursuant to the Campaign Finance Act, before deciding how much credibility to attach to the scurrilous accusations that have filled The Sentinel.

If The Sentinel was a real newspaper, and not a campaign publication, it would not have suspended publication for the three months after the November 6, 2018 election. Indeed, it would have published a regular issue, reporting on the results of the election, for the benefit of Township residents. But this information was not disseminated until the late January, 2019 edition, three months later. Only in the pages of George Orwell's novel <u>1984</u>, would a partisan publication such as The Hayes Township Sentinel qualify to be called a "newspaper."

The Respondents' further claim that because Frank Shepherd used to publish real newspapers, then anything he publishes today should be considered a "newspaper." But calling oneself a "publisher" or an "editor" of a partisan campaign publication does not make that publication a "newspaper." Just because they call it a "newspaper" does not make it a bona fide newspaper.

The Respondents claim that because they hired someone they wish to call a "reporter", then articles written by this person must be considered news article. But this mysterious, unidentified person did not ever write an objective, non-partisan news article for publication in The Sentinel, because no such objective, non-partisan news articles ever appeared in any issue of The Sentinel, and the Respondents' Response does not identify any such article.

The Hayes Township Sentinel does not qualify as a "newspaper" by any reasonable definition. An objective reading of the issues clearly discloses that it is a publication of a campaign committee: a group of disgruntled Township residents who wanted to unseat hard-working, honest members of the Township Board of Trustees and replace them with puppets of Frank Shepherd and Leslie Cunningham.

And sure enough, the January, 2019 issue of the Sentinel, reports in an article on the front page entitled "Money Tight — May be Crunch Time," that the newly elected Board of Trustees has appointed Frank Shepherd to be a "new member of the Zoning Board of Appeals", and Leslie Cunningham has been appointed to the Parks and Rec Committee. This completes the underhanded coup these two have engineered, and completes their takeover of Hayes Township government. All of this was accomplished in direct violation of the Michigan Campaign Finance Act.

The Secretary of State should reject the contention that The Hayes Township Sentinel qualifies as either a "newspaper", or a member of the news media, for purposes of the MCFA.

### II. THE MCFA DOES NOT AUTHORIZE A MEDIA PUBLICATION TO PURCHASE PAID ADVERTISING IN ANOTHER PUBLICATION EXPLICITLY ADVOCATING THE ELECTION OF SPECIFIC INDIVIDUALS TO PUBLIC OFFICE.

The Hayes Township Sentinel does not dispute that it purchased advertising in several issues of The Charlevoix Courier which explicitly encouraged citizens to vote for Frank Shepherd and Leslie Cunningham's preferred candidates: Warren Nugent, Julie Collard, and Bob Jess. Under no circumstances can these ads be considered to be any type of objective reporting. It is simply a partisan, campaign publication using funds furnished by mysterious, unidentified persons, to purchase ads to further its

partisan election agenda.

Not only is The Hayes Township Sentinel not a newspaper, but even if the Secretary of State should conclude that it is part of the media, then its activity in purchasing these ads is not any objective news reporting, but is clearly partisan, political activity. As such, The Hayes Township Sentinel is required to register as a campaign committee, as required by the MCFA, and notify the public, through the Secretary of State, of the identify of the financial supporters of its partisan propaganda.

#### III. CONCLUSION.

The Michigan Legislature, in enacting the MCFA, clearly wanted to protect the First Amendment rights of legitimate news media publications. But the Legislature just as clearly did not intend that surreptitious campaign publications should be allowed to masquerade as part of the news media, and thereby evade the requirements of the MCFA. The Hayes Township Sentinel in and of itself, along with its paid ads in The Charlevoix Courier, is clearly not part of the news media. It the Secretary of State accepts the contention that it is part of the news media, then such a contention will effectively drive a truck through the MCFA's attempt to protect the public's right to know who is financing election campaigns, including recall campaigns. The Respondents' transparent efforts to evade their statutory obligations under the MCFA should be rejected by the Secretary of State.

#### IV. RELIEF REQUESTED

Should the Secretary of State agree that the Respondents have operated as a surreptitious, unregistered campaign committee, then the Petitioner requests that an appropriate financial sanction should be imposed, keeping in mind the substantial financial resources of Respondent Frank Shepherd, as a result of the sale of the real newspapers he used to own. In addition, the Petitioner requests that the Secretary of State require the Respondents to publish another issue of The Sentinel, distributed free of charge to all residents of Hayes Township, in Charlevoix County, MI, with a statement on the upper part of the front page directly below the masthead, acknowledging that the Respondents have been publishing The Hayes Township

Sentinel in violation of the MCFA, and publishing the names and contribution amounts of all financial contributors to The Sentinel since it first began publication in November, 2017.

WHEREFORE, for all the above reasons, together with the reasons set forth in the original Complaint, the Secretary of State should find the Respondents in violation of Michigan's Campaign Finance Act, and impose appropriate sanctions.

In other business, the board unanimously approved bills submitted by the Park contractor, MDC, for \$203,553.95 and turned down a payment request by Park engineer, Jim Malewitz for \$7,048.44.

The board also approved repaying the \$250,000 bank loan due on March I that the previous trustees secured from Charlevoix State Bank.

As to the current cash position of the township and it's ability to continue paying township bills and to cash flow the park various board members expressed the following:

Supervisor VanZee...."this pretty well wipes out our construction budget...The issue is cash flow not our ability to pay bills...we must be cautious; we don't want to get into our reserves...We'll be in a better place in another month," continued VanZee.

Clerk Warren Nugent stated, "We may be getting close to not paying our monthly bills... we will know more in a month or so. It may be crunch time."

As to the board not approving Performance Engineering's bill, the Trustees took the following positions: "I have a hard time paying for work not done," said Trustee Bob Jess. "I want to be fair and respectful," said Treasurer Julie Collard. Supervisor VanZee said, "Haven't heard anyone up here saying we are not going to pay you. 





### Tighten your belts

The Hayes Township Board has major challenges ahead of it in 2019, most of them financial. I believe that while the expenses associated with the Phase I Boat Launch and Road Project are daunting, and rising monthly, we have elected the people who can collectively keep us out of debtor's prison and put us on the path to responsible stewardship of both money and property.

The most immediate task is to find a way to pay the construction bills we have. Treasurer Julie Collard has wound her way through a very sloppy set of books and records that she inherited and concluded that as of January 8, 2019 we will owe a total of \$187,730.48 if all current invoices are paid in full. This does not include the 10% retainage that we are required to withhold until a year after Phase I is completed. That figure is currently \$134,562.57, but future work that we already know we will have to do will increase that amount as well.

Then we have the \$250,000 Charlevoix State Bank Loan that we have to pay back plus interest by March I, 2019. That brings our total bill owing up to \$572,293.05. Are you gasping for breath yet? Collard estimates that after we pay the loan with interest back, we will then owe \$317,996.30. We do not have enough grant money coming in to cover this. We never were going to have enough! The 2019 Board (I've dubbed them the Fearless Five) has to come up with a plan that makes sense and

doesn't hurt too much.

Supervisor Ron VanZee said of the challenge, "We are not going to borrow any more money. I refuse. I've known from the beginning we couldn't cash flow



this." He recommends a careful look at the current general budget to see where we can transfer money into the Park fund to pay

the bills. While our bank loan

must be repaid with grant fund: the road to the launch must b paid for out of the general fund and that will be a large part of ou 2019 Park expenses, but we stil don't know exactly how much Our general fund savings accoun holds \$272,560.55 as of January & Even if we used the savings, wwould still be behind but more manageably so.

Further we need to remembe that we have to, by state law, retain about \$210,000 in our genera budget as a 6 month operating cushion so that we can still mee payroll and keep vital service going in case we find ourselve. in dire straights due to an out side event, like federal funding to the state disappearing due to a federal shutdown, or a loca

The Department of State has received a rebuttal statement from the complainant, a copy of which is enclosed with this letter.

Section 15(10) of the MCFA, MCL 169.215(10), requires the Department to determine within 45 business days from the receipt of the rebuttal statement whether there is a reason to believe that a violation of the Act has occurred. The complaint remains under investigation at this time.

If the Department needs more information, you may be contacted. The complaint will remain under investigation until a final determination has been made. At the conclusion of the review, all parties will receive written notice of the outcome of the complaint.

The Department of State (Department) has finished its investigation into the formal complaint filed by John Royal against your clients, alleging that the Hayes Township Sentinel (HTS) violated the Michigan Campaign Finance Act (MCFA or Act), 1976 PA 388, MCL 169.201 et seq. This letter concerns the resolution of the complaint.

Mr. Royal filed his complaint with the Department on October 25, 2018 alleging several violations of the Act. Mr. Royal stated that the HTS has published political campaign advertisements which expressly advocated for certain candidates in the November 2018 recall election. Mr. Royal stated that the HTS is a non-profit corporation and the Sentinel is distributed free of charge to all Hayes Township citizens. Mr. Royal further stated that HTS has not filed a statement of organization and filed certain reports as required by the MCFA. As evidence of this allegation, Mr. Royal submitted copies of the HTS dated September 29, 2018 and February 2018.

The second allegation raised by Mr. Royal concerns paid advertisements which were placed in the Charlevoix Community Shopper for the months of July, August, September and October. Mr. Royal stated that the HTS has paid for advertisement in the shopper that expressly advocate for the election of Warren Nugent for Clerk, Julie Collard for Treasurer, and Bob Jess for Trustee. Mr. Royal claims that the HTS has violated the MCFA because it has not registered as a committee and filed certain reports as required by the Act. As evidence of this allegation, Mr. Royal submitted copies of the advertisements from the Community Shopper.

By letter dated December 18, 2018, you responded on behalf of your clients. First, you argued that the HTS is a "newspaper, magazine, or other periodical or publication" under the Act, and is therefore exempt. You stated that HTS published the first edition in November 2017 and have published monthly since. You stated that the HTS' mission is to cover, document, and report all

the political news in the Township." You then argued that because HTS is a newspaper, magazine, periodical, or publication, its activity does not count as an expenditure under the Act. MCL 169.206(2)(d). You claim that based off of this exempt, the news, opinion, commentary and editorials published by HTS are exempt from the Act. You further state that the advertisements paid for by the HTS in the Charlevoix Community Shopper were activities taken by HTS "acting in its 'legitimate press function' by promoting its editorial views to the citizens of Hayes Township." You submitted as evidence to the answer copies of each of the monthly publications.

Mr. Royal submitted his rebuttal by letter dated January 30, 2019. In his rebuttal, Mr. Royal states that the HTS is not a newspaper as defined by the Revised Judicature Act, MCL 600.1950. Mr. Royal states that the monthly publication is purely political in nature and does not publish any material other than that which expressly advocates for the defeat of the incumbents. Mr. Royal further states that there is no material published that is non-partisan, and the Sentinel has no paid subscribers. He further stated that the HTS has "quietly raised \$6,000." Mr. Royal further argued that the MCFA does not authorize a media publication to make paid expenditures that expressly advocates for the election or defeat of certain candidates in other newspapers, magazines, or periodicals.

The issue presented in this complaint is whether the HTS should be required to register as a committee for engaging in express advocacy by printing material advocating for candidates or purchasing advertisements in the Community Shopper.

Under the Act, the words "contribution" and "expenditure" are defined, in pertinent part, to include anything of ascertainable monetary value that is made for the purpose of influencing or to assist the nomination or election of a candidate. MCL 169.204(1); 169.206(1). A communication is not treated as an expenditure unless it "support[s] or oppose[s] a . . . candidate by name or clear inference [,]" or unless it contains "express words of advocacy of election or defeat, such as 'vote for,' 'elect,' 'support,' 'cast your ballot for,' 'Smith for governor,' 'vote against,' 'defeat,' or reject." MCL 169.206(2)(b)(j). Further, "[i]n-kind contributions or expenditures must be listed at fair market value and reported as both contributions and expenditures." MCL 169.226(1)(b).

Exempted from the definition of expenditure is "[a]n expenditure by a broadcasting station, newspaper, magazine, or other periodical or publication for a news story, commentary, or editorial in support of or opposition to a candidate for elective office or a ballot question in the regular course of publication or broadcasting." MCL 169.206(2)(d).

The Department has never issued an interpretive statement or declaratory ruling on this exemption and the words are not defined by the Act. When words are not defined by statute, the Department must apply a definition that is generally familiar to the average person. See *People*. v. Martin, 271 Mich App 280, 352 (2006). In these circumstances, it is appropriate to refer to the dictionary definition of "periodical" and "publication." Periodical is defined as "published with

a fixed interval between the issues or numbers." Publication is defined for Copyright as "[t]he offering or distribution of copies of a work to the public."

According to your response, you indicated that the HTS is published monthly and is provided at no charge to the residents of Hayes Township and the primary goal of the paper is to provide coverage of political events in the Township. The HTS' articles of incorporation echo this sentiment but stating that the corporation's purpose is "to report on the monthly political happenings of the Hayes Township governing bodies . . . by publishing and circulating, free of charge, a monthly publication containing this information." 3

Based off the information contained within the articles of incorporation and considering the definition of "periodical" and "publication," the Department concludes that HTS is a publication because it regularly prints material with a fixed interval between issues and offers copies to the public and the information is created, issued, or disseminated on a steady or uniform, and thus, predictable basis. Therefore, because HTS is a publication<sup>4</sup>, express advocacy for a news story, commentary, or editorial that it prints, pays for, and disseminates to the public does not classify as an expenditure under the Act. MCL 169.206(2)(d).

However, this exemption does not extend to advertisements the HTS paid for and placed in the third-party, Charlevoix Community Shopper. In your answer, you argued that the purchasing of these advertisements in the Community Shopper is a "legitimate press function by promoting [HTS] editorial views to the citizens of Hayes Township" and that these advertisements were a "legitimate press function." The Department respectfully disagrees that the purchasing of advertisements which expressly advocate for the election of specific candidates is exempt under the Act. Moreover, the MCFA does not recognize the "legitimate press function" standard. Even if such standard existed under the Act, the purchasing of advertisements in a third-party publication that expressly advocate for the election of candidates squarely falls under the definition of "contribution" and "expenditure" as defined above and cannot be considered exempt under the Act.

Under the Act, corporations may make in-kind expenditures that are not coordinated with the candidate. MCL 169.254(4). A committee may be required to be formed where the corporation solicits or receives contributions in excess of \$500.00 for the purpose of making the independent expenditure. *Id.* While not required to form a committee, a person other than a committee that

makes independent expenditures that expressly advocate for the passage or defeat of a ballot question totaling \$100.01 or more in a single calendar year is required to file a report of the independent expenditure with the county clerk within 10 days of the date of the independent expenditure. MCL 169.251(1). Failure to timely file the independent expenditure report may require the payment of late filing fees. MCL 169.251(2).

Here, in the absence of evidence to the contrary, the Department takes you at your word that HTS did not solicit or receive contributions for the purpose of making the independent expenditure in the Charlevoix Community Shopper. While Mr. Royal alleges that HTS solicited contributions totaling \$6,000 a review of the January 2019 publication shows that the money was solicited for the purpose of publishing the HTS. The January 2019 publication makes no reference to contributions for an independent expenditure. Accordingly, the Department takes you at your word that HTS did not solicit or receive contributions for the purpose of making the independent expenditure in the Charlevoix Community Shopper and those expenditures were not coordinated with the candidates.

However, because the cost of the independent expenditures in the Community Shopper totaled more than \$100.01, HTS is subject to the independent expenditure reporting requirements of section 51. In supplemental questions issued by the Department, you have indicated that each of these advertisements cost \$285. Section 51 requires that independent expenditure reports be filed with the appropriate filing official (here, the Charlevoix County Clerk) within 10 days of the date of the independent expenditure. MCL 169.251(1). Based upon the dates of the advertisements, the HTS should have field four respective reports within 10 days of making the expenditure to the Community Shopper. To date, no such reports appear to have been filed.

Therefore, the Department concludes that the evidence supports a reason to believe a violation has occurred because the HTS made independent expenditures which expressly advocated for the election of certain candidates and failed to file proper independent expenditure reports with the Charlevoix County Clerk.

Upon reaching this conclusion, the Department is required to "endeavor to correct the violation or prevent a further violation by using informal methods [,]" if it finds that "there may be reason to believe that a violation"... has occurred [.]" MCL 169.215(10). The objective of an informal resolution is "to correct the violation or prevent a further violation [.]" *Id*.

As part of the informal resolution, the Department requests you file four independent expenditure reports related to each of the advertisements placed in the Community Shopper with the Charlevoix County Clerk's office. For your convenience, a copy of the form is enclosed. **These reports should be filed no later than April 22, 2019**. The Department notes that you may be assessed a late-filing fee by the Charlevoix County Clerk. MCL 169.233(7). Late-filing fees are assessed and collected by the filing official with whom the statements are filed. MCL 169.217(1). Any questions regarding these late-filing fees should be directed to the Charlevoix County Clerk.

Upon the filing of the independent expenditure reports, the Department will review the reports in order to determine whether further enforcement action may be necessary. If you have any questions, please do not hesitate to contact me.

Dear Mr. Doster:

This letter concerns the campaign finance complaint filed against your client, the Hayes Township Sentinel by John Royal, which alleged certain violations of the Michigan Campaign Finance Act (MCFA or Act), 1976 PA 388, MCL 169.201 *et seq*.

In his complaint, Mr. Royal alleged that the Hayes Township Sentinel had made certain contributions or expenditures but had failed to register as a committee and failed to file certain reports.

By letter dated April 8, 2019, the Department found that the evidence provided supported a reason to believe that a violation had occurred. As previously indicated, upon reaching this conclusion, the Department is required to "endeavor to correct the violation or prevent a further violation by using informal methods [,]" if it finds that "there may be reason to believe that a violation ... has occurred [.]" MCL 169.215(10). The objective of an informal resolution is "to correct the violation or prevent a further violation [.]" *Id*.

As part of the informal resolution, the Department asked you to file independent expenditure reports with the Charlevoix County Clerk's Office (the filing official) and provide a copy of the reports to the Department. These reports were sent via email prior to the requested date and have been received by the County Clerk's Office.

The Department has reviewed these statements and is satisfied that you complied with the Department's request. Therefore, the Department now considers this matter closed and will post the file to its website.

The Department notes that your client may be assessed late-filing fees per report by the Charlevoix County Clerk for each of these statements that were not timely filed. MCL 169.233(7). Late-filing fees are assessed and collected by the filing official with whom the

statements are filed. MCL 169.217(1). Any questions regarding these late-filing fees should be directed to the Charlevoix County Clerk.

Please be advised that this notice has served to remind you of your obligation under the Act to identify your printed matter and may be used in future proceedings as evidence that tends to establish a knowing violation of the Act.
