INSTRUCTIONS: Under the Vehicle Donation Program, a qualified recipient of a donated motor vehicle is exempt from tax on that motor vehicle under the Use Tax Act, MCL 205.94w. To claim an exemption from use tax, an authorized representative of a Regularly Organized Church or House of Religious Worship must certify that the recipient of the donated motor vehicle meets all the qualifications listed in Part A below. The representative must complete this certificate and provide the original to the qualified recipient who must present it to the Office of the Secretary of State when the motor vehicle is registered.
