

# Instructions for Form MI-1041-V

## 2018 Michigan Fiduciary Income Tax e-file Payment Voucher

### Important Information

Mail Form MI-1041-V with your payment after you e-file your MI-1041 return.

**Do not use this voucher to make any other payments to the State of Michigan.**

Enter on Form MI-1041-V below the tax due as shown on your *Michigan Fiduciary Income Tax Return* (MI-1041), line 25.

Your payment and MI-1041-V are due April 15, 2019. If your payment is late, you will owe interest and penalty in addition to the tax due. The annual interest rate is 1 percent above the current prime rate. Penalty is 5 percent of the tax due for the first two months, then 5 percent for each month thereafter until the full payment is received, up to a maximum penalty of 25 percent. If you pay late, you may calculate and add interest and penalty to your payment or Treasury will send you a bill for any additional amount due. Interest rates are adjusted on July 1 and January 1. If you do not owe any tax on your e-filed MI-1041, do not file this form.

### Mailing Instructions

- Make your check payable to the **“State of Michigan.”** Enter the **FEIN of the estate or trust** and **“2018 MI-1041-V”** on the front of the check.
- Detach Form MI-1041-V along the dotted line.
- Do not attach your payment to Form MI-1041-V. Instead, place both items loose in the envelope and mail to:

- Do not attach a copy of your return to the MI-1041-V. Attaching a copy of your return will delay the application of payment to your account.
- Do not write notes on the MI-1041-V or submit the voucher without payment.
