

# 2022 Aviation Fuel Informational Report - Sales and Use Tax

Issued under the authority of Public Act 167 of 1933 and 94 of 1937, as amended.

**INSTRUCTIONS:** Beginning April 1, 2016 and each calendar quarter thereafter, each taxpayer making retail sales of aviation fuel, and each person storing, using, or consuming aviation fuel for which use tax is due, shall file this informational report. "Aviation fuel" means any gasoline, distillate, benzine, naphtha, benzol, or other volatile and inflammable liquid produced, compounded, and used for propelling aircraft. This report is due on a quarterly schedule. Due date is the last day of the month following the end of the quarter. This informational report does not constitute a tax return, therefore, a Sales, Use and Withholding Taxes Monthly/Quarterly return is required to be filed separately - do not include any remittance of tax with this report. A taxpayer (person) required to file this informational report that fails or refuses to file the report within the time and in the manner specified is liable for a penalty of \$10 per day for each day for each separate failure or refusal up to, but not exceeding, a maximum penalty of \$500 for each separate violation.
