NONPARTICIPATING MANUFACTURER (NPM) TOBACCO PRODUCTS THAT MAY BE SOLD IN MICHIGAN AS OF MAY 1, 2022

EFFECTIVE May 1, 2022, the following changes are being made to Michigan's NPM Directory:

- KT&G Corporation Delisted
- Dosal Tobacco Listed for two NPM cigarette brands
- Xcaliber International added one NPM cigarette brand

PLEASE NOTE that cigarettes or RYO tobacco brand families that are not listed on the NPM Directory **may not be purchased, acquired, or sold for consumption in Michigan**. See below or go online to <https://www.michigan.gov/taxes/business-taxes/tobacco/topics/manufacturers>

Inclusion of a tobacco manufacturer or tobacco brand family on Michigan's NPM Directory only certifies that the manufacturers on the list have met their obligations with regard to 1999 PA 244 (MCL 445.2051 *et seq.*) and sections 6c and 6d of 1993 PA 327 (MCL 205.426c and 205.426d). Persons selling cigarettes or RYO for consumption in Michigan that were manufactured by either NPMs or Participating Manufacturers (PMs) should consult other state and federal laws to determine whether a tobacco brand can be sold legally in Michigan.

If a manufacturer or tobacco brand family is not listed on Michigan's NPM Directory, or if a manufacturer or tobacco brand family is not on the list of PMs published by the National Association of Attorneys General (NAAG), a person, including a Michigan tobacco tax licensee, is subject to civil and criminal penalties if the person purchases, stamps or sells that manufacturer's cigarettes or RYO in or into Michigan and those cigarettes and RYO would be subject to seizure and forfeiture. Furthermore, a cigarette or tobacco brand appearing on the Michigan's NPM Directory, or the NAAG list of PMs may not be sold for consumption in Michigan if it is manufactured by anyone other than the party identified on the NPM Directory or NAAG PM list as the manufacturer of that brand family.
