Pursuant to the requirements of Public Act 198 of 1974, as amended, the State Tax Commission (Commission) has issued an Industrial Facility Exemption Certificate numbered 2013-485, to Spen-Tech Machine Engineering Corp. located in City of Flint, Genesee County. Pursuant to the provisions of Public Act 198 of 1974, as amended, the State Tax Commission hereby finds that the industrial property, as described in the approved application, hereafter referred to as the industrial facility, owned or leased by Spen-Tech Machine Engineering Corp., and located at 4221 James P. 


