## Solar Energy Facility Exemption Certificate

This certificate provides the authority for the assessor to exempt the qualified solar energy facility for which this certificate is in effect, but not the land on which the qualified facility is located from ad valorem taxation. This certificate further provides the authority to levy a specific tax known as the Solar Energy Facility Tax.

The time schedule for undertaking and completing the qualified facility is July 15, 2024, through December 1, 2025. The estimated taxable value of the qualified facility for the tax year immediately preceding the effective date of this certificate after deducting the taxable value of the land as determined under MCL 211.154(4) is: \$0.00.

Branch Solar, LLC qualifies for a tax rate of \$7,000.00 per megawatt of nameplate capacity.

This certificate, unless revoked as provided by Public Act 108 of 2023, shall remain in force for a period of **20** year(s):

## Beginning December 31, 2025 and ending December 30, 2045.

This Solar Energy Facility Exemption Certificate is issued on April 1, 2025.
