Contributions to a certified community foundation may be eligible for the tax credits described in Revenue Administrative Bulletin 1995 - 10 and MCL §§ 208.38c and 206.261.

Listed below are the community foundations that have been certified by the Department of Treasury for tax year 2001. A number of the larger community foundations manage the funds of smaller community foundations. The smaller community foundations, known as geographic affiliate funds, are listed under the managing community foundation. Donations made to a geographic affiliate fund must be claimed by using the managing community foundation's code listed on the appropriate tax form. No other applications for certification will be accepted for tax year 2001.
