ORDER GRANTING PARTIES JOINT MOTION TO ADJOURN

NOTICE OF RESCHEDULING IN-PERSON HEARING

On February 5, 2024, the parties filed a Joint Motion to Adjourn the scheduled hearing for the above-captioned case. The motion also included a request for immediate consideration. A hearing date certain was scheduled for February 13-15, 2024. Petitioner's counsel was notified on February 1, 2024 that Petitioner's appraiser had unforeseen medical circumstances involving the appraiser's wife involving emergency surgery.
