

Election of Lessee Report of Eligible Manufacturing Personal Property

Issued under the authority of the General Property Tax Act, Public Act 206 of 1893, and the Essential Services Assessment Act, Public Act 92 of 2014. Filing is mandatory.

Leasing companies are not eligible to receive the exemption for qualified new personal property and qualified previously existing personal property and may not use the Combined Document (*Eligible Manufacturing Personal Property Claim, and Report of Fair Market Value of Qualified New and Previously Existing Personal Property*, Form 5278). With respect to personal property that is the subject of a lease agreement, regardless of whether the agreement constitutes a lease for financial or tax purposes, if the personal property is or will be Eligible Manufacturing Personal Property, the lessee and lessor may elect that the lessee report the leased eligible manufacturing personal property on Form 5278 and be responsible for any Essential Services Assessment liability that results. To elect for the lessee to report the leased personal property, at least some, but not necessarily all, personal property subject to the lease agreement must be Eligible Manufacturing Personal Property as defined in MCL 211.9m and MCL 211.9n. Property subject to the lease agreement must be reported on Part 2 and/or Part 3 of the Combined Document, as applicable.

To make this election, the lessee and lessor must complete this form in its entirety. In Part 3, list all parcel numbers included in this election. **It must be attached to Form 5278 when it is filed with the assessor of the local unit in which the property is located no later than February 20 or the March Board of Review prior to its adjournment.** Absent an election and the attachment of this form, the personal property shall be reported by the lessor on the personal property statement pursuant to MCL 211.19. See MCL 211.1057(8).
