# Program Overview

The Michigan Legislature appropriated \$409 million to the Michigan Department of Treasury to create and administer the Growing MI Business Grant Program as defined by Public Act 132 of 2021. In total, out of approximately \$130 million in application requests, nearly \$120 million was awarded to Michigan businesses.

Under the Growing MI Business Grant Program, eligible businesses in operation before October 1, 2019, could receive a grant up to \$5 million to hire additional staff to fill open positions, renovate or expand their business, or improve operations as they emerged out of the pandemic. Eligible businesses that began operating between October 1, 2019, and May 31, 2020, could receive a grant equal to 25% of certain specified costs.

Under state law, nine business types were eligible to apply for a grant:

- Entertainment venues
- Recreational facilities and public places of amusement
- Barbers and cosmetologists
- Exercise facilities
- Food service establishments
- Nursery dealers and growers
- Athletic trainers
- Body art facilities
- Hotels and bed & breakfast establishments

Interested businesses were required to submit a completed online application to the Michigan Department of Treasury by March 31, 2022. Grant award notifications to businesses have been sent. Michigan-based public sector consulting firm, Guidehouse Inc., worked on this project under a scope of work concluded with the Michigan Department of Treasury.

# Communicating with the Public

It was important to the Michigan Department of Treasury that the public be provided access to information and assistance before the Growing MI Business Grant Program launched, during its administration, and throughout the review process. In order to accomplish this, the department and program partners took the following actions:

- Held closed sessions with key stakeholders, including the Michigan Restaurant and Lodging Association, the Michigan Association of CPAs, the New Economy Initiative, and Goldman Sachs 10,000 Small Businesses to plan our community engagement strategy. We also communicated with other stakeholders throughout the state to communicate key dates and resources for the grant program;
- Hosted three informational webinars with 3,798 registrants;
- Sent three press releases from the Office of the Governor and eight email blasts from the Michigan Department of Treasury to industry partners, public interest groups, local units of government, legislators and the public;
- Created a grant website – [www.michigan.gov/abr](http://www.michigan.gov/abr) – which included links to recorded informational webinars, FAQs, eligibility information, and links to submit the application;
- Provided a grant call center phone number and email to address questions entities had for the grant; and
- Created and published overview documents (see appendix).

### Growing MI Business Grant Program Fact Sheet

The State of Michigan is launching a grant program to distribute up to \$409 Million of its American Rescue Plan Act funds. The program will support "Affected Businesses" – as defined by Public Act 132 of 2021 – that have experienced financial hardship as a result of the COVID-19 Pandemic.

**Information Requirements**  
Businesses will need to complete an online application, provide supporting documents and make a series of certifications. Eligible businesses will also need to submit electronically the following:

- **Financial Documentation and Information** to verify their decline in Michigan total sales from calendar year 2019 to calendar year 2020 for businesses that were in operation on October 1, 2019.
- **Financial Documentation and Information** to verify their fixed costs for calendar year 2020 for businesses that were not in operation on October 1, 2019, but started before June 1, 2020.
- **Beneficiary Agreement** with terms and conditions that has been electronically signed.

**Eligibility**  
Businesses that were in operation on October 1, 2019, may receive a grant based on the year-to-year total sales in Michigan (2020 from 2019) up to a cap that is the lesser of the financial hardship\* or \$5 Million. Businesses must add into total sales Paycheck Protection loan(s), a percentage of any federal Restaurant Revitalization any other state or local awards received.

Percent Decline in Total Sales	Grant Award
20% or more	100% of financial hardship*
≥ 10% but < 20%	75% of financial hardship*
≥ 5% but < 10%	50% of financial hardship*
≥ 1% but < 5%	25% of financial hardship*

**Businesses that were not in operation on October 1, 2019, but started before June 1, 2020, receive a grant of 25% of their "financial hardship", which represents their calendar year 2020. Financial hardship is calculated in the same manner for all eligible businesses in becomes oversubscribed, awards will be prorated on an equal basis among all eligible businesses.**

**Grant is calculated as the following:**  
For an eligible business that pays property taxes: (i) For an eligible business that leases a amount of Michigan (non-residential) property OR business premises, 17% of the lease fees paid for calendar year (CY) 2020.  
For an eligible business that owns a amount of Michigan (non-residential) property OR business premises, 17% of the lease fees paid for calendar year (CY) 2020.  
50% of the state unemployment insurance (SUI) taxes paid for CY 2020

# Communicating with Applicants

Applicants were encouraged call or email our Contact Center team throughout the application process. Our team also placed outbound emails and calls to request additional information to help applicants achieve eligibility whenever possible.

Throughout the duration of the program our Contact Center team fielded over **59,800 emails** and over **10,000 calls**. Below are a few example responses received back from applicants.

# Application Review Process Overview

- **8,329 applications** were submitted and reviewed.
- Applications were reviewed through a three-stage quality assessment process detailed below to verify compliance required per Public Act 132 of 2021.
  1. Applications were first screened to determine completion. Reviewers verified the following points:
    - The applicant uploaded the proper tax returns documents required to demonstrate the decrease in sales;
    - The applying business was in operation during the eligible dates;
    - The applying business was a business type that was eligible under the legislation;
    - The application was signed; and
    - Duplicate applications were removed.
  2. Reviewers then assessed all supporting documentation included with each application to ensure that applicants were eligible per Public Act 132 of 2021, which included the following parameters:
    - The business decline in total sales was properly calculated;
    - The supporting documents (e.g., lease documentation) submitted accurately represent the finances of business submitting the application;
    - To verify whether applicants fell into one of the nine categories eligible for the grant, reviewers assessed tax documentation and completed a Google search of the business name, address, associated websites, and general operations;
    - The cost of state license fees aligned with documented amounts paid to the state;
    - The cost of property tax claimed aligned with what was paid to the local government. Additionally, reviewers used the BS&A online database to confirm that the cost claimed was for property tax of a business location and not property tax for equipment or a residential address;



- Any additional financial hardship claimed (e.g., unemployment insurance tax) was verified through valid documentation;
  - Reviewers used public databases from the U.S. Small Business Administration and USASpending.gov to confirm the amount of other federal grants received and loans forgiven for each applicant as required per Public Act 132 of 2021; and
  - In compliance with Public Act 132 of 2021, federal American Rescue Plan Act (ARPA), and federal uniform guidance, an award formula was applied to ensure grants were only awarded if a business' total loss resulting from the COVID-19 emergency exceeds the amount received from any federal financial assistance for the same costs.
  - The Michigan Department of Treasury partnered with LexisNexis to access information and assess each business' general risk level to ensure business validity.
  - Reviewers requested additional information from applicants throughout the review process as needed:
    - Reviewers contacted applicants via phone or email and provided opportunities to correct errors and upload valid documentation when missing.
3. Reviewers completed quality assurance activities as needed, including:
- Taxpayer Identification Number (TIN) matching against IRS data
  - Confirming that TIN matched across relevant documents
  - Reviewing all documents and data included by applicants
  - General completeness checks

# Award Methodology

Eligible businesses that were in operation on October 1, 2019, may receive a grant based on the % decline in year-to-year total sales in Michigan (2020 from 2019) up to a cap that is the lesser of the amount of “financial hardship” or \$5 million. Businesses must add into total 2020 sales any forgiven Paycheck Protection Payments (PPP) and Restaurant Revitalization receipts per Public Act 132 of 2021.

Percent Decline in Total Sales	Grant Award
20% or more	100% of financial hardship*
≥ 15% but < 20%	75% of financial hardship*
≥ 10% but < 15%	50% of financial hardship*
≥ 5% but < 10%	25% of financial hardship*

Eligible businesses that were not in operation on October 1, 2019, but started before June 1, 2020, may receive a grant of 25% of their “financial hardship.” Financial hardship was calculated in the same manner for all eligible businesses.

Financial hardship is calculated in the following way, in accordance with Public Act 132 of 2021:

# Application Overview

## Key Insights

- The Growing MI Business Grant Program received 8,329 applications.
- In total 2,981 applications were approved bringing the total amount awarded to \$117,329,177.
- The average award amount for those approved is \$39,359.
- The range of award amounts spans from \$2 to \$5 million dollars.
- Applications were received from businesses in all 83 Michigan counties.

# Deep Dive: Reason for Denial

Of the applications reviewed, 5,333 applications did not meet the program's eligibility requirements per Public Act 132 of 2021. Applicants received a denial notice via email, containing one of the nine denial reasons listed below. The following table shows the number of applicants associated with each denial reason.

### Information Requirements

Businesses will need to complete an online application, provide supporting documents and make a series of certifications. Eligible businesses will also need to submit electronically the following:

- **Financial Documentation and Information** to verify their decline in Michigan total sales from calendar year 2019 to calendar year 2020 for businesses that were in operation on October 1, 2019.
- **Financial Documentation and Information** to verify their fixed costs for calendar year 2020 for businesses that were not in operation on October 1, 2019, but started before June 1, 2020.
- **Beneficiary Agreement** with terms and conditions that has been electronically signed.





## Award Methodology

- Eligible Businesses that were in operation on October 1, 2019, may receive a grant based on the % decline in year-to-year total sales in Michigan (2020 from 2019) up to a cap that is the lesser of the amount of "financial hardship" or \$5 Million. Businesses must add into total sales any forgiven Paycheck Protection loan(s), a percentage of any federal Restaurant Revitalization receipts, and any other state or local awards received.

Percent Decline in Total Sales		Grant Award
20% or more	=	100% of financial hardship*
≥ 15% but < 20%	=	75% of financial hardship*
≥ 10% but < 15%	=	50% of financial hardship*
≥ 5% but < 10%	=	25% of financial hardship*

- Eligible businesses that were not in operation on October 1, 2019, but started before June 1, 2020, may receive a grant of 25% of their "financial hardship," which represents their calendar year 2020 fixed costs. Financial hardship is calculated in the same manner for all eligible businesses.

*If the ABR program becomes oversubscribed, awards will be prorated on an equal basis among all eligible businesses as defined by PA 132..*

\*Financial Hardship is calculated as the following:
