





SUBJECT: Children of Veterans Tuition Grant (CVTG) Expenditures for FY 2018

Public Act 248 of 2005 states: *“By December 1 of each year, the authority* shall annually submit a report to the state budget director and the house and senate fiscal agencies for the preceding fiscal year, on the Children of Veterans Tuition Grant program. The report shall include, but is not limited to, the total number of tuition grants paid by the department in the preceding fiscal year, the total dollar amount of those tuition grants, and the number of students receiving grants and the total amount of those grants at each eligible institution.”*

The attached report provides all requested information regarding The Children of Veterans Tuition Grant program. Please note that the Police Officer's and Fire Fighter's Survivor Tuition Grant (STG) is allocated with the same line item as CVTG, but details on expenditures for that program are not included in this report. *Executive Order 2010-2 eliminated the Michigan Higher Education Assistance Authority (the authority) and placed the CVTG program under the Department of Treasury.
