RESOLUTION 2015-11

**APPROVING THE CITY OF DETROIT’S FY 2016 BUDGET
AMENDMENT 2016-1 TO IMPLEMENT THE OFFICE OF THE CHIEF
FINANCIAL OFFICER**

WHEREAS, Public Act 181 of 2014, the Michigan Financial Review Commission Act (the “Act”), allows for the creation of the Detroit Financial Review Commission (the “Commission”) within the Michigan Department of Treasury; and

WHEREAS, Section 6(1) of the Act empowers the Commission to provide oversight for the City of Detroit (the “City”) beginning on the Effective Date of the Plan of Adjustment; and

WHEREAS, Section 7(c) of the Act provides that during the period of oversight, the Commission review, modify, and approve the City’s proposed and amended operational budgets and that a proposed budget or budget amendment does not take effect unless approved by the Commission; and

WHEREAS, Section 6(3) of the Act further requires the Commission to ensure that the City complies with the requirements of the Uniform Budgeting and Accounting Act; and

WHEREAS, the Uniform Budgeting and Accounting Act prevents the City from deviating from its original general appropriations act without amending it and requires the City to amend its general appropriations act as soon as it becomes apparent that a deviation from the original general appropriations act is necessary and the amount of the deviation can be determined; and

WHEREAS, Emergency Manager Order No. 41 directs the City's Chief Financial Officer (CFO) to establish a centralized financial management organizational structure for the City (the "Office of the Chief Financial Officer") and authorizes the City's CFO to transfer certain positions and their associated funding from the City's various departments, divisions and agencies to the Office of the Chief Financial Officer; and

WHEREAS, at the Commission meeting on July 27, 2015, the City presented a budget-neutral FY 2016 budget amendment No. 2016-1 to implement the OCFO, which transfers the funding of finance, budget, and grant related positions to the OCFO from various City departments, divisions and agencies.

NOW THEREFORE, be it resolved by the Detroit Financial Review Commission as follows:

1. That the City's FY 2016 budget amendment No. 2016-1 to implement the Office of the Chief Financial Officer presented on July 27, 2015, is hereby approved.
2. That the minutes of the Detroit Financial Review Commission meeting at which this Resolution is adopted take notice of the adoption of this Resolution.
3. This Resolution shall have immediate effect.
