Page 7 with the exception of Resolution Number 4 which is an 1 amendment to the fiscal year 2014 general fund and 2 3 utilities services fund budgets. You so move? 4 5 MR. WITKOWSKI: Yes. MR. VAUGHN: Is there a second? 6 MS. HUNT: I second. 7 MR. VAUGHN: All those in favor, say aye. 8 MR. WITKOWSKI: 9 Aye. MS. HUNT: Aye. 10 11 MR. VAUGHN: All those opposed, say no. 12 Motion passed. The next item on the agenda is the resolution 13 for Number 4 budget amendment to general fund and 14 whiley tilities services fund. On this motion, we can only 15 deny or recommend passage of this to the state treasurer. 16 Is there any discussion on this item? 17 Mr. Watson can you give us a little bit of 18 19 information about this budget amendment? There were a couple of issues that 20 MR. WATSON: 21 we had that we had to address in the form of budget 22 amendments. For example, there were costs that came in 23 above what we had anticipated, unemployment expenses,

healthcare expenses and we had to make modifications in

the budget line item so we would not be over on that

- 1 particular line item.
- 2 If there's any specific questions to it, I
- 3 would be more than willing to answer, but these are just
- 4 more -- the overall amendment netted to zero, so it's
- 5 just moving dollars from different line items to other
- 6 line items that are necessary to accommodate over-ages
- 7 in those specific line items.
- MR. VAUGHN: Are you moving money from the
- 9 local street fund to the general fund then? Is that
- 10 right?
- MR. WATSON: Yes.
- MR. VAUGHN: And the equipment rental, the
- 13 local street fund was renting equipment from the general
- 14 fund?
- 15 MR. WATSON: Correct.
- MR. VAUGHN: Okay. Can you tell me if these
- 17 expenses were incurred before the City Commission approved
- 18 the amendment to the budget?
- 19 MR. WATSON: I believe they were. I would
- 20 ask Jodi to also assist with this. These were normal
- 21 course-of-business items that came up. Like I said,
- 22 unemployment costs that we had dedicated 50,000 came
- 23 in at 55,000. So those were the movements of money that
- 24 were necessary to accommodate that.
- MR. VAUGHN: Okay. Miss Lundquist, can you come

- 1 to the podium, please?
- 2 Were these expenditures incurred before the
- 3 budget amendment was passed?
- 4 MS. LUNDQUIST: Yes. For instance, as the city
- 5 manager had just indicated, we did have our unemployment
- 6 filled, which comes in quarterly and it's fully
- 7 reimbursing. So if our unemployment costs exceed what we
- 8 had already remitted, according to our regular billing
- 9 cycle, we have to then reimburse those additional costs.
- 10 So, for instance, several of the departments, we had not
- 11 been able to anticipate that individuals would still be
- 12 receiving unemployment benefits. Therefore, we were
- 13 charged back those reimbursements. So to that extent,
- 14 yes.
- To speak to the equipment rental, those expenses
- or the rental of that equipment is tracked for both major
- 17 and local streets and we were advised by our auditors that
- 18 if we're going to continue to charge major streets, that
- 19 budget could afford the rental, but local streets with the
- 20 winter we had could no longer afford rental of the
- 21 equipment, so both the equipment rental and the transfer
- 22 out to local streets went to zero.
- MR. VAUGHN: So there's sufficient funding in
- 24 the local street fund for this then. Right?
- MS. LUNDQUIST: There is sufficient funding by

- 1 virtue of the transfer out to local streets. So the
- 2 general fund, it's basically just accounting, so the
- 3 general fund is saying, okay, we'll recognize this as a
- 4 transfer into local streets so then local streets can
- 5 afford the transfer back to the general fund for
- 6 equipment.
- 7 MR. VAUGHN: Gotcha.
- 8 Is there any way to be more predictive in these
- 9 going forward or will we be approving budget amendments
- 10 after the fact in the future?
- MS. LUNDQUIST: We will definitely, for
- 12 instance, with unemployment, be taking a look at those
- 13 departments that were impacted by these reimbursement
- 14 costs and project going forward. Also, the amendment,
- 15 you know, pre-receiving any future bills, might still be
- 16 receiving benefits.
- MR. VAUGHN: Okay. Do you have any questions
- 18 for Miss Lundquist?
- MR. WITKOWSKI: No.

- MS. HUNT: I make a motion to approve.
- MR. WITKOWSKI: I'll support that.
- MR. VAUGHN: All those in favor, say aye.
- MR. WITKOWSKI: Aye.
- MS. HUNT: Aye.

- Motion passed.

- MR. WATSON: What we're requesting is that
- 24 there's a notary fee that was omitted from that listing of
- 25 all the fees that the city charges for the notaries that

- 1 we have in the city to notarize stuff for the general
- 2 public. The \$10 fee, notary per page notarized is what
- 3 we're asking for.
- MR. VAUGHN: Okay. Thank you, Mr. Watson.
- 5 Any further discussion?
- I would entertain a motion to recommend to the
- 7 state treasurer an amendment to EM Order 13-9 per the
- 8 recommendation of the city manager.
- 9 MR. WITKOWSKI: I'll make that motion.
- MS. HUNT: I second it.
- MR. VAUGHN: All those in favor, say aye.
- MR. WITKOWSKI: Aye.
- MS. HUNT: Aye.
- MR. VAUGHN: All those opposed, say no.
- Motion passed.
- Just one more reminder to the public. If you
- 17 want to have public comment at the end of this session,
- 18 you have to sign in at the table up front. If you do not,
- 19 you will not be recognized, and you can do that now if you
- 20 want.
- 21 The next item is the approval of the lawsuit
- 22 settlement.
- Mr. Watson, would you please give us some
- 24 information on this?
- MR. WATSON: Yes, sir.

- 1 Under EM Joseph Harris, there was a -- where he
- 2 relieved the contract of the building official that we had
- 3 and, in doing so, there was a contention of payment due.
- 4 This has gone through the local courts and has also been
- 5 appealed by the City of Benton Harbor, and it was the
- 6 decision that the courts were upheld at the appellate
- 7 court as well.
- What we're recommending is that we make payment
- 9 for the lawsuit involving Mr. Walter Martlew to basically
- 10 put that to bed, for lack of a better term. It's been
- 11 going on for a while and I know there's been some
- 12 discussion and inquiries by Mr. Martlew as to what
- 13 happened once the appellate court upheld the decision.
- 14 So we're asking for approval of that payment to
- 15 Mr. Martlew.
- MR. WITKOWSKI: How much is that?
- 17 MR. WATSON: Right around \$75,000, 76,000,
- 18 \$76,000, give or take.
- MR. WITKOWSKI: Where does it come out of?
- 20 MR. WATSON: It is coming out of the general
- 21 fund. We have allocated for lawsuits and settlements
- 22 \$110,000, and this is going to come out of that line
- 23 item.
- MR. WITKOWSKI: What line item is it?
- MR. WATSON: It's in the general fund under

- 1 settlements and lawsuits. I can't remember exactly the
- 2 exact line item. I think it's legal fees or --
- 3 MR. VAUGHN: Miss Lundquist?
- 4 MS. LUNDQUIST: It would be coming out of the
- 5 general admin budget. Within the General Administration
- 6 Department and general fund, we do have a line item for
- 7 claims and deductibles in the budget. For this year, it
- 8 was set at \$106,847.
- 9 MR. VAUGHN: Thank you.
- 10 Any further questions for Mr. Watson?
- 11 Thank you, Mr. Watson.
- MR. WATSON: You're welcome.
- 13 MR. VAUGHN: I'd like to entertain a motion to
- 14 approve the settlement of the Walter Martlew settlement
- 15 or lawsuit according to the recommendation of the city
- 16 manager.
- MS. HUNT: I'll make a motion to approve the
- 18 settlement of that lawsuit.
- MR. WITKOWSKI: I'll support that.
- 20 MR. VAUGHN: All those in favor, say aye.
- 21 MR. WITKOWSKI: Aye.
- MS. HUNT: Aye.
- MR. VAUGHN: All those opposed, say no.
- 24 Motion is passed.
- The next item on the agenda is the approval of

- 1 commission vacancy appointment.
- 2 Is there any discussion on this item?
- 3 Seeing none, I would entertain a motion to
- 4 approve the appointment of Mary Donald as city
- 5 commissioner to fill the existing vacancy.
- 6 Oh, sorry. Yes, commissioner.
- 7 MR. SEATS: Commissioner Duane Seats, City of
- 8 Benton Harbor.
- 9 I would ask of the chairman and this board,
- 10 being that we're in a transition and this is one of the
- 11 first things that our commission has been able to do.
- The policy and procedure that was voted on by
- 13 the commission somehow was contaminated. The procedure
- 14 that we put in place was not followed to choose a
- 15 commissioner.
- I would ask of the city manager that he would
- 17 forward the information to the TAB Board or have some
- 18 expert from the state look into this process because many
- 19 of the ballots or what have you were compromised. It was
- 20 a 1 to 10 process. Some Commissioners even refused to
- 21 sign. There was zeros put in place where there was no
- 22 zeros on the original ballot.
- So I would just ask the TAB Board, if possible,
- 24 if we can reconvene this and if the policy is found not to
- 25 be compromised, we're more than willing to accept her in

- 1 that seat, but if it is found that the policy and
- 2 procedure that was in place was compromised, I would ask
- 3 of the TAB Board to have the City Commission go back to
- 4 the drawing board and do this process the right and
- 5 correct way, which was voted on by the City Commission in
- 6 a previous meeting.
- 7 MS. HUNT: I'd like to ask a question. How did
- 8 this happen? And how can we be assured that it won't
- 9 happen going forward?
- MR. SEATS: Well, an assurety (sic) to the TAB
- 11 Board, I would also request moving forward that another
- 12 governing body interview candidates as they did for the
- 13 Benton Harbor School Board, which was recommended by the
- 14 state, and then they recommend the appointees or we go
- 15 from the interview process outside of a commission
- 16 meeting, bring forth the best two or three candidates,
- 17 then vote.
- But the way this was handled, there was no
- 19 set-in-stone way to make sure that this practice was
- 20 followed, and when the practice was compromised, there
- 21 was no stopping of the process.
- 22 Some commissioners even refused to turn in
- 23 their ballots until they got done; some were not signed;
- 24 some, again, added numbers that were not even on the
- 25 ballot itself, which I recommended of our city manager

- 1 to bring forth to the state and the TAB because there was
- 2 many different city residents, also commissioners who did
- 3 have a problem with the process.
- And I would just ask that we could wait on this
- 5 issue, have the issue vetted by either the TAB or the
- 6 state to make sure that our process was followed correctly
- 7 and, if deemed necessary, to bring this process back and
- 8 start the process over.
- 9 MS. HUNT: Are you suggesting that that
- 10 additional body be outside of --
- MR. SEATS: Well, even if we have to go -- thank
- 12 you, Committee Member Hunt. Even if we have to go to the
- 13 county and have them interview or Berrien Springs,
- 14 Buffalo, St. Joe, any other municipality, because now it's
- 15 proven that there's some things that we don't have the
- 16 ability or to have another process in which the process
- 17 is judged or graded, because this should not have
- 18 happened, we should not even be discussing this matter,
- 19 and if the process was done correctly, I would not take
- 20 time off work to come down here and vet the process, but
- 21 the process has definitely been contaminated.
- I had to spend \$40 to FOIA for ballots and,
- 23 to see them, any person with any kind of governmental
- 24 knowledge would be appalled of what you would see. So I
- 25 would ask the city manager to forward this information to

- 1 the TAB and also the treasury board or the state and have
- 2 some expert from the state or someone to look at our
- 3 process and procedure.
- MR. VAUGHN: Commissioner, are you saying that a
- 5 majority of the commissioners did not vote to approve the
- 6 appointment?
- 7 MR. SEATS: I am saying that a majority did not
- 8 follow the process correctly, yes, sir.
- 9 MR. CLINE: Mr. Chairman, if I may --
- 10 MR. VAUGHN: Mr. Cline.
- 11 MR. CLINE: May I make a suggestion? It was
- 12 actually my recommendation that this issue be placed on
- 13 the agenda because this would be outside of our normal
- 14 review process since this happened at a meeting outside
- 15 the city's normal submission deadline for items.
- And we did this primarily as a way to avoid any
- 17 debate that if the city wished to, after making this
- 18 selection, wanted to swear the commissioner in to allow
- 19 them to begin to fulfill their duties, we wanted to avoid
- 20 any possible question that this had to wait for the RTAB
- 21 because I'm sure the city would be anxious to move
- 22 forward, so it was recommended that we bring this issue
- 23 forward.
- 24 If the city has questions or concerns about the
- 25 process that the city used, I think the first place that

- 1 we should begin would be to see what the city attorney has
- 2 to say about that. I'm not entirely certain where the
- 3 city's right to make this appointment in our jurisdiction
- 4 on that begins, whether to approve or deny, because I
- 5 think that was an issue not necessarily envisioned when
- 6 the RTAB process was created. So I'm certain that the
- 7 city manager will be giving us any information on this and
- 8 we can certainly take a look at it.
- 9 If the RTAB Board wishes to postpone
- 10 consideration today, I think then this discussion will
- 11 just come up next month as part of the resolution that was
- 12 voted on at that meeting, but I do not know nor would I
- 13 wish to speculate whether or not this prevents the city
- 14 from swearing in the selection that they made because I
- 15 think it's a matter for the city attorney to determine
- 16 if the vote that was taken was in any way invalid. I
- 17 wouldn't even want to speculate on that because I think
- 18 that's more a matter for the City Commission, the city
- 19 manager and the city attorney to review and look at, so --
- MR. VAUGHN: Mr. Cline, could the city attorney
- 21 look at that information after the TAB has passed on it
- 22 or denied it? What is your recommendation?
- MR. CLINE: I don't know. I think if there's
- 24 some question or some hesitation -- we were just simply
- 25 moving this forward in the process out of a potential --

- 1 we were moving it forward from our normal review process
- 2 to sort of prevent any question of what our role in this
- 3 process would be, but it appears now that there may or may
- 4 not be some concerns. I don't actually know if the new
- 5 commissioner has been sworn into office yet.
- 6 MR. SEATS: No, no, sir.
- 7 MR. CLINE: So I would think that if the city is
- 8 still reviewing this internally, then perhaps it would be
- 9 best we just postpone it until the next meeting and then
- 10 we'll address it. By then hopefully the city will have
- 11 more clarity for us because I think it would be
- 12 difficult -- it puts the RTAB Board in a difficult
- 13 situation to make a decision one way or the other when
- 14 there apparently are some questions on this, even among
- 15 the city itself. So I think we should just maybe pass on
- 16 it and see how this unfolds.
- 17 MR. SEATS: Mr. Chairman, I would ask of the
- 18 city manager if he would speak to also outside of the
- 19 commission having, if possible -- I know meetings don't
- 20 last that long, but if possible he can speak to it and
- 21 see if there's any issues that he also might have found
- 22 himself because I do believe this information had been
- 23 forwarded to the state. I don't know which avenues it was
- 24 forwarded to, but there was definitely some questions and
- 25 concerns that have been raised about that.

- 1 I do appreciate the TAB Board taking time to
- 2 address this issue, and I would just hope for the sanctity
- 3 of our city and where we're going and where we've come
- 4 from that we would take under consideration postponing it
- 5 until the next meeting.
- 6 Thank you, honorable chair.
- 7 MR. VAUGHN: Thank you, commissioner.
- MS. ADAMS: May I speak on this?
- 9 Commissioner Mary Alice Adams.
- 10 We hadn't got to the point because of this very
- 11 important matter that's important to Commissioner Seats.
- 12 I would ask this board to approve this
- 13 appointment by the consensus that was given by the Benton
- 14 Harbor City Commission, even outside of the votes.
- This process started on the basis of what is
- 16 in the City Charter or within the ordinance that the
- 17 commission chooses to replace a seat. I mean I'm sorry
- 18 that it didn't go the way that Commissioner Seats would
- 19 hope and still probably hopes that you all would handpick
- 20 someone, but I would ask that you would respect the
- 21 consensus that this elected body appointed.
- MR. VAUGHN: So, commissioner, you're saying
- 23 that a majority of the commission did vote --
- MS. ADAMS: Exactly.
- MR. VAUGHN: -- in the affirmative?

- 1 MS. ADAMS: Exactly.
- 2 MR. WITKOWSKI: What was the vote of the
- 3 commission?
- 4 MR. WATSON: The vote for the affirmation was
- 5 six to two.
- 6 MS. HUNT: Commissioner, I do have a question.
- 7 Are you saying the process was followed?
- MS. ADAMS: Yes, it was, and it was a process
- 9 that we among ourselves put in place, and Commissioner
- 10 Seats, during the process of the vote --
- MR. WITKOWSKI: Can we just stick to the
- 12 process?
- MS. ADAMS: -- he left the chamber. How he came
- 14 into the knowledge of knowing a bunch of the information
- 15 that he has shared with you all, the rest of us are
- 16 clueless about.
- 17 MR. VAUGHN: Okay. Thank you, commissioner.
- 18 MS. ADAMS: Thank you.
- MR. VAUGHN: There will be no more discussion
- 20 from the public at this time.
- MR. WITKOWSKI: My feeling on this issue is the
- 22 city is supposed to take care of itself from an
- 23 administration standpoint. Now, if something has been
- 24 done wrong and it can be proved, then I think that
- 25 opportunity is removed, and sounds like there's discussion

- 1 on both sides, but we also know that appointments are
- 2 political. That's a reality of your job as commissioners.
- 3 That's just a reality of the world we live in.
- 4 My feeling is if it was passed six to two, the
- 5 person should be seated regardless of what we say, and
- 6 then I would ask that it be looked into, the process,
- 7 because the process needs to be followed I think from
- 8 start to finish, and if there's a problem with the
- 9 process, then that needs to be addressed because then it's
- 10 going to spring off into other things that we'll have to
- 11 deal with that will have effects on the budgets and, at
- 12 the end of the day, our main function is to make sure
- 13 financially we are watching the books and making sure the
- 14 city is moving forward.
- As to appointments to the Planning Commission,
- 16 City Commission, I respect everybody having how they
- 17 believe and you know everybody can come to my office and
- 18 talk to me. I don't want us to be getting into looking
- 19 over every little, minute detail.
- To me, the process was approved by the state.
- 21 The state told the city how to appoint somebody. Right?
- 22 MR. CLINE: For the appointment of a city
- 23 commissioner, that isn't necessarily specifically
- 24 addressed.
- MR. WITKOWSKI: I thought the EM's order was

- 1 for the commission to develop a process to appoint
- 2 somebody.
- 3 MR. CLINE: The final EM order discusses the
- 4 RTAB review and approval of appointments to boards and
- 5 commissions, and it requires the city to move forward on
- 6 those in a timely manner. The specific wording regarding
- 7 a vacancy in the City Commission is a little less clear on
- 8 that.
- 9 Now, my office did provide some advice and we
- 10 had some discussions with the city manager regarding the
- 11 internal process that the City Commission ultimately ended
- 12 up using. It's similar to a process that I know has been
- 13 used in other communities and that type of thing.
- 14 I think really at the heart of the matter is,
- 15 at least from the city's standpoint -- this is just my
- 16 opinion, but as I see it, in my experience, the heart of
- 17 the matter is whether the vote the City Commission took
- 18 was a valid vote or not and --
- MR. WITKOWSKI: Well, there's two discussions.
- 20 One is the process which has been brought to us and then
- 21 one is the vote. The vote was six to two. The process
- 22 to me is a different issue.
- MR. CLINE: Yes, I agree. They put a process
- 24 in place, and there's been some indication or at least
- 25 some concerns raised over whether or not that process was

- 1 followed perfectly as written. But then does that in and
- 2 of itself invalidate the vote that was taken? And I think
- 3 that's a matter for the city attorney to weigh in on.
- And, as I said, part of the recommendation to
- 5 put that particular item on this agenda was to avoid any
- 6 discussion that we, in our meeting -- that we, the RTAB
- 7 in our meeting scheduling was unnecessarily holding up a
- 8 review of that because it falls on a meeting that was
- 9 outside of our review date for this particular RTAB
- 10 meeting.
- 11 So really the question becomes: Do we let the
- 12 city work this out and bring forth at the next meeting a
- 13 final, definitive what their intentions are or do we just
- 14 postpone our decision and let it fall back into our normal
- 15 review process or do we just move forward on the basis
- 16 that it appears a valid vote was taken by the City
- 17 Commission and, you know, you vote on that basis today.
- 18 MR. VAUGHN: Thank you, Mr. Cline.
- 19 Any further discussion?
- MR. WITKOWSKI: Well, again, I think we've got
- 21 to move forward with the vote until we have otherwise
- 22 information that says, you know, that the city and the
- 23 state can come forward and say the process is -- I guess
- 24 the bigger question is: Do we even have a say in the
- 25 process? Do we? I don't know if we even have a say in

- 1 the process. Do we?
- 2 MR. CLINE: As part of our charge, we routinely
- 3 look at resolutions adopted by the City Council at a
- 4 regular meeting and, as was done already in this meeting,
- 5 you vote to approve or deny those or whatever action
- 6 you're going to take.
- 7 This vote was taken and passed as a regular
- 8 routine vote of the City Commission meeting, which would
- 9 be on a review normally based on our own schedule, not
- 10 by any requirement, but just for the convenience of
- 11 scheduling or organizing the RTAB meetings. That will
- 12 happen at the August meeting.
- MR. WITKOWSKI: Why was it brought to us today?
- MR. CLINE: Because there was some concern about
- whether or not if the RTAB needed to specifically approve
- 16 this appointment, whether or not there would be some
- 17 concerns raised over the extra delay of the month until
- 18 the end of August when our August meeting occurs and,
- 19 you know, it's been done on other RTABs, it's been done
- 20 with this RTAB, you know, bringing that issue forward to
- 21 eliminate that time lag and, once that recommendation was
- 22 made, it's been subsequent to that that some of these
- 23 other concerns have been raised, but the issue was still
- 24 left on the agenda.
- 25 So my own opinion is that it is unclear

- 1 specifically if we have to make any type of determination
- 2 on this particular appointment. I think what we were --
- 3 MR. WITKOWSKI: I guess then the question I go
- 4 back to, you brought up, who seats the new commissioner,
- 5 whether it's Mary Donald -- is that the name?
- 6 MR. VAUGHN: Correct.
- 7 MR. WITKOWSKI: Mary Donald. Who makes that
- 8 choice? My understanding is RTABs aren't in that
- 9 business.
- 10 MR. CLINE: Well, the RTAB --
- 11 MR. WITKOWSKI: That's a city function and
- 12 that's the whole purpose of --
- MR. CLINE: If you eliminate the RTAB from the
- 14 equation, it would be the business of the City Commission
- and still is the business of the City Commission, but we
- 16 have this RTAB layer that's been placed on that. In the
- 17 final EM order, plus some other -- you know, when you look
- 18 at the law, the order that the governor issued, the final
- 19 EM order gives us some authority over reviewing decisions
- 20 made by the City Council and approving those, and this is
- 21 the process that, you know, that we're following.
- I think it becomes a little unclear because
- 23 I don't think that was -- you know, that may have been
- 24 envisioned for appointments to boards and commissions.
- 25 I don't necessarily think that it was thought of what

- 1 would happen in the event of a City Commission
- 2 appointment. So I think we're -- for lack of a better
- 3 term, I think we're in a little bit of a grey area.
- 4 MR. VAUGHN: Thank you, Mr. Cline.
- 5 The RTAB scope is a little broader than just the
- 6 financial. We do a little bit more than just financial.
- 7 MR. CLINE: We are to look at operations as
- 8 well, yes.
- 9 MR. WITKOWSKI: Well, I just get concerned --
- 10 obviously there's concern the process is flawed. I get
- 11 concerned about: Are we looking into something that we
- 12 have no business looking into? Because if we do it for
- 13 this, we're going to be asked to do it for everything
- 14 else, and that's where the concern -- you know, I don't
- 15 want us to be the jury and trial, you know, judge of
- 16 issues that I believe our City Commission should -- now,
- 17 if the process has been flawed and there's evidence of it
- 18 and the state and city attorney say that that has been
- 19 jeopardized, then I think we'd have to get involved.
- 20 I'm really having a hard time -- I don't want to
- 21 overreach our power and do something that we really don't
- 22 have the authority for, number one, and, number two, we
- 23 could set a precedence that we're going to be involved
- 24 with every --
- MR. CLINE: I don't believe that it would

- 1 necessarily set a precedence. In terms of -- currently,
- 2 there's three RTABs in the state and, as far as the scope
- 3 of what they review and how they go about it, I would
- 4 place this one firmly in the middle, that the scope of
- 5 what the RTAB reviews is not as expansive here in Benton
- 6 Harbor as it is in other locations.
- 7 So I think really, you know, this occurs to me
- 8 because procedurally even if you did move forward with
- 9 affirmation, you know, let's say some -- and this is just
- 10 a hypothetical for the sake of argument. Let's say some
- 11 issue did come to light, that affirmation can always be
- 12 reconsidered at a subsequent meeting, but if you do
- 13 nothing today, when you review the resolutions adopted
- 14 at -- I don't recall what meeting this was; coming
- 15 forward, what the specific date was, but that will just
- 16 fall into the mix of all, be under resolutions adopted
- 17 that night by the City Commission anyway. So whether
- 18 directly or indirectly, there will be some sort of vote
- 19 that encompasses this resolution, either today or next
- 20 month.
- 21 MR. VAUGHN: Our options are to approve, deny or
- 22 table this item.
- MR. CLINE: I would not -- Mr. Chairman, I would
- 24 not -- while denial is certainly an option, I wouldn't
- 25 necessarily recommend that.

- 1 I would recommend approval and we move on and
- 2 if other issues come up, then those can always be
- 3 reconsidered or you just postpone it and it goes back
- 4 into the mix for the next meeting and then if anything
- 5 comes to light between now and then, we'll review it and,
- 6 if not, then it will be just be part of the regular
- 7 meeting agenda.
- 8 MR. VAUGHN: Thank you, Mr. Cline.
- Those are the three options available.
- 10 MS. HUNT: I guess with me for the approval,
- 11 are we saying we're approving that Mrs. Mary Donald is
- 12 seated with a six to two vote and we look at the process?
- 13 What does the approval mean?
- MR. CLINE: I would just simply recommend that
- 15 we're affirming that they took this vote and that was the
- 16 outcome of the vote, and then our role -- see, the whole
- 17 basis for our recommendation was to not raise questions as
- 18 to what our role in the process was or when our timing was
- 19 going to -- we were trying to, out of deference to the
- 20 city, make this as seamless for them as possible and just
- 21 sort of eliminate the question of, does the RTAB have to
- 22 approve this by just saying, you know, by just moving --
- 23 recommending it and moving forward, you know, on the basis
- 24 that there's no questions about the vote that they took or
- 25 the outcome.

- So, you know, were I to make the motion, I would
- 2 just say, you know, something along the lines that, you
- 3 know, you're recommending to approve the vote taken at the
- 4 City Commission that appoints Mary Donald as a city
- 5 commissioner to fill the existing vacancy and leave it at
- 6 that.
- 7 MR. VAUGHN: Thank you, Mr. Cline.
- 8 Our approval will eliminate the question of
- 9 whether the RTAB has approved or denied it, so I think it
- 10 kind of takes us out of the way and then the city can
- 11 concentrate on what they need to do, if we so choose to
- 12 approve.
- MR. WITKOWSKI: And then it would be up to the
- 14 city to look at the process?
- MR. CLINE: Right. In my opinion, the city then
- 16 would be able to review this internally and if there's no
- 17 issue, then there's no issue, and if there is an issue,
- 18 then, you know, say the city attorney makes some sort of
- 19 recommendation, it would be up to the city to act on that
- 20 recommendation and then we would respond accordingly.
- 21 Because until we get some sort of action coming
- 22 from the city to this board, we can't sort of take
- 23 preemptive action. So really anything moving beyond this
- 24 point is really up to the city before we can even get
- 25 involved as an RTAB Board.

- 1 MR. VAUGHN: Thank you, Mr. Cline.
- 2 MR. SEATS: But she has a vote then.
- MR. VAUGHN: No, no, no. We're not taking
- 4 any --
- 5 MR. SEATS: Oh, I'm sorry.
- 6 MR. VAUGHN: The question before the TAB is
- 7 whether we're going to approve, deny or table this motion.
- MR. WITKOWSKI: Well, let's go back before I
- 9 make a motion.
- I think we have to remember that the existence
- of this board is a reactive board. That is the key for
- 12 the most part. It's not a proactive board, which some
- 13 people like on some issues and some people don't like on
- 14 some issues. I think reactive is basically a six to two
- 15 vote. Now, my feeling is if there's evidence otherwise,
- 16 that would go through the city attorney and then brought
- 17 to the TAB Board; then the board can react.
- Does that make sense?
- 19 The board can't preempt -- stop me if I'm wrong.
- 20 We can't stop the city from doing a process. Everything
- 21 has to be reactive. We can only react to the decisions
- 22 that you make. Right now, the decision is six-two. The
- 23 process is part of what led you to the decision. If there
- 24 was a flaw in the process, then I think the city attorney
- 25 has to bring it to you as the manager, to the board to

- 1 say, "I don't think our City Commission followed the
- 2 process."
- 3 I'm not saying you're wrong, but I think we have
- 4 to set up procedures here to protect the city and protect
- 5 this board from getting into areas that I think are
- 6 definitely a grey area, as was described. We're squarely
- 7 in the middle, and so I think from that, I want us maybe
- 8 to go back to what our charge is as being reactive, you
- 9 know, no different than when the commission decided not to
- 10 vote on the four cars. Some people said, "Well, push the
- 11 board to vote." No. That's up to the board to decide.
- That's just me personally. I am only speaking
- 13 for me, not the board, and it doesn't change how you feel.
- 14 I'm not trying to change that. I'm trying to explain what
- 15 I think the role of this board is, which is different than
- 16 having EM, which is very proactive.
- Does that make sense? No?
- MR. VAUGHN: Our charge is to pass a motion on
- 19 this.
- Do I hear a motion on this item?
- 21 MR. WITKOWSKI: I'll make a motion to approve
- 22 it.
- MR. VAUGHN: Is there a second?
- MS. HUNT: I second it.
- MR. VAUGHN: There's a motion to approve the

- 1 appointment of Mary Donald to the city commission to
- 2 fill the existing commission vacancy.
- 3 All those in favor, say aye.
- 4 MR. WITKOWSKI: Aye.
- 5 MS. HUNT: Aye.
- 6 MR. VAUGHN: All those opposed, say no.
- 7 Motion passed.
- MR. WITKOWSKI: And I guess so we don't get put
- 9 in the middle, Eric, is that something that the state
- 10 could look at, do we get involved in processes?
- MR. CLINE: Well, I believe we do have a role in
- 12 that involvement. I think --
- MR. WITKOWSKI: What level do we make the choice
- 14 if the process was flawed or not?
- MR. CLINE: Well, I think that's actually an
- 16 internal determination --
- 17 MR. WITKOWSKI: Okay.
- MR. CLINE: -- based on -- I mean that internal
- 19 determination, it first has to be made by the city because
- 20 really, again, what I believe it goes back to is: Did
- 21 following -- and I know this is going to sound like I'm
- 22 splitting hairs, but they adopted a process to screen
- 23 these candidates. There are questions as to whether that
- 24 process was followed perfectly or not. But then did that
- 25 in any way invalidate the vote that was taken to make that

- 1 appointment? And I think that's really what the --
- 2 MR. WITKOWSKI: I agree.
- 3 MR. CLINE: -- what it hinges on is: Is the
- 4 vote itself made by the commission, regardless of how many
- 5 yeas or mays were there, is the vote itself invalid for
- 6 some reason?
- 7 MR. WITKOWSKI: That makes sense.
- MR. CLINE: And, again, what we were attempting
- 9 to do here at this level was to remove ourselves, given
- 10 the timing of when that selection was made and when our
- 11 next meeting would be was to eliminate that as a potential
- 12 issue and avoid the necessity of perhaps requiring a
- 13 special meeting of the RTAB just for that one issue.
- 14 So, again, this process I think, trying to
- 15 address all these issues ahead of time as best we can,
- 16 but there are still some things that get a little
- 17 cumbersome.
- MR. VAUGHN: Thank you, Mr. Cline.
- 19 That item is closed.
- We are moving on to the nonaction items. The
- 21 monthly financial report for June 2014. I just want to
- 22 note that the budget to actual is dated June 2013. I
- 23 believe it should be dated June 2014 on that report,
- 24 June 30, 2014.
- The next item is the city manager update.

- 1 Mr. Watson.
- 2 MR. WATSON: Just a couple quick things.
- I know that the -- I've had conversations with
- 4 the state revolving around the conservancy, and just to
- 5 let the board know and those that are here, yesterday,
- 6 the conservancy took a bus tour of all the parks because
- 7 when we started the conservancy, there was a lot of
- 8 energy, a lot of enthusiasm; that kind of waned, and then
- 9 we had the resignation of the then-seated chairman.
- 10 There's been a newly-elected chairman and she wanted to
- 11 make sure everybody knew what we were talking about when
- 12 we talk about the parks and just actually see them for
- 13 themselves.
- 14 As it relates to the discussion that just
- 15 preceded, once that conversation started about that there
- 16 was issues here, I started a conversation with the city
- 17 attorney. So that's in process and we're discussing it.
- 18 He hasn't issued any statement, any recommendation one way
- 19 or the other because he's looking at all the information.
- MR. WITKOWSKI: Okay.
- MR. WATSON: So at any time when that
- 22 recommendation does come forth, whatever it is, it will be
- 23 conveyed to the City Commission, thus to the RTAB and then
- 24 also I will give updates to the state as necessary on that
- 25 process.

Page 38 So those are the couple of things I have right 1 2 now. 3 MR. VAUGHN: Okay. Thank you, Mr. Watson. The next item on the agenda is public comment. 4 5 I will call your name on the list. 6 (Brief pause.) MR. CLINE: Mr. Chairman, there's an individual 7 8 here that just walked into the meeting that wasn't 9 aware --10 MR. VAUGHN: I'll make an exception. 11 (Brief pause.) 12 MR. VAUGHN: David Singh, please step to the 13 podium. You have two minutes on the clock. 14 MR. SINGH: My name is David Singh and I have a store on Broadway and Pipestone and last week I read in 15 fore open on another the newspaper there's another st 16 17 corner, Pipestone and Jefferson, and there's no difference 18 between two stores, very near and the City of Benton 19 Harbor, I think no need to open another store, liquor 20 store, very small city and they have too many stores 21 already along here. If you walk just a couple of steps, you see another store, every corner, beer sale, cigarette 22 23 sale, and I think this city needs (indiscernible) schools and I request the city please stop open stores because 24 25 that hurts us, too.

- 1 My family runs the store and we pay tax for
- 2 last 10, 15 years to Benton Harbor every year two times,
- 3 summer tax and a winter tax we pay, and we just obey all
- 4 for the long time we live here, and I would request if
- 5 you open a new store, that's really, really bad for our
- 6 community. I think me myself (indiscernible) my
- 7 neighborhood people, nobody want the store open.
- If the store is (indiscernible) far from a
- 9 couple blocks, that's okay, but this all (indiscernible)
- 10 just walk a couple of steps. If you walk a couple steps
- 11 from my store on Pipestone, you'll see there's too many
- 12 stores in the city, with city having no jobs, no job
- 13 opportunities and already (indiscernible) and
- 14 (indiscernible) taxes (indiscernible) insurance.
- That's it. That's what I wanted for my request.
- 16 So please don't open liquor stores, beer stores no more.
- 17 We don't need them. Thank you.
- MR. VAUGHN: Thank you.
- Miss Huddleston, please.
- 20 MS. HUDDLESTON: Hi. I'm Peggy Huddleston.
- 21 I've been gone for a while, but I wanted to come and see
- 22 what your jobs were over the commissioners because I've
- 23 never seen it before.
- 24 And I also have a complaint about the streets
- 25 and then the storm. When I came back, there were limbs

- 1 everywhere. So I came and asked Mr. -- the manager, the
- 2 city manager. He said the meeting was going to be in
- 3 August. So I found out it was going today, so I came
- 4 running down here so I could find out about when there's
- 5 a storm and limbs laying all over Benton Harbor, who
- 6 is -- if this board is responsible for it, seems like
- 7 they would set up something for someone to go around and
- 8 get them because they were everywhere.
- 9 MR. WITKOWSKI: That would be up to the City
- 10 Commission. That's not our board.
- MS. HUDDLESTON: Okay. Then Monday they was
- 12 laying asphalt. Next door to me -- I live on 1068 Colfax.
- 13 The house across the street was torn down where the city
- 14 went and dug up to turn the water off, and I asked the
- 15 guys could they fill that hole in right there with asphalt
- 16 because the cars and the mailman, when he runs down, he's
- 17 bringing all the dirt down the street and it gets in front
- 18 of the house. They said, well, next year they're going to
- 19 tear the street up and put a new street down. Well, I
- 20 need it done now. There's too much dirt in front of my
- 21 house. I don't like that dirt.
- 22 MR. WITKOWSKI: You have to talk to the
- 23 commission.
- MS. HUDDLESTON: Okay.
- 25 MR. WITKOWSKI: Sorry.

- 1 MS. HUDDLESTON: I didn't know who to talk to.
- 2 MR. WITKOWSKI: She's right there.
- 3 MS. HUDDLESTON: Yeah, okay. I didn't know
- 4 because there's two boards.
- 5 MR. VAUGHN: We'll address your comments during
- 6 the board comment.
- 7 MS. HUDDLESTON: Okay. But anyway, I was really
- 8 concerned about the storm because it -- I put a limb in
- 9 front of the yard and they never came and got it, and I
- 10 wanted to know who was responsible for picking them up,
- 11 so he said the people that pick the trash up come back and
- 12 get the limbs. Well, I know you supposed to tie them up
- 13 and put them there, but this is just one limb, so I took
- 14 it and cut it down and put it in a bag, but --
- MR. VAUGHN: Thank you, Miss Huddleston.
- MS. HUDDLESTON: Okay.
- 17 MR. VAUGHN: Willie Dortch.
- 18 MR. DORTCH: Willie Dortch. I won't be very
- 19 long. I've been dealing with the City of Benton Harbor
- 20 for the last 10 years, motorcycle club. The only reason
- 21 I'm here is because Willie Locke told me to come down here
- 22 and talk to you all, and the problem is I went through all
- 23 the process I was supposed to go through, I went through
- 24 public safety and I'm having hours of operation out of the
- 25 chief of police and Darwin Watson.

- 1 Darwin Watson was not in the last public safety
- 2 meeting I was in, and the public safety approved for me to
- 3 go ahead and operate my place as long as I keep them
- 4 abreast of what's going on and so we started operating.
- 5 (Indiscernible) I didn't have no problem operating during
- 6 the hours. After he left, then everybody put a stop to
- 7 it.
- 8 So I didn't know -- I looked in the paper and
- 9 it said the board was about financial. Then it came out
- 10 again that you had to approve everything they do. So
- 11 that's why I never came here.
- So I went to the City Commission, at least the
- 13 public safety and the public safety (indiscernible)
- 14 approval. By me not being a bar, a club, a nightclub, we
- don't sell alcohol, we don't allow anyone to sell alcohol,
- 16 we don't allow anyone to give it away and we do not
- 17 violate any curfews and so they approved for me to go on
- 18 and operate.
- But after that, I got stopped again. I got
- 20 stopped again back in I guess October I guess, November,
- 21 something like that, but it took me all this time to
- 22 figure out what was going on and who I talk to.
- I thought that if public safety approved
- 24 something, it was all right unless you all had a problem
- 25 with it. We do a lot of stuff for the City of Benton

- 1 Harbor. Salvation Army called me and all this stuff we
- 2 do for them. We're not operating like we should, you
- 3 know --
- 4 MR. VAUGHN: Thank you, Mr. Dortch.
- 5 Miss Hull, please.
- 6 MS. HULL: My name is Emma Hull. I live at
- 7 617 Pipestone Street.
- 8 Based upon what Miss Huddleston was talking
- 9 about and you said, Mr. Witkowski, that it goes through
- 10 the commissioner and the city manager, but I need to know
- 11 what is the turnaround time when you make a complaint,
- when you call; if we need more people to work because
- 13 every time we call about services that we need in the
- 14 city, then they say we only have one worker, two workers.
- Who is in charge of okaying -- you say you're
- 16 reactive and not proactive. Who is in charge if they need
- 17 workers to give us better service so that these things
- 18 can't happen, trees, limbs, streets, holes in the streets?
- 19 And where do we go? And what is the turnaround time when
- 20 we do make a complaint? And when they send it to you, can
- 21 we get an answer, yes, no or maybe or do we have to wait.
- Because we need to have some answers about the
- 23 process of how this works with the state, because we call
- 24 the city manager, maybe there's a time we get no answers;
- 25 if we talk to the commission, they say if there's a

- 1 finance to it, then the state has to do it, but you say
- 2 you're reactive.
- 3 So we need to know -- I think you explained some
- 4 of it, Mr. Witkowski, but we need to know as citizens just
- 5 how this works, what service we can get and what's the
- 6 turnaround time to get some answers about questions that
- 7 we need for the services that we need to be expecting as
- 8 citizens that live in the City of Benton Harbor.
- 9 Thank you.
- 10 MR. VAUGHN: Thank you, Miss Hull.
- 11 Commissioner Adams, would you like to speak?
- MS. ADAMS: Yes. Again, my name is Commissioner
- 13 Mary Alice Adams, City of Benton Harbor.
- 14 I'd like to just address the financial portion
- 15 of the conservancy. I don't know if it has or will come
- 16 back across you all desk, but the reason that the City of
- 17 Benton Harbor went into this partnership with a
- 18 conservancy was solely for the form of saving Benton
- 19 Harbor city (indiscernible) money that we could no longer
- 20 afford to pay the insurance and, to date, I think that we
- 21 still are, and it needs to stop.
- Thank you.
- MR. VAUGHN: Thank you, commissioner.
- The next item on the list is board comment, and
- 25 I will be giving the board comment.

- 1 I'll try to explain what the RTAB does and does

- The RTAB, as many of you have referred to today,
- 4 is a reactionary board.
- If you need any services from your city, whether
- 6 that be limbs or trees or paving or whether liquor stores
- 7 or grocery stores are going in, whatever you have with the
- 8 city has to originate with the city. All of the
- 9 complaints, all of the requests, all of your activity
- 10 should originate with the City Commission.
- Once they act on something, then it comes to us
- 12 for our approval or denial. If they don't act on it, then
- 13 it never gets to us. We cannot and will not proactively
- 14 go out and initiate an activity outside the scope of
- 15 whether the City Commission has already acted. So if they
- 16 do not act, we will not act. So you must start with the
- 17 City Commission.
- 18 It's just exactly like before the EM came and
- 19 the RTAB came; you went to the City Commission. It's
- 20 still like that. You still must go to the City
- 21 Commission. The only difference is there's another layer
- 22 after that. After they initiate something, then we
- 23 respond to it. So we cannot and we will not help you if
- 24 the City Commission hasn't taken an action. It's outside
- 25 our scope of authority.
