CHAIRPERSON: Good afternoon. 4 It's 1:00 p.m., and I'll call the City of Pontiac 5 Receivership Transition Advisory Board meeting to 6 order. 7 Mr. Cline, roll call, please. 8 MR. CLINE: Yes. Edward Koryzno? 9 MR. CHAIRPERSON: Here. 10 MR. CLINE: Robert Burgess? 11 MEMBER BURGESS: Here. MR. CLINE: Louis Schimmel? 12 13 MEMBER SCHIMMEL: Here. 14 MR. CLINE: All right. Mr. Sawdon is 15 excused from this meeting, but we do have a quorum. 16 MR. CHAIRPERSON: All right. Thank 17 you. I'd like to remind the public that if you 18 intend to speak at audience participation, that 19 there's a sheet, a sign-in sheet at the table, and 20 to have you please sign in. If you do not sign in, 21 you will not be recognized during that portion of 22 the meeting. 23 Next item is approval of the agenda. 24 MEMBER SCHIMMEL: I'll move for 25 approval.

1	MEMBER BURGESS: Support.
2	MR. CHAIRPERSON: Moved and supported
3	to approve the agenda. Any discussion?
4	Seeing none, all in favor of the
5	motion say "Aye."
6	BOARD MEMBERS: Aye.
7	MR. CHAIRPERSON: Opposed, same sign.
8	The agenda is approved as printed.
9	Next item is approval of minutes, the
10	regular meeting March 18, 2015 RTAB meeting with
11	noted clarifications.
12	MEMBER BURGESS: I'll make that
13	motion.
14	MEMBER SCHIMMEL: I'll second it.
15	MR. CHAIRPERSON: Moved and supported
16	to approve the minutes with the noted
17	clarifications. Any discussion? All in favor of
18	the motion say "Aye."
19	BOARD MEMBERS: Aye.
20	MR. CHAIRPERSON: Opposed, same sign.
21	The minutes are approved.
22	Old business. The annual evaluation.
23	Mr. Cline?
24	MR. CLINE: Yes. I'm going to draw
25	the Board's attention that you have received a draft

1	report from my office regarding the City's annual
2	evaluation that was conducted by a member of our
3	staff, with myself participating, and we met on
4	March the 18th with both the Mayor and the City
5	Administrator. I think that the meeting went very
6	well. I think that, you know, it was a very
7	positive meeting. It is worth noting that even
8	after a couple of starts and stops on this process,
9	that I think the delay actually worked to the
10	advantage of helping to improve the process, because
11	evaluation of this City was really the first
12	constructive opportunity to do an evaluation of the
13	community that has been under the oversight of a
14	transition board. And I think that went very well.
15	You have the draft report. I would
16	like the Board to have an opportunity to review it
17	before you consider it for approval. Have gotten a
18	couple of comments of, you know, minor grammatical
19	things and stuff to tweak, but I'd like you to have
20	an opportunity to review it, see if you have any
21	other feedback, or anything you'd like to add to the
22	report. And then when you believe that it's ready,
23	we will present it back for consideration. And at
24	that point, as is outlined in the process, the City
25	will get an official approved copy, as well as the

Governor's office and the State Senator and State 1 Representative for Pontiac, so their offices will, 2 3 as well. MR. CHAIRPERSON: Very good. 4 5 MR. CLINE: So at this point this is informational, but I appreciate any feedback that 6 7 you have. 8 MR. CHAIRPERSON: And I'd like to 9 propose to the Board members that we place this on 10 for the next month's meeting for formal approval by 11 the Board. 12 MEMBER BURGESS: We would agree. 13 MR. CHAIRPERSON: Very good. Move on 14 to new business, approval of resolutions and 15 ordinances for City Council meetings, the March 12, 16 2015 regular meeting. 17 Mr. Cline, can you provide some 18 background? 19 MR. CLINE: Yes. Most of the items in 20 this meeting are pretty -- you know, pretty 21 standard. One of the items, which is Resolution 22 15-59, the City Council adopted a resolution requesting an order to -- or an amendment to an EM 23 24 order that would permit unobstructed after hours 25 access to City Hall for members of the City Council.

1 The City Administrator has recommended 2 that this resolution be denied. In the information 3 that we received, I saw no real justification 4 exactly as to why this issue has come up at this 5 point, or any of the problems there were. 6 So barring that, we have a 7 recommendation from the City Administrator to deny 8 that; and if it's the Board's desire to do so, then 9 you can approve all resolutions with the exception 10 of Resolution 15-59, which you could address in a 11 separate motion. 12 MEMBER SCHIMMEL: I'll move as stated. 13 MR. CHAIRPERSON: Second? 14 MEMBER BURGESS: Second. 15 MR. CHAIRPERSON: Been moved and 16 supported to approve all ordinances and resolutions from the March 12th, 2015 City Council meeting with 17 the exception of Resolution 15-59. Discussion? 18 19 MEMBER BURGESS: Yes, I have some 20 questions about this ordinance. MR. CHAIRPERSON: Mr. Sobota? 21 2.2 MEMBER BURGESS: Do we have a 23 procedure now for elected officials to get into the 24 building? 25 MR. SOBOTA: Yes, we always have had a

1 procedure for the elected officials to gain access 2 to the building. 3 For security reasons, they have been 4 asked to go to the Sheriff's Office, essentially 5 sign in so the Sheriff's Office knows that someone is in the building, and then they're given an access 6 7 card and they're able to access the facility. And 8 then when they're done, they have to return the access card to the Sheriff's Office so they know 9 10 that no one is no longer in the building. So it's 11 for security purposes. 12 MEMBER BURGESS: That does not satisfy 13 their need? 14 MR. SOBOTA: No. They want to obtain 15 24/7 access to City Hall without requesting permission or notifying anyone that they are in the 16 17 building. 18 MEMBER BURGESS: That could be a 19 little dangerous. 20 MR. SOBOTA: We had security issues 21 when Mr. Schimmel issued the order. Improvements 22 have been made, and we've discovered we have other 23 security issues that we're hoping to address 24 relatively soon. Whether or not it would be wise 25 for anyone to have 24/7 access to the building,

1 other than those limited in the order, we'll 2 evaluate it at that time. 3 MEMBER BURGESS: I quess I'm not 4 opposed to having 24/7. I am opposed to someone 5 being in the building with no one else here and they 6 get ill or what have you. But, okay. Thank you. 7 MR. CHAIRPERSON: All right. Any further questions for Mr. Sobota? 8 Seeing none, all 9 in favor of the motion say "Aye." 10 BOARD MEMBERS: Aye. 11 MR. CHAIRPERSON: Opposed, same sign. 12 The resolutions from the March 12th, 2015 meeting 13 are approved with the exception of Resolution 15-59. 14 Item 2 --15 MR. CLINE: Excuse me, Mr. Chairman. MR. CHAIRPERSON: 16 Yes? 17 MR. CLINE: Do you want to, as you've 18 done in the past, adopt a motion specifically 19 addressing what you want to do with 15-59? 20 MR. CHAIRPERSON: Yes. That was the 21 next step. Thank you. 22 MR. CLINE: All right. MR. CHAIRPERSON: Now I'll entertain a 23 24 motion to consider Resolution 15-59 either approved, 25 denied or postponed.

1 MEMBER BURGESS: I move that we 2 postpone. 3 MEMBER SCHIMMEL: Support. 4 MR. CHAIRPERSON: It's been moved and 5 supported to postpone consideration of Resolution 15-59. Discussion? Seeing none, all in favor of 6 7 the motion say "Aye." 8 BOARD MEMBERS: Aye. 9 MR. CHAIRPERSON: Opposed, same sign. 10 Resolution 15-59 is postponed. 11 Item 2, March 19, 2015 regular City 12 Council meeting. Entertain a motion. 13 MEMBER BURGESS: I'll make that 14 motion. 15 MEMBER SCHIMMEL: Support. MR. CHAIRPERSON: And the motion is 16 17 to? 18 MEMBER BURGESS: Approve. 19 MR. CHAIRPERSON: Okay. Thank you. 20 It's been moved and supported to approve the regular 21 meeting minutes of March 19th, 2015. Discussion? 22 Seeing none, all in favor of the motion say "Aye." 23 BOARD MEMBERS: Aye. 24 MR. CHAIRPERSON: Opposed, same sign. 25 March 19th minutes are approved.

1	The March 26, 2015 regular City
2	Council meeting minutes. I'll entertain a motion.
3	MEMBER BURGESS: I'll make that motion
4	to approve.
5	MEMBER SCHIMMEL: Support it.
6	MR. CHAIRPERSON: It's been moved and
7	supported to approve the minutes. Discussion?
8	Seeing none, all in favor of the motion say "Aye."
9	BOARD MEMBERS: Aye.
0	MR. CHAIRPERSON: Opposed, same sign.
1	The minutes are approved.
2	Item 4, the April 2nd, 2015 City
3	Council meeting minutes. Mr. Cline, could you
4	provide some background on this issue, please.
5	MR. CLINE: Yes. One resolution that
6	I'd draw your attention to is Resolution 15-91,
7	which deals with the rates charged at the Senior
8	Center. If you recall, a couple months ago the
9	Mayor came before us, the City Council had offered a
0	resolution to lower the rates, as I recall, and the
1	Mayor had asked that we delay action on that to give
2	her an opportunity to have some further discussion
3	with the City Council on this matter.
4	I know that there has been some lack
5	of discussion, for whatever reason, between the

Mayor and the City Administrator and the City 1 2 Council on this particular issue. 3 At this particular meeting, the City 4 Administrator provided a report to Council that he 5 wished to present on the Senior Center rates and 6 that Council postponed hearing that report 7 indefinitely, which effectively killed that item. 8 I think the Board, given that, may 9 have been requested to take no action on this. You 10 know, you have the option of denying that specific 11 resolution and then still allow an opportunity 12 for further conversation at the City Council level 13 to occur on this matter. 14 MEMBER SCHIMMEL: Okay. I'll move --15 MR. CHAIRPERSON: Mr. Sobota? 16 MR. SOBOTA: Mr. Chairman, technically 17 at this point in time, the resolution to postpone 18 indefinitely which will definitely kill the 19 resolution, would be proper to approve, as Council 20 will no longer be considering that particular 21 resolution. 22 There is a new resolution pending 23 before the City Council at tomorrow's meeting that 24 is different than the one that was considered back 25 in March.

MR. CHAIRPERSON: 1 Now you. 2 MEMBER SCHIMMEL: So based on that, I 3 guess I'll make a motion to --4 MR. CHAIRPERSON: Hold on. Do you 5 have a question, Mr. Burgess? 6 MEMBER BURGESS: No. 7 MR. CHAIRPERSON: Okay. All right. 8 I'm sorry. 9 MEMBER SCHIMMEL: To approve all of 10 the meeting except for Resolution 15-91. 11 MEMBER BURGESS: Second. 12 MR. CHAIRPERSON: It's been moved and 13 supported to approve all resolutions from the 14 April 2nd Council meeting with the exception of Resolution 15-91. Any further discussion? All in 15 16 favor of the motion say "Aye." 17 BOARD MEMBERS: Aye. 18 MR. CHAIRPERSON: Opposed, same sign. 19 The motion is approved. Now we'll consider 20 Resolution 15-91. 21 MEMBER SCHIMMEL: What is the Mayor 22 and the City Administrator asking us to do regarding 23 this? 24 MR. SOBOTA: The resolution that was 25 presented in March was more comprehensive than what

1 Council was looking for. So they will not consider 2 this resolution. The Mayor has presented a new, 3 more narrower resolution to be considered tomorrow. 4 We were trying to address all of the issues with the 5 Senior Center. Council wants to concentrate only on 6 one issue. 7 So that is what the Mayor has 8 presented for consideration for tomorrow. My guess 9 is, this whole issue is going to come up again when 10 we do our fee schedule revision in June. 11 MEMBER SCHIMMEL: So, Mayor, should we 12 just postpone this? 13 MAYOR WATERMAN: Yes, I agree with 14 that statement. 15 MEMBER SCHIMMEL: I'll move to 16 postpone. 17 MEMBER BURGESS: I'll second. 18 MR. CHAIRPERSON: It's been moved and 19 supported to postpone Resolution 15-91. Further 20 discussion? Seeing none, all in favor of the motion 21 say "Aye." 22 BOARD MEMBERS: Aye. 23 MR. CHAIRPERSON: Opposed, same sign. 24 Resolution 15-91 is postponed. 25 Item 5, April 9, 2015 regular City

1 Council meeting minutes. Mr. Cline, provide some 2 background, please. 3 We have a couple of MR. CLINE: Yes. 4 different resolutions. Resolution 15-94 (sic) is a 5 resolution that was adopted by Council to consider 6 the adoption of an ordinance amendment for their 7 retirement system that would allow 69 former 8 employees to effectively gain early retirement 9 status. 10 The City attorney has subsequently 11 come out and issued an opinion on this matter after 12 the vote was taken, that basically calls into 13 question that there are a number of reasons not to 14 adopt this at this time. The City Administrator has 15 recommended that the Board, this Board, not adopt that resolution. 16 17 And in speaking with the Finance 18 Director, there are some concerns about the actual 19 financial impact of implementing this. And the 20 Finance Director has some concerns that the level of 21 research into that impact has been limited. And as 22 I stated, the City Administrator has recommended 23 that the Board not approve that resolution. 24 On another matter, there is a 25 Resolution 15-103, which is a report from some

1 consultants from the City, regarding the granting of 2 prior service credit to two former employees, a Mr. 3 Brown and another individual whose name, I'm sorry, eludes me at the moment. 4 5 But, I'm suggesting that the Board 6 consider postponing that, because I don't believe 7 that we have enough information on that to give you a thorough report as to the details of that. 8 And 9 that is Resolution 103. 10 MR. CHAIRPERSON: All right. I will 11 entertain a motion to approve all the ordinances and 12 resolutions from the April 9th meeting with the 13 exception of Resolutions 15-103 and 15-104. 14 MEMBER BURGESS: Second --15 MEMBER SCHIMMEL: I'll move. 16 MEMBER BURGESS: Second. 17 MR. CHAIRPERSON: It's been moved and 18 supported. Any discussion? 19 MR. CLINE: I'm sorry, just for the 20 record, I misspoke and I said it was Resolution 21 15-94, and it was actually 104. 22 MEMBER BURGESS: 104. Okay. 23 MR. CHAIRPERSON: So it's been moved 24 and supported to entertain a motion -- or to approve 25 all ordinances and resolutions from the April 9,

2015 meeting with the exception of Resolutions 1 2 15-103 and 15-104. Further discussion? 3 MEMBER BURGESS: Yes. Madam Mayor, do 4 you have a position on this? 5 MAYOR WATERMAN: I'm sorry, is it 103 6 or 104 we're talking about? 7 MR. CHAIRPERSON: Well, actually, why 8 don't we save that discussion, Mayor. 9 MAYOR WATERMAN: Yes. 10 MR. CHAIRPERSON: We'll approve all of 11 the other resolutions and then have you comment on 12 those. 13 MEMBER BURGESS: Okay. All right. 14 Fine. 15 MR. CHAIRPERSON: Any other questions? Discussion? 16 17 MEMBER BURGESS: No. 18 MR. CHAIRPERSON: Seeing none, all in 19 favor of the motion say "Aye." 20 BOARD MEMBERS: Aye. 21 MR. CHAIRPERSON: Opposed, same sign. 22 The motion is approved. 23 Now consideration of Resolution 24 15-103, the report from Rodwan. 25 MEMBER BURGESS: Rodwan.

1	MR. CHAIRPERSON: Rodwan. Excuse me.
2	Is that your
3	MEMBER BURGESS: Yes.
4	MR. CHAIRPERSON: Okay. Now, Mayor,
5	you may speak to this issue.
6	MAYOR WATERMAN: That was just a
7	simple calculation of time. And, actually, I don't
8	have that information in front of me, but I have no
9	concerns about that, 103 at the time for your
10	consideration, but I just don't have the specific
11	details for you in front of me. And I think that's
12	what Mr. Cline is saying, that he wanted you to have
13	the specifics. Is that what
14	MR. CLINE: Yes. I don't think the
15	issue is that particular detail, but we just didn't
16	have a good opportunity to really discuss that in
17	detail with the City. So I'm just wish you to
18	consider, you know, postponing it until the next
19	month.
20	MR. CHAIRPERSON: Any other
21	discussion?
22	MEMBER BURGESS: No.
23	MAYOR WATERMAN: And you have that
24	information. I can speak to 104, because that was
25	the matter that was brought to Council.

1 MEMBER SCHIMMEL: Mayor, let's just 2 stay right there. I move that we postpone 103. 3 MAYOR WATERMAN: Okay. MEMBER BURGESS: 4 Second. 5 MR. CHAIRPERSON: It's been moved and 6 supported to postpone consideration of Resolution 7 15-103. Further discussion? Seeing none, all in 8 favor of the motion say "Aye." 9 BOARD MEMBERS: Aye. 10 MR. CHAIRPERSON: Opposed, same sign. 11 Resolution 15-103 is postponed. 12 Now consideration of Resolution 13 15-104, the Early Retirement Ordinance. Mayor? 14 MAYOR WATERMAN: Yes. That is the one that was originally brought by resolution as a first 15 16 reading of the ordinance, and the resolution is the 17 one that you just talked about that granted --18 indicated Council's intention to grant early 19 retirement status to 69 employees. 20 This is a matter that had been 21 previously discussed and had been reviewed by the 22 TAB Board about a year and a half ago, from what I 23 understand. And this resolution, because it was 24 added on at the time of the Council meeting, did not 25 give many of us a chance to -- have a chance to

review the details about it. It had been discussed once at -- in my presence, at a Finance Subcommittee meeting back in October. And I recall from that, that the Finance Director had been advised to do some research about it, and had asked some questions which had never been answered.

After that, there wasn't any formalized discussion, so I thought it was a dead issue, and didn't realize that there was continued discussion on the -- directed to some Council. It was not shared with me, and that it was brought to this Council meeting.

Now, the resolution was passed and that was considered the first reading of this. The following week -- and there was really no time for discussion at that meeting. The following week, Council president did announce at the acceptance of the agenda that this matter would be referred back to Subcommittee for further discussion. I did commend Council for that, because like anything of this import, we wanted to have a chance to look at its ramifications. And certainly I did not have the information that had been shared with maybe some of the other Council members, and I certainly needed that to completely evaluate it. And certainly

1	something of this import not only has an effect on
2	the mediation that we are undertaking right now,
3	which has gone quite a long a long way, and has
4	been extended by Judge Cohn because he feels that
5	we're making some progress. I don't know whether
6	adequate progress, but some progress, because I
7	can't read his mind and what he's thinking. But
8	certainly he has extended the period of mediation
9	beyond the original 60 days that he had allowed. So
10	we're now into several months past that 60 days.
11	And we have, in lieu of getting
12	information, have already undertaken actuarial
13	studies. The City paid for all of the actuarial
14	studies, because the complaining plaintiff has
15	not has the wherewithal to do the studies, and at
16	\$10,000 to \$15,000 a study, this is certainly an
17	expense for the City that I take very seriously.
18	So, those are all things that need to
19	be taken into consideration. But I do want to I
20	think I would invite further discussion at the
21	Subcommittee meeting, and that is going to happen
22	April 28th. And we'll have a chance to hear from
23	the various proponents and have a chance to see if
24	we can approach each of these situations
25	individually, because I understand that there's

differing collective bargaining agreements for some 1 2 of these, and I'm not sure all the 69 people have 3 been notified and want to be part of this. 4 So we're just trying to do some 5 discovery right now. We understand that some people 6 were -- feel appeased by that, but nobody is not 7 going to get what is due to them in terms of their 8 pension. That has been certainly guaranteed by the 9 situation, the pension situation. These are people 10 asking for something in terms of early retirement 11 based upon what maybe a few other people have been granted. 12 13 So that's where we are at right now, and we will continue that discussion April 28th. 14 15 MEMBER BURGESS: Okay. Thank you. 16 MR. CHAIRPERSON: I'll entertain a 17 motion. 18 MEMBER BURGESS: I make that motion to 19 postpone. 20 MR. CHAIRPERSON: Is there support? 21 MEMBER SCHIMMEL: I was going to make 22 a motion to deny, but I will support a postponement. 23 MR. CHAIRPERSON: It's been moved and 24 supported to postpone Resolution 15-104. Any 25 further discussion? Seeing none, all in favor of

1	the motion say "Aye."
2	BOARD MEMBERS: Aye.
3	MR. CHAIRPERSON: Opposed, same sign.
4	Resolution 15-104 is postponed.
5	Next item is the City Administrator
6	items. Item number 1 is Correction to DPW
7	Assistant's Employment Agreement. The City
8	Administrator wishes to amend the employment
9	agreement to address sections regarding paid leave
10	that were inadvertently left off. Mr. Sobota?
11	MR. SOBOTA: I tried to take a
12	shortcut and use the existing agreement when we made
13	him a full-time employee, and I failed to remember
14	and recognize that part-time employees were offered
15	no paid time off, and all hourly full-time employees
16	were. So we wanted to provide the time off that
17	should have been granted, and then allow the
18	gentleman in question to either choose to use it or
19	to have it cashed out before the end of the fiscal
20	year; and funds are available.

to approve the amendment of the employment agreement
for the DPW assistant. Any further discussion?
Seeing none, all in favor of the motion say "Aye."
BOARD MEMBERS: Aye'.
MR. CHAIRPERSON: Opposed, same sign.
The motion is approved.
Item 2, Estate of Jkhary Craft versus
Edward Lasseigne. City Administrator wishes to file
an appeal with the United States Supreme Court
regarding this matter. Mr. Sobota? Did I come
close on the names?
MR. SOBOTA: I think that's as close
as you can come.
This is an alleged complaint where
a juvenile was allegedly killed by a Pontiac Police
Officer. And this is a Federal case. Our attorneys
believe that the Court of Appeals failed to consider
a certain point in law that has recently been
decided at the Federal level. So they feel that by
referring this to the U.S. Supreme Court, we have a
better chance. The amount in controversy exceeds
half a million dollars, and the City is responsible
for the first half a million dollars on this case.
And I believe that the cost to file the appeal is

1	\$5,000. So if you spend \$5,000, you save half a
2	million, I think that's a good investment.
3	MR. CHAIRPERSON: Any questions for
4	Mr. Sobota? I'll entertain a motion.
5	MEMBER SCHIMMEL: I'll move.
6	MEMBER BURGESS: Second.
7	MR. CHAIRPERSON: Moved and supported
8	to approve of an appeal to the United States Supreme
9	Court regarding the Estate of Jkhary Craft v Edward
10	Lasseigne. Any further discussion? Seeing none,
11	all in favor of the motion say "Aye."
12	BOARD MEMBERS: Aye.
13	MR. CHAIRPERSON: Opposed, same sign.
14	The motion is approved.
15	Item 3, Willie Kellem versus City of
16	Pontiac. The City Administrator wishes to reject
17	the proposed settlement and proceed to trial.
18	MR. SOBOTA: We were prepared to
19	proceed to trial back in March, however, just before
20	trial, plaintiff's attorney contacted our counsel
21	and made another settlement offer. Our counsel had
22	a negotiation and was able to bring that down to
23	\$30,000. However, both the City Council and I and
24	the Mayor, in closed session, discussed this
25	strategy, and we believe that the City has a very

good opportunity to prevail at trial. The attorney for the plaintiff has been in practice for a little bit over a year, even though this case has been ongoing. The attorney who had prepared this case is no longer even with the firm.

The allegation is that excessive force was used on the particular individual. We believe, obviously, that excessive force was not used and it was justified.

10 The plaintiff in the case filed -- has 11 no medical bills, and the only thing that we're able 12 to identify is he had a split lip. Our attorney 13 believes that we do have a very good case moving 14 forward, however, his argument has always been, you 15 have 100 percent of settling for \$30,000 than a 16 chance of having a case come and award anywhere 17 between \$7,000 and \$110,000. There is no evidence 18 that any sort of medical awards would be made, since 19 there are no bills, and the only injury, allegedly, 20 was a split lip.

So Council, the Mayor and I, are all in agreement that there are some outstanding cases that are out there where we need to start putting our foot down and saying No, we're not going to settle, because the likelihood of winning is very

good for the City. This is one. We're going to be 1 2 discussing a couple other cases over the next few weeks and months, as well, so you may be seeing 3 4 similar recommendations coming. But we do want to 5 set the bar high, saying that in Pontiac we're no 6 longer going to be paying out. 7 The suspect in this case is a habitual 8 offender, actually, and was actually being chased 9 for attempted murder. The only drawback was that in 10 the case that he was tried for, he was not 11 convicted, for one reason or the other. But his list of witnesses and even his testimony will be 12 13 highly scrutinized by our attorney. 14 MR. CHAIRPERSON: All right. Any 15 questions for Mr. Sobota? I'll entertain a motion. 16 MEMBER SCHIMMEL: I'll move to 17 approve. 18 MEMBER BURGESS: Second. 19 MR. CHAIRPERSON: It has been moved 20 and supported to approve the rejection of the 21 proposed settlement and proceed to trial on the 22 Willie Kellem versus City of Pontiac case. 23 Any further discussion? Seeing none, all in favor of the motion say "Aye." 24 25 BOARD MEMBERS: Aye.

3	Item 4, Comprehensive Compensation
4	Package. Mr. Cline, could you provide
5	MR. CLINE: Yes. This is something
6	that's been discussed periodically over a few
7	months, but the City has proposed a comprehensive
8	plan for employee benefits that they would like to
9	begin to offer. Our office is in the process of
10	reviewing this, and in some additional discussion
11	with the City Administrator, they are comfortable
12	and expected and it would be a suggestion that the
13	Board consider postponing this to allow us further
14	time to review this, so we fully understand what the
15	City is proposing and can better explain all of the
16	possible impact of this to the City. So, we had
17	this information, and it is under review.
18	MR. CHAIRPERSON: All right.
19	MEMBER SCHIMMEL: I'll move to
20	postpone.
21	MR. SOBOTA: If I could, Mr. Chairman,
22	before you do so. If I could sort of put some seeds
23	out there and get a gut reaction so I have an idea
24	of where we may be going over the next month.
25	The comprehensive compensation package

has actually been talked about for probably close to a year around here. We have had employees requesting raises or improvements in benefits. I forgot to include in here that this will require an amendment to an EM order, so all the more reason why this can't be approved today. It will require an amendment to an EM order.

But what we are essentially asking for the employees, is based on the City's current economic situation with the improvement in finances and the general fund, I will say rather significant improvement, the fact that other communities that are in receivership or have been in receivership have not eliminated benefits for their employees, and also that there is some question, and we're debating this internally, as to whether or not the City is compliant with the Affordable Care Act. This has all been brought into account.

What I have done is I have identified comparable communities in the State of Michigan, which happens to be the same communities, the Local Officers Compensation Commission has identified for purposes of compensation for mayor and council, to identify comparable positions across these communities to see what salary ranges are, taking

into consideration what the duties of those positions are compared to Pontiac, because there is a difference, verifying to make sure, and we have confirmed every community offers benefits, health insurance benefits for current employees, and offers some sort of a pension package.

So what the comprehensive compensation package does is two things, primarily. Number one, it would offer health insurance coverage to employees only when they are working for the City. When they retire, they will not be entitled to any health insurance.

Number two, it would create a defined contribution plan with MERS, with an employee match. For every \$2 the employee contributes, the City will deposit \$1 into the DC plan with MERS to a limit of 7 percent.

So those are the two main enhancements that would affect all of the employees who -- except the four, who presently receive benefits.

There are a few minor salary modifications that are made. We have noted that there is one position in particular that is significantly underpaid based on comparables. And we're trying to also make some minor corrections to a few other positions.

So the net impact to the City's financial statements is approximately \$325,000 should everyone accept all benefits. Because if you don't accept health benefits, then you get a cash-out, which is significantly less, and the pension contribution is a match. So if the employee does not contribute, the City does not spend any money. And that is assuming 100 percent of the time of every employee is charged to the general fund, and we know that's not going to be the case, because of charges to the major local and senior funds as well.

So, what I'm sort of looking for is a gut reaction -- I'm hoping I have supplied enough information to the Board so that you can see the thought process. We did talk to the Mayor. Under the final order, I did confer with the Mayor. She had offered some suggestions. I accepted a few, I rejected others. Conferred with Council. Their reaction was no raises, no benefits until they get some staff. So that's been the reaction from Council.

I will say this. Within the last year, we almost lost a very important member of the

1 administration due to another job offer, but that 2 individual chose to stay with the City, realizing 3 that there may be something that we could 4 potentially be doing. And there is another employee 5 that I am aware of, is also seeking employment in 6 another community. And when we have such a small 7 group of employees, and it was evidenced by the fact when we lost our purchasing agent to death a little 8 bit over a year ago, it's very difficult right now 9 10 to attract quality employees when you are not 11 offering at least health insurance benefits. 12 Pension is something that's also assumed. Mayor has 13 had trouble with a deputy mayor. We have had 14 trouble with an income director. We have had trouble finding a purchasing agent. And the job 15 16 environment today is significantly different than it 17 was two, three years ago when these individuals were 18 first identified and brought in through Accountemps. 19 The job market is very tight out there. It's very 20 competitive. And as a city, for us to maintain good 21 quality employees, we need to be able to compensate 22 them accordingly, especially comparing our community 23 to other comparable communities.

So that's my summary and brief argument, and I'm hoping to at least get some sort

24

1 of a reaction as to whether or not I'm barking up 2 the wrong tree or if this will be given serious 3 consideration, or if there's any other gut reaction, especially since the City's financial position has 4 5 changed considerably in the last two years, which Mr. Nazarko will be addressing in his financial 6 7 report. 8 MEMBER SCHIMMEL: You want feedback? 9 MR. SOBOTA: I'd appreciate some. 10 MEMBER SCHIMMEL: Well, I'm certainly 11 on board for what you're doing. I don't need to 12 give a long speech on that. But, I mean, I think 13 the financial position of the City now is to the 14 point where we have to be competitive to get good employees; and we're not going to get good employees 15 16 if we don't have competitive compensation packages. 17 I'm good with what you're doing. 18 MEMBER BURGESS: I will wait until I 19 see the numbers. 20 MR. CHAIRPERSON: And I agree with Mr. 21 Burgess. 22 MR. SOBOTA: Okay. Thank you very 23 much. 24 MR. CHAIRPERSON: All right. So I'll 25 entertain a motion.

20	Mayoral request, Phoenix Center
21	Litigation. The Mayor and the City Administrator
22	wish to file a complaint in Oakland County Circuit
23	Court regarding the liens filed against the City.
24	The Mayor and City Administrator also request
25	approval of a budget of \$50,000 for this action.

2	MR. SOBOTA: Funds are available in
3	our parking fund for this. The owners of Ottawa
4	Towers filed liens two or three liens on the
5	property that encompasses the Phoenix Center,
6	arguing reimbursement for repairs that they made
7	without City permission, and also for attorney fees.
8	Our attorneys strongly argue and agree that those
9	liens are not proper. And in order for us to
10	proceed on the condemnation case, which was the
11	initial case that was filed, which had been
12	dismissed by the Circuit Court, we need to start a
13	new action to have these liens removed from the
14	property, so therefore when we make our good faith
,15	offer, the Circuit Court cannot say that the liens
16	need to be taken into consideration when that good
17	faith offer is made.
18	So this is part of the legal
19	gymnastics that we need to go through in this
20	particular case.
21	MAYOR WATERMAN: I have some
22	additional information that we have had since we
23	sent this up April 19th when these reports were due.
24	April 15th, the Plaintiff, Ottawa
25	Towers, did file a brief on appeal that is a new

1 action on their part, that has to be responded to in 2 21 days. So that means our attorneys have to 3 respond to it by May 6th. So when the money to 4 support the action that Mr. Sobota described, 5 although we already had the \$50,000 there that had 6 been allotted, but now this is a new action that has 7 to be responded to by May 6th. So that will mean 8 that we will use up that allotment and we need 9 another allotment to cover both actions. 10 MR. CHAIRPERSON: Thank you. I'11 11 entertain a motion. 12 MEMBER SCHIMMEL: I'll move for 13 approval. 14 MEMBER BURGESS: Second. 15 MR. CHAIRPERSON: It's been moved and 16 supported to approve filing a complaint in Oakland 17 County Circuit Court regarding the liens filed 18 against the City, and also approving a budget of 19 \$50,000 for this action. 20 Any further discussion? Seeing none, 21 all in favor of the motion say "Aye." 22 BOARD MEMBERS: Aye. 23 MR. CHAIRPERSON: Opposed, same sign. 24 The motion is approved. 25 Item 8, Mayoral Request, Appointments

1 to the Arts Commission. The Mayor is requesting 2 approval of three appointments to the Arts 3 I'll entertain a motion. Commission. 4 MEMBER BURGESS: I move to approve. 5 MEMBER SCHIMMEL: Support. MR. CHAIRPERSON: Been moved and 6 7 supported to approve the appointments. Discussion? 8 All in favor of the motion say "Aye." 9 BOARD MEMBERS: Aye. 10 MR. CHAIRPERSON: Opposed, same sign. 11 Motion is approved. 12 Item 9, Mayoral Request, Appointments 13 to the Public Housing Commission. The Mayor is 14 requesting approval of one appointment to the Public 15 Housing Commission. 16 MEMBER BURGESS: I move to approve. 17 MEMBER SCHIMMEL: Support. 18 MR. 3	Financial Reports monthly for March 2015, and

7	MR. NAZARKO: Members of the Board.
8	The financial reports I presented to the TAB include
9	the monthly required reports by the Board, as well
10	as the quarterly one; and a new addition to the
11	financial reports this quarter is the investment
12	report as of March 31st, 2015. This will be a
13	staple, hopefully, in all future quarters, because
14	we are investing money, as you all know, for the
15	first time we started back in December. Was not
16	enough to report in December quarter, we just
17	started. However, the quarter that ended in March,
18	we added to the investment amounts, and these are
19	not money that are fund balances, all of them
20	or general fund money, I should say, however, these
21	are \$12 million of that that is invested with two
22	financial institutions, represents money that we are
23	managing the cash flow situation and trying to earn
24	interest on the idle amounts that, again, are part
25	of the cash balances or fund balances or part of the

cash flow situation, such as we collect the property taxes, we keep them two weeks and then submit to the jurisdictions. However, we have decided to play quote/unquote with that money, to invest so the City can get some return on that money instead of sitting idle.

Again, we are projecting that this is going to be a significant amount that come into the general fund and other funds as well. For the year, I'm projecting in excess of \$60,000, which again given the fact that we did not earn anything in previous two years, that, to me, is a significant amount. Every little bit helps.

14 The financial statements are as 15 presented to the TAB, represent the situation, 16 financial statements as of March 31st, 2015. However, I'd like to point out that our financial 17 18 situation is trending in the right direction, and 19 mainly because we have managed to keep our 20 expenditures within the approved budget, and we have 21 managed also to bring additional revenues over and 22 above what the budget has -- the budget has been 23 approved for.

The most significant item on the revenue side is the fact that we are bringing more

income tax revenue and we are -- we hope and we'll do our best to keep that pace going. For the fiscal year 2015 ending in June, we are already ahead \$1.8 million compared to the previous fiscal year, the same year for nine months. And for the year-end, I'm projecting that amount to stay at BLS least 1/8 or approach \$2 million.

Therefore, we are projecting that at the end -- now this is probably the first projection that I'm presenting to the TAB, that at the end of the year, our fund balance will be increasing in excess of \$2.5 million. So we will be adding -- we do have the fund balance policy now in place that was approved both by the Council and by the TAB; and not just that, our intention is to maintain and we have recommended to the Mayor and the City Administrator via the budgets, to maintain that fund balance, but to add to it. And, again, it is a healthy situation.

If you look at the statement of cash flow as presented -- cash flow as I presented to you, we are projecting that we've given you more than 15 months now of cash flow, and I'm projecting that at the end of June 2016, we should have more than \$8 million cash flow. Again, doesn't equate

1 fund balance, doesn't equate cash that we can use 2 for other purposes; however, to get -- to go from 3 the point that last year I came before this Board to 4 ask to allow me to borrow from other funds to meet 5 the expenditures, temporarily mind you because we 6 did have a balanced budget, but from that situation 7 now to the situation that we are in, I approached the City Administrator and I asked -- or I 8 9 questioned the usefulness now of the cash flows as 10 presented to the TAB. I will present them to you 11 quarterly, but it will be a healthy situation, in 12 my professional estimate. 13 There are a couple of items that we 14 have been working on. The Mayor and I went to 15 Lansing the other day this week to meet with Mayor 16 Duggan. He had initiated this meeting with the mayors and finance directors of 22 municipalities 17 18 that have income tax. And there is something, just 19 to give you a head's up, coming down the pike that 20 the Mayor of Detroit is pushing for a so-called 21 universal withholding law that will allow 22 municipalities or employers to withhold for 23 employees that are not -- that live -- that work in 24 their jurisdiction, but live in jurisdictions that 25 have income tax, i.e., Mr. Schimmel works in

1	Pontiac, which he doesn't, but lives in Waterford,
2	then Waterford will be able to withhold money for
3	the residents who work in Pontiac, again, that work
4	elsewhere. I believe that the Mayor and I will be
5	talking about that. We have not made any commitment
6	or determination, but just something that is going
7	to come probably before this Board in the future.
8	We did send the delinquent tax roll to
9	Oakland County; however, I would like to bring to
10	the Board's attention that there is a disagreement
11	between us and Oakland County, because as it
12	pertains to a TIFA district. And the unique
13	situation goes like this, in a nutshell. I'm not
14	going to take a lot of time on that, but we have a
15	TIF district number two, right, that was it has
16	two subdistricts, if you want to call it that way.
17	And one was created in 1981, the other one was
18	created in 2000. The one that was created in 1981
19	has a positive capture, and the one that was created
20	in 2000 has a negative capture. Our position is
21	that those two should be computed and captured
22	separately. Oakland County's position has been to
23	connect them together, which is a causes a
24	negative capture, and therefore wanting more money
25	from us, not allowing us to capture. We have

1	escalated that case to the Treasury Department.
2	MR. SOBOTA: Jim Mills.
3	MR. NAZARKO: Jim Mills. I know he is
4	an authority because we have dealt with him before.
5	And also to Oakland County too, because Oakland
6	County does our assessing. And I've asked them
7	questions as to, you know, their opinion.
8	But this may escalate a little bit
9	further, because we believe that our position is
10	right, of course.
11	And the last item, the initial plan
12	that Mr. Cline is asking every Friday, it's still
13	pending, it's still out there. I believe that we
14	did a good job on the second attempt to convince the
15	Treasury Department Local Audit Division not to
16	require us to do in-depth. However, upon that
17	response, which we're waiting any day now, we will
18	take the proper cause of action to rest assured that
19	we are going to be in compliance with the
20	requirement that we within 30 days we respond via
21	in-depth or explanation or not. So we're doing good
22	in that regard.
23	And that concludes my report. Again,
24	the overall picture is positive. We're doing
25	everything we can to keep it going.

1	MR. CHAIRPERSON: Questions?

9	to the opportunity to start with good news, and I
10	will do that today, because there is good news.
11	Earlier this morning there was a
12	meeting of the Bloomfield Park. REDICO is moving
13	along. They're very motivated, and they presented
14	their concept plans, which look most interesting for
15	the community. This is just the first step in the
16	process, but I'm very happy to announce that. But
17	the good thing for Pontiac is not only the economic
18	vitality it will bring, but also the 700 to 900 jobs
19	that are predicted for that development. That is
20	great news.
21	Also, Forman Mills, another 75 jobs.
22	And most of these are Pontiac-hired people, they
23	were brought into this community, I think they're
24	known, and they opened up with a lot of aplomb. So
25	that is another group that's coming to town.

And IRG, which is the group that bought two of the large properties, the GM Research property on Centerpoint Campus, they are announcing -- I think it's pushed back to a little later this week, but they're announcing a new tenant that's coming in and also bringing jobs, and new to this area, back to International.

So those are all good things that says Pontiac is open for business. I don't know that I want to harbor upon this, because I know they want to keep this very much QT until later on in May, but one of our major, major, major employers here in the City is also due to make an announcement. I'm going to just use that as a tease, because I promised not to reveal anything real soon, but more to come on that as well.

17 MR. CHAIRPERSON: Details at 11:00? 18 MAYOR WATERMAN: Details very shortly 19 here. I'm just proud to say that the jobs and the vitality and the growth that brings to this 20 21 community will be phenomenal with those kinds of 22 things. So it does say that the financial practices 23 and things that we're doing in the City have taken 24 out the message that Pontiac is open for business. 25 Now, one of the things that's going to

help us along that pathway too, is I've talked about the economic recovery plan that's going on. Yesterday, we got the draft proposal for that economic recovery plan, and that is going to be very detailed and will be the strategic implementation plan for which we can go out and get other investors interested in Pontiac, foundations and such. They're going to outline a number of priority development areas. And we do have a lot of potential here in Pontiac. One of the things that is key to that, is what we call the Central Area District, the near Downtown District. And it's not just about Phoenix Center, although Phoenix Center is a great part of that.

15 So we know that we need to have a plan 16 for that Central City area. And we have -- we need 17 to get involved with what various support agencies 18 will do for us, including there's something that the 19 MEDC offers, it's called Development Ready City 20 Initiative, and once we get involved in that, we 21 can take advantage of all of the resources and 22 support services they offer, not only for this 23 development, but for other developments, they'll 24 support us in the N3 (ph).

So I'm very interested to get involved

1 in that process. I know Mr. Sobota has a meeting 2 with one of the leaders of that MEDC set shortly. 3 But I hope that's a process we can get involved in, because there's a long list of priority items, a 4 5 long list of opportunities for Pontiac, but we -when they said "Mayor, how are you going to 6 7 implement these things once we come up with this 8 list?" I said, "Well, let's look for ways in which 9 we can get support for this." So that's one of the 10 things I hope to report on later, and we will 11 hopefully have that be one of the ways that we can 12 work toward the development in many areas within the 13 City.

14 We talked about Phoenix Center already 15 and the litigation going on with that. I don't have 16 to go over the court motions that were filed, 17 because we talked about that earlier. There are 18 other ways that are being -- other matters that are 19 being handled there too. I'm not at liberty to say 20 in an open meeting like this, but I just want you to 21 know that we are progressing along a number of other 22 fronts too, which we will not talk about in terms of 23 strategies here.

The blight campaign. Certainly as we have taken down a lot of the structures here and

24

1 have caught up with the usage of our CDBG monies for 2 that, we're now working on the CDBG 14 money. We just had a hearing officer meeting in which we have 3 another 50 structures that were identified to be 4 5 condemned, that went before the Board of Appeals I 6 think last night. So, these are structures that can 7 be removed from the community, but as we remove them, we now have vacant lots. And so one of things 8 9 we needed to do is how do we develop a vacant lot 10 strategy for the City of Pontiac. Just today, 11 there's a group that came down from the State Vacant 12 Lot Campaign that are working with 13 district-by-district volunteer groups, some of the 14 people who are left from the Master Plan Steering 15 Committee, and they did a whole tour today. They 16 are in the building off and on all during the day. I met with some of them earlier. But they're now 17 18 proposing a way in which we can deal with the vacant 19 lots within the City in many creative, 20 environmentally-friendly and other ways. 21 So we have a lot of people involved in 22 that on a volunteer basis who are going to help with 23 that campaign. So I wanted to tell you that. 24 Mediation, we already talked about. 25 And I did submit to you this organizational plan,

and it's not only because the Deputy Treasurer asked me to do that, but also because you may recall a conversation we had some months ago here in which we talked about the positioning and the staff under the Community Development, Economic Development Department. And I think there was a question about whether one position should be eliminated or how that should be handled. And you did ask me also to come up with a chart, so I did present this for your information as well.

11 But the main difference is we've grown 12 the Finance Department, the DPW Department depending 13 upon the needs of the community, but my conception 14 of meeting the economic development is one of the 15 ways that we're going to be able to carry forth this 16 economic recovery plan for the City. I don't want 17 to go into detail about this, but it does require 18 that we have a community plan that is more than just 19 tearing down houses. It's much more involved. And 20 what I see in terms of bringing -- it also requires 21 economic retention, business retention, business 22 support. And also I would conceive of bringing the 23 whole Senior Citizen Center situation under the community development. It's now under DPW, and 24 25 those guys are great at fixing faucets, but they

1 don't really know much about senior programming. 2 So that's what I foresee in bringing 3 We do have a position there that is going to this. 4 be vacated very soon, and because that's the only 5 person I have working with blight, and now I'm very 6 interested in having that position filled with the 7 skill set that we need to handle and continue to 8 work along the blight program, as we have had great 9 achievements thus far. 10 So that's my report for this morning. 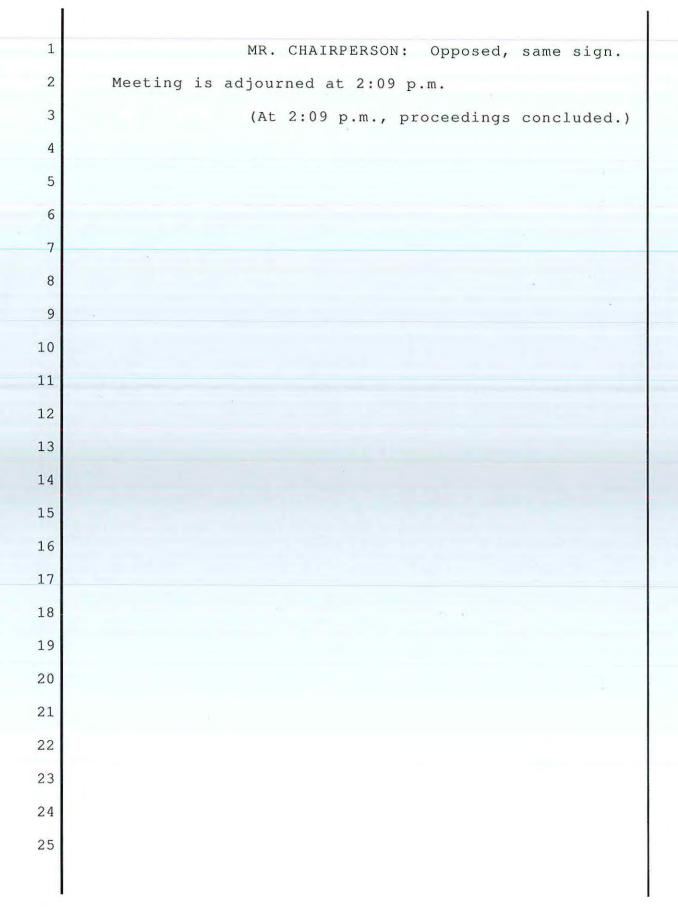

9	was. So we may want to check out the pay for that.
10	And also, the Mayor is not a liar. I

13	about people who are misinterpreting her statements.
14	We there's a disconnect here. We need to find

18	be dealt with, because she did not lie. She knew

22	been showing up at the Council meetings daunting
23	anybody. Let's all get it together. Thank you.
