3	First item there is the approval of resolutions

7	resolutions from this meeting.

21	One of the things that I wanted to point out,
22	for the record, is that our last meeting, we pulled a
23	couple items forward; those two items were Resolutions 184
24	and 185. Those were approved, so with that being said,
25	I'll entertain a motion to approve the remaining

1	resolutions from the regular city council meeting of July
2	5th, 2016.
3	MS. BROPHY: So moved.
4	MR. BOVITZ: Support.
5	MR. SYKES: Okay, so there's an opportunity here
6	to have some discussion. One of the things that I wanted
7	to bring up, some of the items that come before this
8	board, and also some of the information that's provided to
9	treasury, so that we have all of the information that we
10	need for this board, is that we've noticed that there's a
11	couple items.
12	In particular, the intergovernmental agreement.
13	We're having some difficulty receiving or receiving in a
14	timely manner. So I just wanted to point out that that's
15	something that's incredibly important for us to be able to
16	do what we do.
17	So, with that being said, let's see, we have
18	entertained the motion, any further discussion?
19	MS. BROPHY: No.
20	MR. SYKES: Okay, seeing no further discussion,
21	all those in favor of the motion say aye. Aye.
22	MS. BROPHY: Aye.
23	MR. BOVITZ: Aye.
24	MR. SYKES: Opposed, the same.
25	(No response)

1	MR. SYKES: Motion is approved. So the next
2	item is claims and accounts from the regular city council
3	draft minutes of July 19th, 2016. Entertain a motion to
4	approve the claims and accounts.
5	MR. BOVITZ: So moved.
6	MS. BROPHY: Support.
7	MR. SYKES: Any discussion?
8	(No response)
9	MR. SYKES: Okay, seeing none, all those in
10	favor say aye. Aye.
11	MS. BROPHY: Aye.
12	MR. BOVITZ: Aye.
13	MR. SYKES: Opposed, the same.
14	(No response)
15	MR. SYKES: Motion is approved.
16	So next we have city administrator items. We
17	have approval of city council minutes.
18	Next, we have approval of resolution number
19	200.16, the Rizzo Environmental Service contract. While
20	action on this item occurred during a city council meeting
21	outside the normal review of today's meeting, the city
22	administrator requested we bring this item forward for
23	early review. So that's what we're doing.
24	Does somebody want to speak to this Rizzo
25	Environmental Service contract, does anybody need any

1	additional information, or are you guys comfortable?
2	MR. WYCOFF: I can speak
3	MR. SYKES: Sure, could you? Go ahead, just
4	give us a little bit of information.
5	MR. WYCOFF: Charles Wycoff, city attorney, on
6	behalf of Mr. Flaten today. This contract is for waste
7	disposal services with Rizzo Contractors. You will recal?
8	that about a year ago, the waste hauler that we had wasn't
9	able to continue performing that service.
10	They assigned their agreement to Rizzo, and
11	Rizzo fulfilled those duties for a year. The contract
12	came up for renewal, and it was reviewed by the
13	administration in great detail. You will note that this
14	contract was not bid.
15	There was research done by the administration;
16	they contacted other municipalities in the area who had
17	bid contracts, they found out what their rates were, what
18	the bid rates they had gotten from all these suppliers
19	from the area.
20	And with all due respect, Mr. Rizzo gave us a
21	rate that was extremely beneficial, I guess is the
22	appropriate term, and economical at this point in time.
23	They also guaranteed it for a five year period.
24	So we looked at that, and there was a
25	determination made that the bidding of this contract

1	served no useful purpose for the city, based on the rates
2	that were going on in the community, versus what we were
3	being offered. That was number one.
4	Number two, we had a copy of the contract.
5	Legal reviewed the contract in detail and made some
6	significant changes to the agreement, relative to
7	environmental concerns, clean up of oil on the streets,
8	things of that nature. We also made the contract
9	terminable on short notice if things are not as
10	represented.
11	And so it is the recommendation of the
12	administration and the legal department that this contract
13	be approved. I'll answer any questions.
14	MR. SYKES: Typically, these are this type of
15	a contract would be bid out?
16	MR. WYCOFF: Yes, that is absolutely correct.
17	MR. SYKES: So then, you say that it was, that
18	the fee, the amounts that are going to be paid, are fair,
19	compared to what you see you out in the industry? Is it
20	fair, or is it superior? Is this better?
21	MR. WYCOFF: Superior.
22	MR. SYKES: Okay. That's good to hear.
23	MR. WYCOFF: It's very favorable.
24	MR. BOVITZ: Just my observation, Rizzo's been
25	taking over the, manage the control of most of the cities

1	I know around here, and they do a very good job, and if
2	the rate they bid is very competitive, then I see no
3	reason to go further with the search. So I move for the
4	Resolution 200.16.
5	MS. BROPHY: I'll support.
6	MR. SYKES: Any further discussion?
7	(No response)
8	MR. SYKES: Okay, seeing none, all those in
9	favor of the motion say aye. Aye.
10	MS. BROPHY: Aye.
11	MR. BOVITZ: Aye.
12	MR. SYKES: Opposed, the same.
13	(No response)
14	MR. SYKES: Motion is approved. So, the next
15	resolution is approval of resolution number 203.16, first
16	right of refusal. So first off, I just wanted to point
17	out that this has this particular resolution, has
18	something to do with what I do during my day job.
19	I'm the chief financial officer of the Michigan
20	State Housing Development Authority, and we've had a
21	tremendous amount of federal resources flow through the
22	authority, as hardest hit funds.
23	So I wanted to point out that me, personally, I
24	don't have anything to gain from this. There's no
25	personal gain or interest, but also, wanted to point out

1	that this isn't something that you know, per se, benefits
2	the authority.
3	It doesn't hit the bottom line of the authority,
4	these are funds that are being used or administering for
5	blight elimination in a number of communities around the
6	State of Michigan.
7	MS. BROPHY: Okay. Mr. Chair, I would like to
8	disclose a similar type of arrangement. Wayne
9	Metropolitan Community Action Agency, my employer, is
10	partnering with the City of Ecorse on this blight
11	elimination project. There may be, there's a small fee
12	that Wayne Metro does get for the blight project per home,
13	but I have no personal gain in the agreement.
14	MR. BOVITZ: I have absolutely no ties to this.
15	I'm 100 percent behind blight elimination.
16	MS. BROPHY: As we all do.
17	MR. SYKES: I agree. It's been a wonderful
18	program, so.
19	Okay, so, while this action is an item that
20	occurred during a council meeting outside of normal review
21	period for today's board meeting, the city administrator
22	is requesting to bring this item forward for early review.
23	So with that being said, I'll entertain a motion to
24	approve resolution number 203.16.
25	MR. BOVITZ: So moved.

1	MS. BROPHY: Support.
2	MR. SYKES: Any discussion?
3	(No response)
4	MR. SYKES: Okay, seeing none, all those in
5	favor of the motion say aye. Aye.
6	MS. BROPHY: Aye.
7	MR. BOVITZ: Aye.
8	MR. SYKES: Opposed, the same.
9	(No response)
10	MR. SYKES: This motion is approved. Okay.
11	Now we move on to number four, approval of
12	resolution number TBD, pay adjustments. Again, this is
13	another situation where we have an item that has occurred
14	outside the normal council meeting review period, and the
15	city administrator is asking for us to pull this one
16	forward.
17	So with that I'll save this for discussion.
18	I'll entertain a motion, well no. I have some discussion
19	about this first. I know that this is important, and I've
20	listened to a number of folks talk about the fact that in
21	order to be able to retain city employees, that there
22	needs to be some sort of compensation so that they don't
23	continue to move.
24	We need to sort of stop the bleeding from that
25	standpoint, but one of the concerns I have is that during

1	the last board meeting, or it was the board meeting prior
2	to that, we brought a five year budget. So there was a
3	five year budget that was brought, and it showed that once
4	we got out a couple of years, that I believe it was the
5	third, fourth and fifth year, that there was a deficit.
6	So one of the things that I asked for was, to
7	take a look at that budget, and go through and show, once
8	we get to those deficits, below the deficit line, to show
9	what items in the budget are going to be addressed to
10	shore up that deficit. I mean, at some point, there's
11	only so much money that's coming in, and it can only cover
12	so many so much in the expenses.
13	So when we go through this process of looking
14	about pay increases, and other types of expenses, I really
15	do want to see something that addresses that particular
16	issue.
17	Is there somebody that you would recommend,
18	Patrick, that might be able to talk to that, or?
19	MR. DOSTINE: It could either be Mr. Wycoff or
20	Ms. Capra.
21	MS. CAPRA: I don't know about that detail.
22	MR. DOSTINE: Okay.
23	MS. CAPRA: Other than I'd like it.
24	MR. WYCOFF: It's my understanding Mr. Sadowski
25	would address that issue.

MR. SADOWSKI: I have the same concerns. I had addressed those concerns to the city administrator. He still feels that they were warranted. Pretty much my concern is always have MERS, MERS is in a pact with Braden (sic), especially if we look at it, how is the city going to make up those funds? I have no idea. He seems to think that budgeting will be adjusted during the current fiscal year to pay for these raises, and thinks there is funds to do that, and --

MR. SYKES: Okay. So, I think the way I look at this, is I understand, too, that there's some opportunity for adjustment, based on maybe a position or so, that hasn't been filled or won't be filled, or something that would kind of offset that. But, what my concern is, is to say, if we do this, how are those other, you know, years, three, four and five, going to be dealt with?

And it's not to say that they can't be dealt with in some other manner. It's just, there needs to be some sort of forethought, and to say, is it going to be some type of service? Is it going to be a reduction in staff, is it going to be, something?

And so, when we're talking about, you know, increase, maybe across the board, or some sort of pay increase where it's a little bit amongst everybody. It,

1 when you come to a shortfall, is it going to be the same 2 Is it just going to be a reduction, is it--? thing? 3 MR. SADOWSKI: The raises -- this was supposed 4 to be the first round in several divisions. The city was 5 supposed to (indiscernible) but my understanding of the plan is that each department was going to be looked at, 6 7 and raises would be given out accordingly. The employees in contact; give them raises, offer them a little time 8 9 supplement that was given in November, that was before the 10 emergency manager in 2009. And this position, this pay 11 request, was for AFSCME employees. And we looked 12 comparably with -- that was the study that the 13 administrator did. You can see we're several dollars per hour under the surrounding communities. 14 15 MR. SYKES: Uh-huh. 16 MR. SADOWSKI: So, like you said, we had good employees that left for other jobs, because they are 17 18 making several thousand dollars more than when they come 19 here, and then they moved. 20 So that was his goal, under this. The concern I had development for how the city is going to stop the 21 22 unemployment liability from increasing. The raises are 23 minimal, to the benefits. 24 MR. SYKES: Uh-huh.

The county retirees that go with

MR. SADOWSKI:

1	raises because MERS is based on a payroll factor.
2	MR. SYKES: Right.
3	MR. SADOWSKI: And the payroll factor is going
4	up.
5	This year it went from one and a half to four
6	and a half times payroll for this division, and now we are
7	close to 16 times payroll. So this division of payroll is
8	\$100,000 a year. Last year it was well, about 150,000
9	from MERS. This year, it's \$450,000; next year, it's
10	going to about \$55,000.
11	And so that's what the city has to work on. We
12	had a similar situation with the non-bargaining unit, and
13	that division was closed, and went to a monthly fixed
14	plan. That saved the city several hundred thousand
15	dollars a year. And that is what I had recommended
16	happen but that takes union negotiations and bargaining in
17	the different steps.
18	But like I said, this plan, that the
19	administrator came up with, was based on the union
20	division for AFSCME, for comparable wages, so we don't
21	lose any more people to surrounding communities. We felt
22	that the current year could be adjusted with a budget
23	amendment, and that the future years would be addressed at
24	a later time.

MR. SYKES: Okay, so that kind of led into my

25

1	next question, so there's another piece in there. And
2	it's my understanding, and correct me if I'm wrong on
3	this. Is that the there is a union component to this.
4	And it's my understanding that this hasn't been worked
5	through with the union, is that the case? I mean, does
6	that potentially create a union issue with the city?
7	MR. SADOWSKI: I believe so. I believe that's
8	legal; I don't sit on any of the union boards or contract
9	negotiations.
10	MR. SYKES: Okay.
11	MR. SADOWSKI: I would imagine so.
12	MR. WYCOFF: That's been factored in.
13	MR. SYKES: When you say that's been factored
14	in, what do you mean by that?
15	MR. WYCOFF: Mr. Flaten has been talking with
16	the union. Personnel is aware of the union component;
17	this is agreeable to all of them. And I that's as far
18	as I know. I just know that he is aware of the issue; he
19	has talked to the union personnel about it, and that
20	includes the officers of the union.
21	MR. SYKES: Okay. So we're, ultimately, we're
22	going to bring this up to vote, so we can talk about
23	whether or not we're going to entertain a motion, but I
24	just wanted to be clear on the two issues.
25	One, we're talking about pulling this forward,

so this is something that we're doing earlier, it's outside our purview. I think it's important to make sure that we are compensating people appropriately, and definitely not just appropriately, but not less than the surrounding communities. It's difficult to maintain staff and continuity, so I am fully in support of that.

The issue that I do have, and that I would like to see addressed, for me to be okay with this going forward, is that five year budget. And even if it's to say that you know, something dramatic is going to have to take place to deal with those issues, then at least address it.

And so I'd like to see that, and then the other thing I'd like to see is, you know, some sort of documentation on that union issue. Because that did kind of concern me, that kind of stuck out, so, once we know that the union has sort of blessed this process, or, you know, I would imagine that the union's not going to step in the way of raises for their represented individuals, but, I still would like to make sure that all that is covered. So that's where my feelings are on this particular issue.

Do you guys --

MR. BOVITZ: Well, I'm all for the pay raises for compensation, but I'm not clear on the unfunded

1 liability for the pension. It seems like it's a pretty 2 big escalation, so, I would move that until we have those issues addressed, that we postpone this resolution. TBD. 3 4 MS. BROPHY: I'll support that. 5 MR. SADOWSKI: I've brought the factors, if you 6 wanted to see; I figured it was going to come up, so, for 7 this decision. So, like I said -- the bottom numbers it's 8 16 -- that's the -- right now, if you look at the bottom 9 line next year, it goes to 1,622.8 percent of payroll. 10 Which is a factor of 16.2. And that's the only concern I 11 have as going out, how do you budget for \$1.6 million MERS 12 payment? 13 Right. MR. SYKES: MR. SADOWSKI: The raises themselves are 14 15 budgeted, and have been, I know it was part of the 16 original five year budget, to give the employees raises, 17 going out. That's pretty much the only thing that's not 18 in the five year budget, and it's unexpected with the 19 market. 20 MR. SYKES: Okay. So Patrick, what's the process here? Do we go ahead and move the motion, and 21 22 then vote it down for pulling it forward, or do we put a 23 motion forward to delay? 24 MR. DOSTINE: Well, it sounds like you want more

information.

1	MR. SYKES: Correct.
2	MR. DOSTINE: So, I think the path would be to
3	make a motion to postpone it.
4	MR. SYKES: Okay.
5	MR. DOSTINE: Until for waiting for more
6	information to be brought forward that satisfies the
7	questions you have for Mr. Sadowski.
8	MR. BOVITZ: And that's the motion on the floor.
9	MR. DOSTINE: That's the motion on the floor.
10	MS. BROPHY: That's the motion.
11	MR. SYKES: Okay.
12	MR. DOSTINE: That's the motion on the floor.
13	MS. BROPHY: And I'll support that.
14	MR. SYKES: And you'll okay. Okay, so any
15	further discussion on the motion to postpone?
16	(No response)
17	MR. SYKES: Okay, seeing none, all those in
18	favor of the motion, aye? Aye.
19	MS. BROPHY: Aye.
20	MR. BOVITZ: Aye.
21	MR. SYKES: Opposed the same.
22	(No response)
23	MR. SYKES: And this motion has been approved.
24	Thank you very much.
25	Next item is informational only, related to the

1	25th District Court.
2	Next item is, again, informational only, checks
3	released.
4	Next is the approval of budget to action
5	reports. This is another one that's a little bit
6	challenging, because, again, I'm just going to say that
7	it's my understanding that this information oh, you're
8	ready to get back up?
9	MR. SADOWSKI: Here we go again.
10	MR. SYKES: Let's go there.
11	MR. BOVITZ: We want our money's worth.
12	MR. SYKES: Yeah. So, my concern here is that
13	this hasn't it's my understanding, again that this
14	hasn't, these reports haven't gone to city council. So
15	there's two things. One, it's important for city council
16	to have an understanding, particularly when we're talking
17	about a city that's having some financial difficulties,
18	that they get a chance to see these. And I think this is
19	the second month in a row now that they haven't.
20	The other piece of that is for us to go through
21	and sort of approve these. It kind of feels like it's
22	getting out in front of city council.
23	MR. SADOWSKI: Yes. It is. I had to write a
24	financial report, and Treasury requested a financial
25	report in a month, it wasn't finished.

1	MR. SYKES: Okay.
2	MR. SADOWSKI: I don't know how you do that, but
3	meaning, we had to classify that, we hadn't received the
4	bank statement for July.
5	MR. SYKES: Okay.
6	MR. SADOWSKI: But it was demanded at the time,
7	so.
8	MR. SYKES: What about June?
9	MR. SADOWSKI: June is finished. June was done
10	that's why you have an August.
11	MR. SADWOSKI: Is because most of the bank
12	statements come in, the final ones get mailed to us by the
13	second week in, following the month. Those are then
14	reconciled and then it goes to city council, and it goes
15	to Silver Slake (sic). You're almost two months behind by
16	the time it gets to you.
17	On the other hand, Treasury wanted it done,
18	wanted it to go to council. July's goes out the second
19	when they get their paperwork the Friday before, so the
20	month hasn't been completed.
21	MR. SYKES: Okay.
22	MR. SADOWSKI: So July hasn't been completed
23	yet.
24	MR. SYKES: So June is that the case though,
25	that June hasn't been to city council yet?

1	MR. SADOWSKI: June has been to city council.
2	MR. SYKES: It has been to city council? Okay.
3	MR. SADOWSKI: June went to city council in
4	July.
5	MR. SYKES: Is that reflected in the minutes?
6	MR. DOSTINE: You know, when I look over the
7	minutes, Mr. Sadowski, we couldn't find it reflected in
8	the minutes.
9	MR. SADOWSKI: June has been adopted.
10	MR. DOSTINE: Specifically the July meeting,
11	which fall under the review of the August RTAB.
12	MR. SYKES: So what I would suggest, then, on
13	this, is again, and this is one of those things where I
14	think we should probably postpone until we have evidence
15	that the city has looked, and approved these reports, so
16	that we aren't getting out in front of them.
17	MR. DOSTINE: Okay.
18	MR. SADOWSKI: I don't mind. I was requested to
19	do the month end for July ended.
20	MR. SYKES: Okay.
21	MR. DOSTINE: I thought maybe it was of
22	interest, so the order asks that the mayor and city
23	council review a monthly budget to actual.
24	MR. SYKES: Correct.
25	MR. DOSTINE: And then they recommend it to the

1	RTAB for approval. And if it comes to you without having
2	been seen by the mayor, or the council, then, you know,
3	the RTAB is actually making decisions, which is before
4	council and mayor has acted.
5	MR. SYKES: Exactly.
6	MR. DOSTINE: And that's not the appropriate
7	order we've got to take them.
8	MR. SYKES: Exactly. So that's why I say I
9	think that we should probably postpone, you know, approval
10	of these budget to actual reports, until we have evidence
11	that the city council has reviewed and approved.
12	MR. BOVITZ: So moved.
13	MS. BROPHY: Support.
14	MR. SYKES: Any further discussion?
15	MR. BOVITZ: Well, that's the direction to the
16	city clerk, then, just to make sure that that is reflected
17	in the minutes, so we know that they've addressed it.
18	Even if they did it officially at one of the prior
19	meetings, you know, to go retroactively to the next
20	meeting.
21	MR. SYKES: That would be sufficient evidence
22	that it had been discussed, or had been given to the city
23	council, so I agree with that.
24	Okay, any additional discussion?
25	(No response)

1	MR. SYKES: Seeing none, all those in favor of
2	the motion say aye. Aye.
3	MR. BOVITZ: Aye.
4	MS. BROPHY: Aye.
5	MR. SYKES: Opposed the same.
6	(No response)
7	MR. SYKES: This motion is approved.
8	So next we have approval of resolution number
9	198.16, superintendent of DPW contract. Again, this is an
10	action that's occurred during a city council meeting
11	outside of our normal review, today.
12	The city administrator's requesting that we pull
13	this one forward. Is there somebody that could give us a
14	little more insight into this particular contract?
15	MR. WYCOFF: I guess it's me.
16	MR. SYKES: All righty.
17	MR. WYCOFF: The RTAB will recall Mr. Lawrence
18	previously worked for the city as the DPW superintendent.
19	He left the city to take a position in Grosse don't
20	hold me to this, either Grosse Pointe or Grosse Pointe
21	Farms, it was one of the two. And he has been recruited
22	to return, by the city council.
23	As a result of that, I was asked to draft a
24	contract of employment for him. You will notice that the
25	contract of employment differs greatly from ones that were

1	issued prior to my return in January.
2	It is a much more reasonable rate of pay, it has
3	significant financial controls on overtime, things of that
4	nature. And it strictly limits, you know, one,
5	reimbursement for expenses to those which are actual,
6	necessary and reasonable. And it also dictates
7	termination provisions, to avoid some of the pitfalls that
8	have been observed in prior contracts.
9	It is the will of the city council that he head
10	the DPW. There is reason to believe that he would be more
11	efficient and economical in performing those duties than
12	perhaps prior to his reappointment.
13	So it's the recommendation of council and the
14	city administrator that the contract be approved. And
15	there is some urgency to get him on board, is my
16	understanding.
17	Any questions?
18	MR. SYKES: I have no questions.
19	Okay, I'll entertain a motion to approve
20	resolution number 198.16.
21	MR. BOVITZ: So moved.
22	MS. BROPHY: Support.
23	MR. SYKES: Any discussion?
24	(No response)
25	MR. SYKES: All right, seeing none, all those in

1	favor of the motion say aye. Aye.
2	MS. BROPHY: Aye.
3	MR. BOVITZ: Aye.
4	MR. SYKES: Opposed the same.
5	(No response)
6	MR. SYKES: This motion is approved.
7	Next, we have public comments. Mr. Dostine?
8	MR. DOSTINE: Mr. Chair, there are no requests
9	today for public comments.
10	MS. COX: There was no pen up there.
11	MR. DOSTINE: Oh, actually there is. Okay,
12	correction, there is one request.
13	MR. SYKES: All right, fantastic.
14	MR. DOSTINE: Ms. Linda Cox.
15	MS. COX: It's going to be the last one that we
16	just talked about, the DPW. I like Kevin Lawrence. But
17	Wayne's been here, and he is working. He is working over,
18	overwhelming, and getting a lot of things done.
19	My feeling is what are we going to do with him?
20	Are we going to just going to push him aside? I feel he
21	is here, he has stepped up to the plate, he does just
22	about anything we ask him to do. He's squeezes it in at
23	the end of the day, or within the reasonable time.
24	And I just feel I don't want to shove him

1	want him to walk away. And I feel I don't understand
2	why we can't have both of them, and that way, neither one
3	of them has too much on their shoulders, since that's what
4	the city seems to do. Pile things on their shoulders, so,
5	I would like them to really look at it, and as much as I
6	like Kevin, like I said, Wayne is here, and he's stepped
7	up to the plate, he's done what we've asked him to do, so,
8	I'd like to see him remain.
9	MR. SYKES: Okay. Thank you.
10	MR. DOSTINE: Mr. Chair, that concludes public
11	comments.
12	MR. SYKES: All right, thank you. The next item
13	is board comment. Comment?
14	MS. BROPHY: No.
15	MR. SYKES: Okay, I just also want to reiterate,
16	we talked about this a little bit earlier. That you know,
17	it is a lot of preparation that goes into putting these
18	meetings together. A lot of information that's related to
19	Treasury, that is shared with us. So I want to make sure
20	that everyone knows that it's important that we receive
21	this information, so that we can have the amount of
22	information that's necessary in order to kind of move
23	things forward.
24	So that's it for me for board comments.
25	Next is adjournment.
