Have you reached out to the former City Attorney Karen Folks to get her feedback?

McCurley – The City Attorney will review the matter regarding the legal fees to confirm the fees are actually owed. Yes, the City reached out to the former City Attorney Karen Folks and her recommendation was to speak with our new City Attorney regarding this matter.

Parker - What is the arrangement with the parcels that are delinquent? How much is included in the \$400,000 and has anyone evaluated whether the City will maintain ownership of these parcels?

McCurley – City Administrator John Openlander is recommending that the City do nothing about these parcels at this time. It may make sense to let the properties go into foreclosure as it may be more money to pay the taxes than what the value of the property is.

Parker – Regarding the Mill Street property – do you have two potential offers related to that property?

McCurley – There is at least one offer, but I do not know the details. City Administrator John Openlander will provide the details of that property to the Board.
