"In our area, pre-K would cost my family close to 8 thousand dollars. That is 8 thousand dollars that could be used for retirement savings or college tuition. It also makes me think of the fact that it would be more than \$8000 since I have two children over the next few years instead of being able to save for my children's college tuition or putting a money away to be able to help them buy their first house. We would be spending tens of thousands of dollars to put them through preschool programs. As an educator, I know how important these pre-K programs are, and I would hate to deny my child the opportunity to excel just because it is so unbelievably expensive."

"It would save us so much money on childcare. We have been relying on family to care for our daughters. This would allow our second daughter to receive education sooner."

Even though we're a two-income family with good jobs, if we had 3 kids like we want, we'd be living paycheck to paycheck. Women leaving the workforce and part of the reason there is gap in pay is often due to childcare expenses."

My 3-year-old doesn't start kindergarten until 2026, which is the soonest we would catch a break in daycare expenses which is really daunting."
