Considerations for NOFO guidance and application preparation

- As of June 6, 2025, this fact pack was based on the prior program NOFO (released in 2023)
- NOFOs may be subject to change. Recent updates to NOFOs for other grants have included:
 - Revisions to program names
 - Removal of language, merit criteria, and application requirements around climate change and sustainability; environmental justice; equity; and workforce development (e.g., BUILD, Large Bridge Projects)
 - Updates to total funding amounts available
 - Defining Historically Disadvantaged Communities using the same statutory definition for Areas of Persistent Poverty
 - New language on applicant compliance with federal laws, regulations, executive orders, policies, guidelines, and requirements, “including cooperating with and not impeding U.S. Immigration and Customs Enforcement (ICE) and other Federal offices and components of the Department of Homeland Security in the enforcement of Federal law”¹
 - Clarifying all grant agreements or contracts must include terms that are in compliance with Section 3(C)(iv) of EO *Ending Illegal Discrimination and Restoring Merit-Based Opportunity*

ASAP intends to finance capital projects to upgrade the accessibility of legacy rail fixed guideway public transportation systems for people with disabilities



Goals and merit criteria for ASAP grants:

Each of the following merit criterion will be considered by the Federal Transit Administration for both **station or passenger facility accessibility improvement** (capital) projects and **planning** projects:

- Demonstration of need
- Demonstration of benefits
- Planning alignment with local or regional prioritization
- Local financial commitment
- Project implementation strategy
- Technical, legal, and financial capacity

FTA may **rate projects higher** if they propose to **exceed the construction standards** by providing:

- multiple paths of travel for people with physical disabilities (including those who use wheelchairs)
- technologies to improve accessibility for people with sensory or cognitive disabilities

High level requirements to apply for an ASAP grant

Applicants are encouraged to explain how the proposed project scope will make all passenger-use areas fully accessible in accordance with title II of the Americans with Disabilities Act of 1990.



Eligible Entities

- Designated recipients that operate or allocate funds to inaccessible pre-ADA (legacy) rail fixed guideway public transportation systems
- States (including territories and Washington, DC)
- Local governmental entities that operate or financially support legacy rail fixed guideway public transportation systems and corresponding legacy stations/facilities



Key Grant Application Components

- Application for Federal Assistance (Standard Form 424)
- ASAP supplemental form
 - Project information (type, summary)
 - Congressional districts
 - Description of need and objectives
 - Project budget and timeline
 - Scalability
 - System map

Examples of past winners



Massachusetts Bay Transportation Authority (2024)

Impacted locality: Massachusetts

Funding: \$67,609,672

Project Description: The Massachusetts Bay Transportation Authority will receive funding to upgrade station platforms at 14 stops along the Green Line's light rail B and C branches that are not accessible to riders with disabilities: Chestnut Hill, Chiswick Road, Packard's Corner, South Street, and Sutherland Road stations on the B line, and Brandon Hall, Dean Road, Englewood Avenue, Fairbanks Street, Hawes Street, Kent Street, Saint Paul Street, Summit Avenue, and Tappan Street stations on the C line. Improvements will focus on improving safety, including installing accessible platforms for level boarding.



Greater Cleveland Regional Transit Authority (2024)

Impacted Locality: Ohio

Funding: \$16,000,000

Project Description: The Greater Cleveland Regional Transit Authority will receive funding to rehabilitate eight stations to make the entire Blue Line accessible for people with disabilities. Station upgrades will include replacing the 40-year-old platforms with new concrete platforms with tactile warning panels, installing redesigned ramps, elevating a platform section to access trains, and improving parking stalls with curb ramps to access the stations.



San Francisco Municipal Transportation Agency (2024)

Impacted locality: California

Funding: \$4,687,612

Project Description: The San Francisco Municipal Transportation Agency will receive funding to construct platforms, wheelchair ramps, and make other accessibility improvements at five Muni light rail stops on the J- Church line and three Muni stops on the M-Ocean View line. These improvements will reduce gaps between the platform and railcar, improving accessibility for the thousands of mobility-impaired residents who are currently unable to use the system.
