The US Marine Highway Program funds projects that provide a coordinated and capable alternative to landside transportation or that promote marine highway transportation



Goals and merit criteria:

The DOT defines marine highways as a network of navigable waterways, including rivers, bays, channels, coasts, the Great Lakes, open-ocean routes and the Saint Lawrence Seaway System. The U.S. Marine Highway system currently includes 35 U.S. Marine Highway Routes that serve as extensions of the surface transportation system.

Applications will be evaluated based on their alignment with the following statutory merit criteria:

- Demonstrating the Need to Develop, Expand, or Promote Marine Highway Transportation or shipper use of Marine Highway Transportation (as determined by market need, project need, and project impact)
- Expanding the Benefits of Marine Highway Transportation (as determined by landside congestion relief, economic competitiveness, alternative to landside transportation, or safety improvements)
- Measuring Project Support
- Leveraging Federal Funding and Financial Viability (including by demonstrating the presence of non-federal funding source(s) that are stable, dependable, and dedicated to the specific project)

High level requirements to apply for a Marine Highway grant

Marine Highway grant applications are open to local governments, transit authorities, and private sector operators



Eligible Entities

- States
- Political subdivisions states or local governments
- Metropolitan planning organizations
- United States port authorities
- Tribal governments
- Private sector operator of Marine Highway Projects or private sector owners of facilities with an endorsement letter from the current Marine Highway Route Sponsor



Key Grant Application Components

- Project description
- Statement of work
- Project location information identifying impacted location (a map in a PDF format)
- Project budget and funding information
- Narrative of how project meets selection criteria and DOT goals (20page narrative limit)

Planning for the SS Badger's Low Carbon Future Project (2023)

Applicant: Lake Michigan Carferry, Inc.

States: Michigan and Wisconsin

Funding: \$600,000

Project description: Grant awarded to support carbon capture feasibility study for historic 71-year-old coal-fired steamship ferry



M-90 Transbay Marine Highway Equipment Acquisition Project (2022)

Applicant: Fincantieri Marine Group, LLC

State: Wisconsin Funding: \$3.3M

Project description: Funds will go towards acquisition of three types of equipment that will facilitate the safe, sustainable, and efficient transfer of project cargoes from shore to vessel and back to shore



Helena Harbor M-55 Container-on-Barge Project (2022)

Applicant: Phillips County (Helena

Harbor)

State: Arkansas Funding: \$2.9M

Project description: Financed the purchase of equipment to operate the terminal and equip the bridge crane to handle containers. Investments will provide improved access to the terminal and equipment will provide efficient and effective material handling capabilities
