# The Brownfields Job Training program funds trainings to unemployed and under-employed residents of communities impacted by brownfields<sup>1</sup>



### Goals and merit criteria:

The Brownfields Job Training Program allows graduates to develop the skills needed to secure full-time, sustainable employment in various aspects of hazardous substances, pollutants, contaminants, and petroleum products within the larger environmental field, including sustainable cleanup and reuse, and chemical safety

#### Merit criteria include:

- Demonstrated community need, including the extent to which trainings will meet the labor market demand and help facilitate the identification and reduction of threats to human health and the environment
- Comprehensive, achievable, need-structured training curriculum
- Clearly identified desired program outputs and post-program outcomes
- The extend of the applicant efforts to collaborate with outside organizations to enhance environmental, job-training, and community impact

# Eligible grant uses

Funds may be used to offer trainings in:

- · Brownfields hazardous waste training "Green Remediation" technologies
- Green infrastructure and stormwater management
- Emergency planning, preparedness, and response for contamination on brownfield sites
- Enhanced environmental health and safety related to site remediation
- Energy efficiency and alternative energy technologies
- · Assessment, inventory, analysis, and remediation of brownfield sites
- Use of techniques and methods for cleanup of hazardous substances
- Building trades related to constructing berms, caps, synthetic barriers, pumping facilities, bioretention systems, and similar structures to remediate contamination and site preparation
- Awareness training in environmental stewardship

## High-level requirements to apply for a Job Training grant

Brownfields grants are available to government and non-profit entities. Previous grantees may not re-apply.



## **Eligible Entities**

- General Purpose Unit of Local Government
- Land Clearance Authority
- Government Entity Created by State Legislature
- Regional Council or group of General-Purpose Units of Local Government
- Redevelopment Agency that is chartered or otherwise sanctioned by a state
- State
- Indian tribe other than in Alaska
- Alaska Native Regional Corporation, Alaska Native Village Corporation, and Metlakatla Indian Community
- Nonprofit organization; including, but not limited to, organizations described in section 501(c)(3) of the Internal Revenue Code. Public and nonprofit private institutions of higher education

## **Examples of past winners (Michigan and comparable communities)**



#### **Green Door Initiative (2023)**

**Applicant:** Green Door Initiative **Impacted locality:** Detroit, MI

**Funding:** \$500,000

**Project description:** Green Door Initiative plans to train 345 students and place them in at least 270 in environmental jobs. Students who complete the training will earn up to three state and four federal certifications. Green Door Initiative is targeting students within the City of Detroit, particularly individuals who are underemployed and unemployed, lack post-secondary education, or have justice-system involvement. Key partners include BDS Environmental, Breaking Chains Mending Minds, City Abatement Services, LLC, the Detroit Brownfield Redevelopment Authority, Go Green Contracting, Great Lakes Restoration Service, the Team Wellness Center, and UAW Health and Safety



### **Southwest Economic Solutions (2021, 2025)**

**Applicant:** Southwest Economic Solutions

Impacted locality: Detroit, MI

Funding: \$315,000

Project description: Southwest Economic Solutions plans to train 60 students and place 34 in environmental jobs. The training program includes 110 hours of instructional training, as detailed in the chart below. Students who complete the training will earn up to 12 federal certifications. Southwest Economic Solutions is targeting students within the City of Detroit, with a focus on unemployed, underemployed, and economically underserved adults, as well as veterans and individuals experiencing homelessness. Key partners include the American Job Center, the Michigan Works Agency, Detroit at Work, Detroit Home Builders, the Michigan Department of Corrections, and North America's Building Trades Unions
