Low Carbon Transportation Materials Program aims to fund projects that will accelerate the use of materials and products that have lower levels of embodied GHG emissions



### **Purpose and goals of the program:**

The purpose of the LCTM Program is to reimburse or provide incentives to eligible recipients (typically state DOTs) for the use, in projects, of construction materials and products that have substantially lower levels of embodied GHG emissions associated with all relevant stages of production, use, and disposal.

Program goals include, but are not limited to:

- Increasing the use of lower carbon materials and products that are used in projects funded under 23 U.S.C.
- Facilitating the use of low carbon transportation materials while ensuring appropriateness for use in projects

• Promoting technology transfer and enhancing workforce development to increase the adoption of environmental quantification techniques used in decision-making by transportation agencies

• Encouraging State DOTs to begin LCTM activities and building successful low carbon transportation material identification frameworks that eventually may be replicated by non-State recipients eligible to apply for LCTM funding

Later in FY 2024, **FHWA will also make available \$800 million to target non-state applicants**, including cities, Tribes, Metropolitan Planning Organizations, and other agencies through a Notice of Funding Opportunity (NOFO). This funding opportunity will encourage applicants to partner with states where appropriate and will include offers of technical assistance for applicants.
